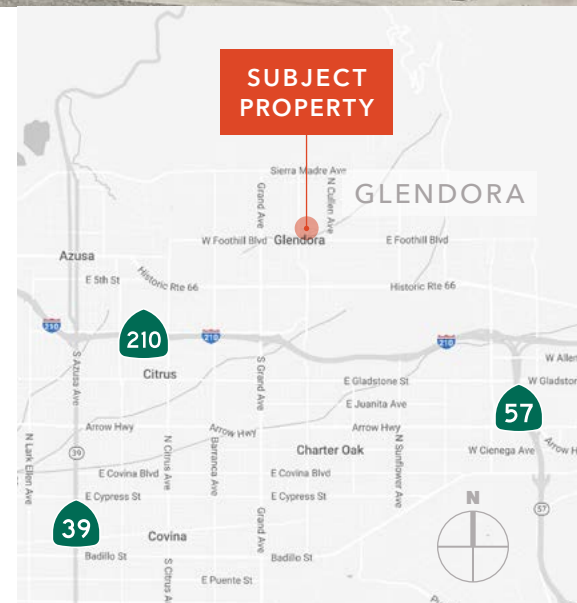

SCHOOL SPACE:	School Space: ±4,444 SF, 5 second floor classrooms, kitchenette, and patio area Available: Traditional School Days and Hours
CHURCH SPACE:	Church Space: ±12,000 SF, Sanctuary (seats ±225), Foyer, classrooms, office, social hall (seats ±200), and kitchen. Available: Sundays from 3:00pm - 9:00pm, Saturdays, and Various Weeknights
UTILITIES:	Tenant to pay its share of sewer, water, gas, electric, and trash.
PARKING:	On-site parking
RESTROOMS:	2 restrooms in the Upper Education level (one single stall and one with two stalls); 2 restrooms on the Main Sanctuary level (one single stall and one ADA-compliant); and 2 restrooms on the Lower Sanctuary level (one ADA-compliant and one with two stalls).
APPROVALS:	A Conditional Use Permit is likely for school use. (verify with city)
SHARED VS. EXCLUSIVE:	Landlord requires shared use of some classrooms, sanctuary, assembly hall, and kitchen
NON-PROFIT VS. FOR-PROFIT:	Non-profit is preferred; Landlord will consider for-profit (Tenant to be responsible for any increase in property taxes)
LEASE RATE:	School space: \$2.00 psf mg Church space: \$3,000 - \$6,500/mo + share of utilities

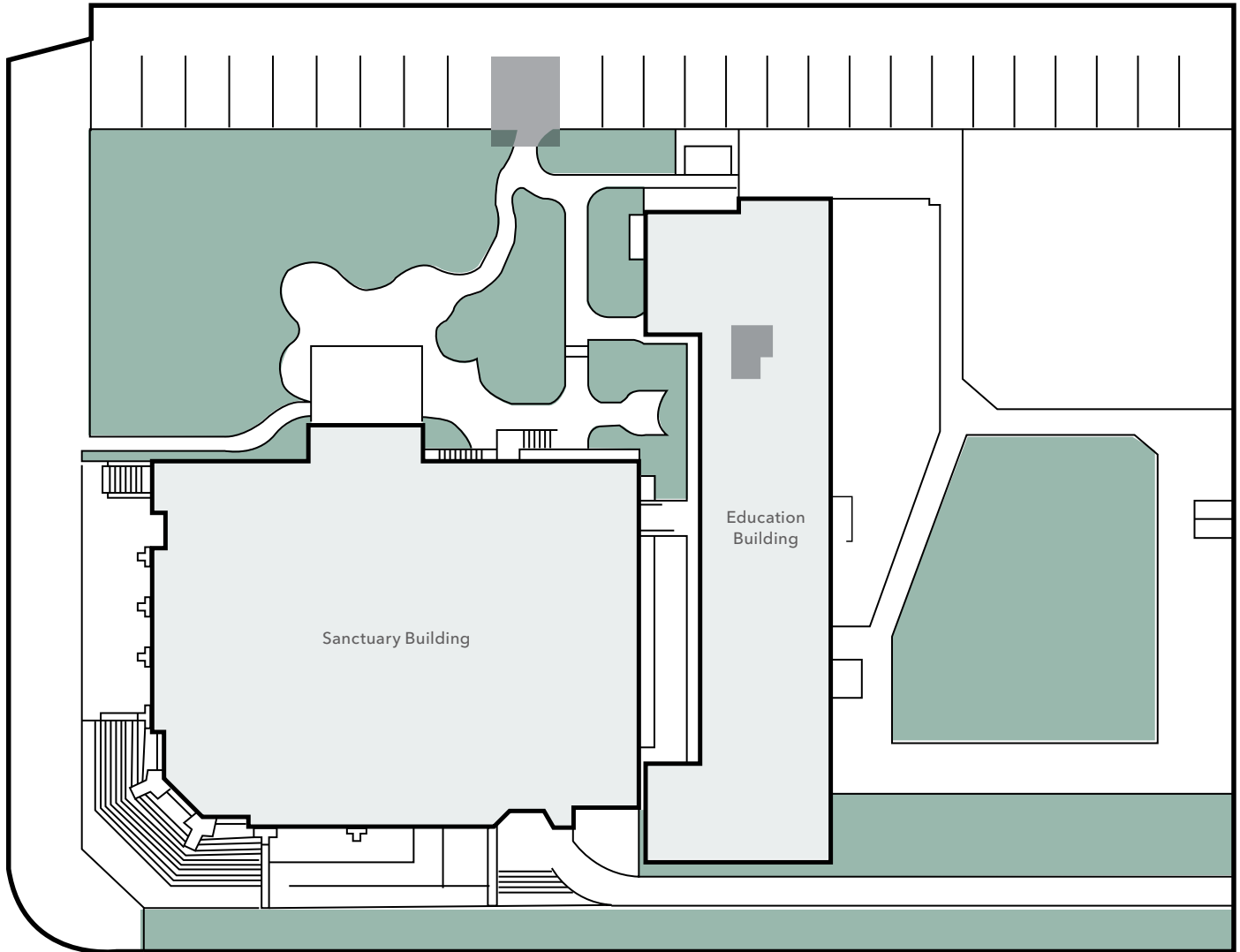

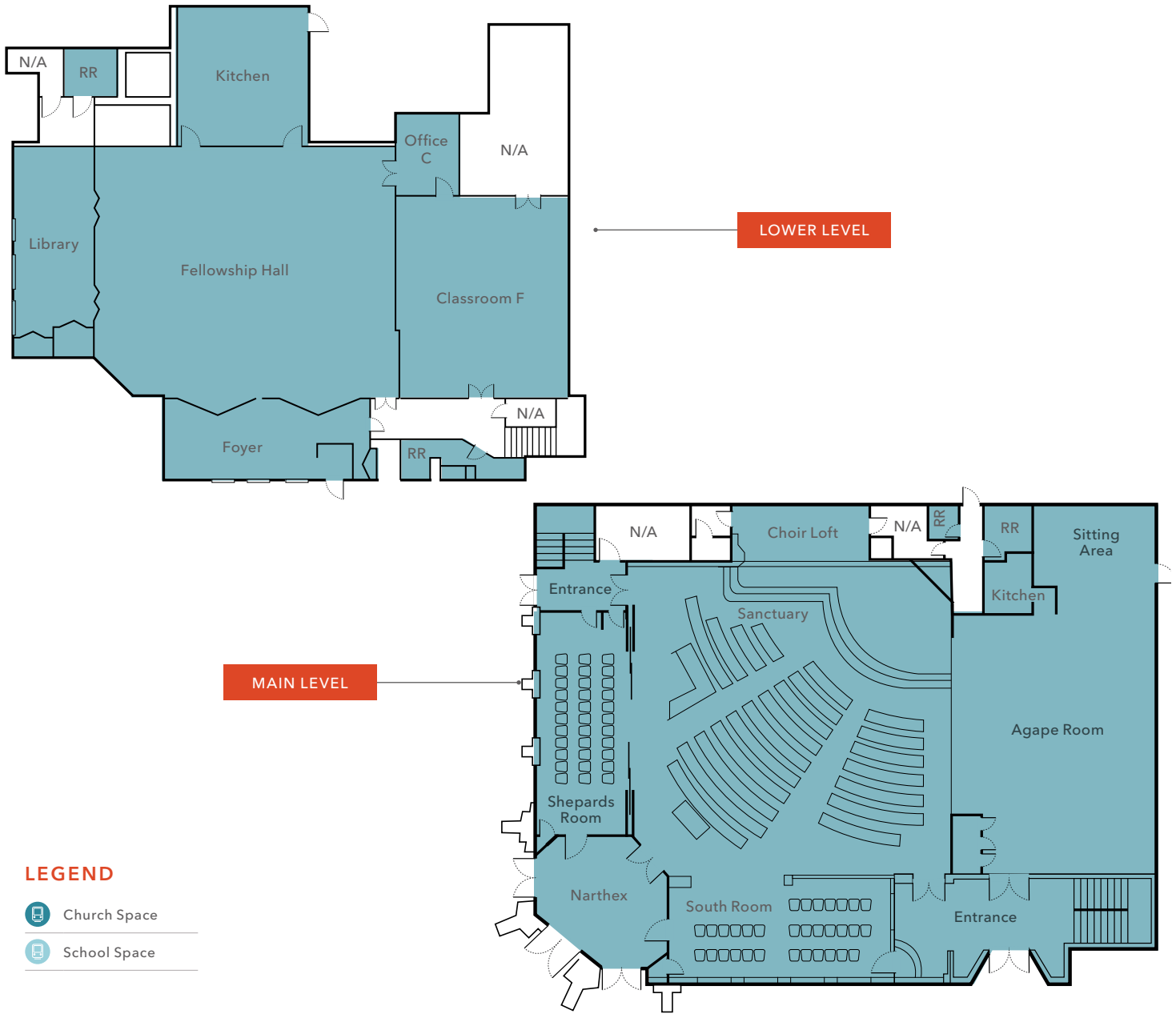

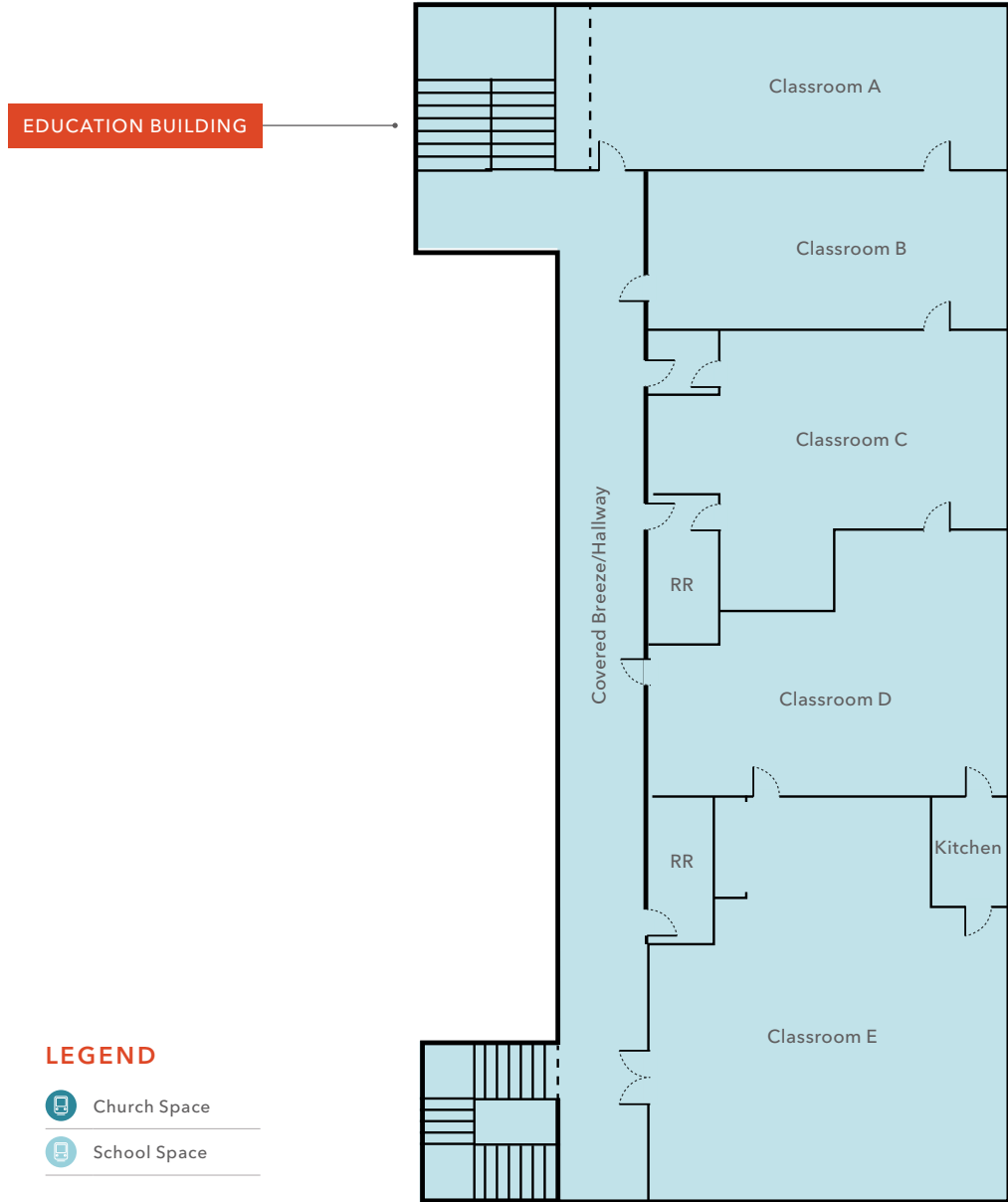
