Location

The property is situated on High Street North, one of Dunstable's main thoroughfares, providing excellent visibility and access to the town centre's amenities. Dunstable is well-connected via the A5, which runs directly through the town, and lies just a short distance from Junction 11 of the M1 motorway, offering easy access to Luton, Milton Keynes and the wider region. The area is served by regular bus routes, with Leagrave railway station approximately 4 miles to the east, providing direct services into London St Pancras. Nearby occupiers include a mix of national and independent retailers, restaurants and professional services, contributing to steady pedestrian footfall throughout the day.
