Parcel B – Frontage Land (7.55 AC): level, vacant commercial land – a shovel-ready pad site with no existing improvements.

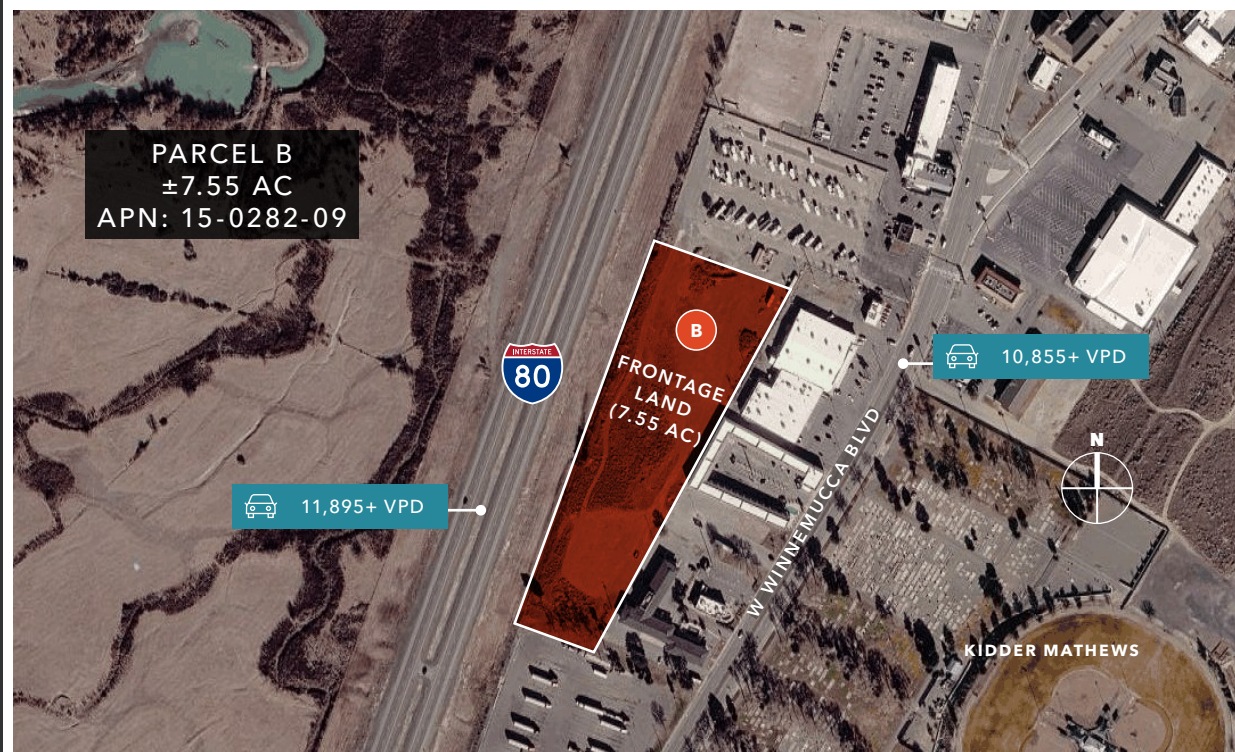

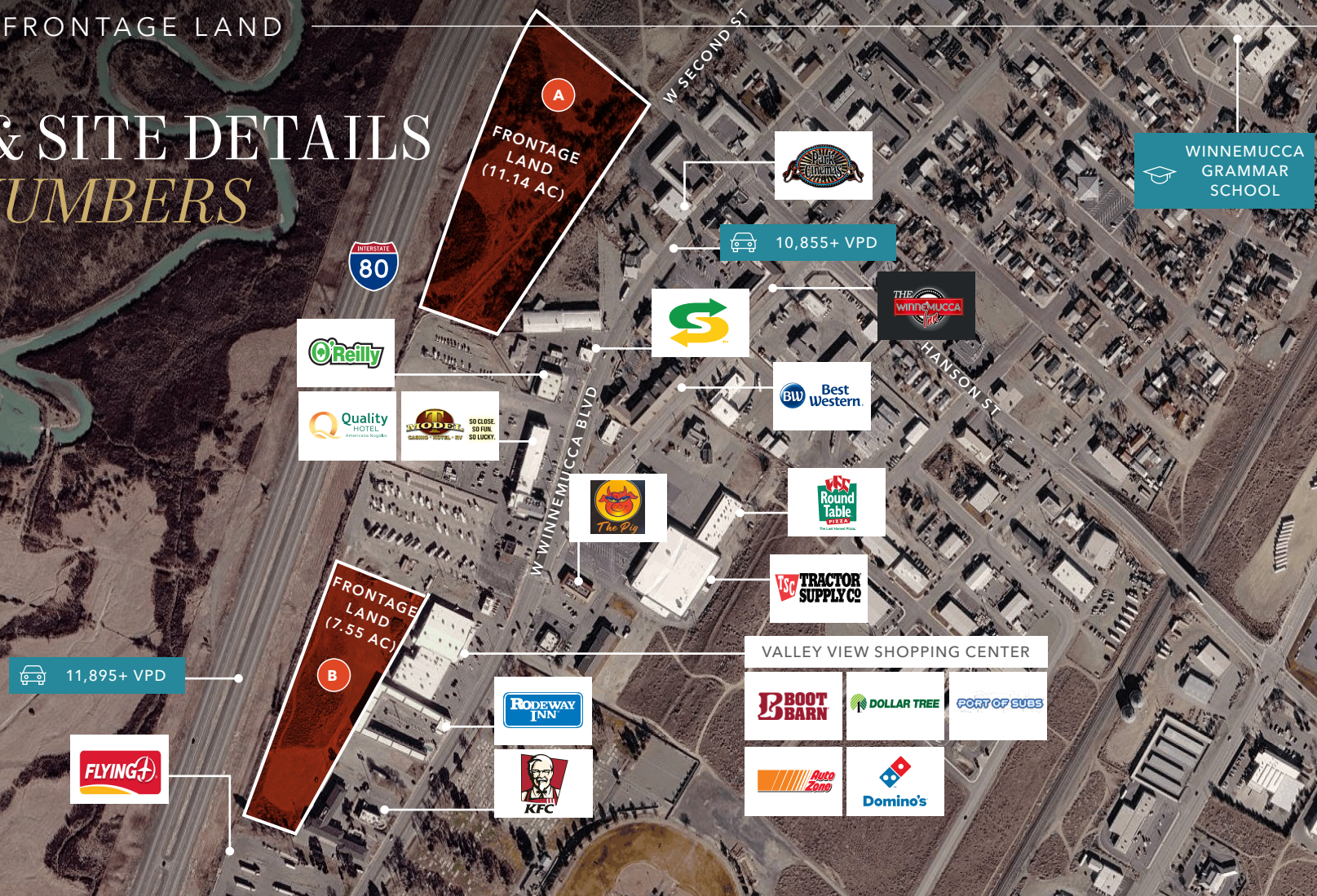

LOCATION & ACCESS

Direct frontage on W Winnemucca Blvd, the business loop connecting I-80 to US-95 through town.

Immediate access to I-80 Exit 176, Winnemucca’s primary interstate interchange.

Approximately 0.4 miles from the Flying J Travel Center at Exit 176, established travel-center demand at this interchange.

Surrounded by active retail and travelers’ services: Valley View Shopping Center, Motel 6, O’Reilly Auto Parts, Subway and Quality Inn.

US-95 runs past the site, connecting traffic north to Oregon/Idaho and south to Fallon, Reno and Las Vegas.

Winnemucca is also served by Union Pacific Railroad and Amtrak’s California Zephyr.

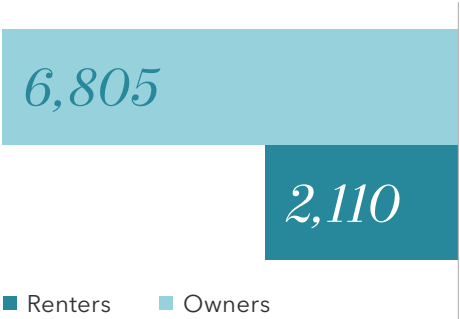

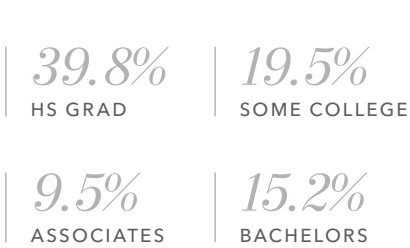

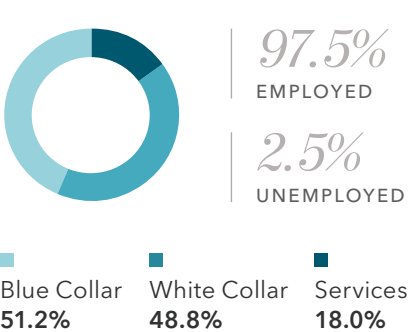

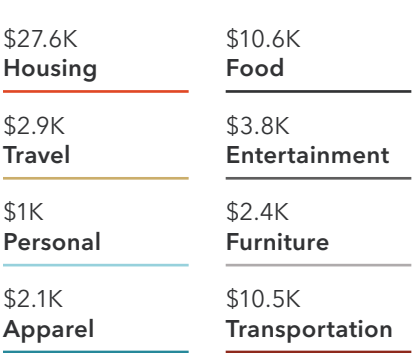

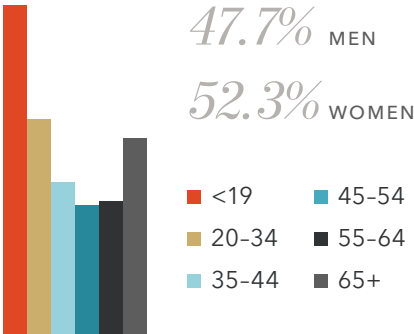

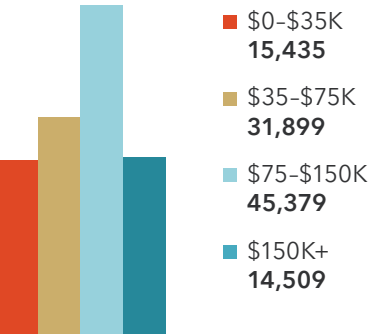
