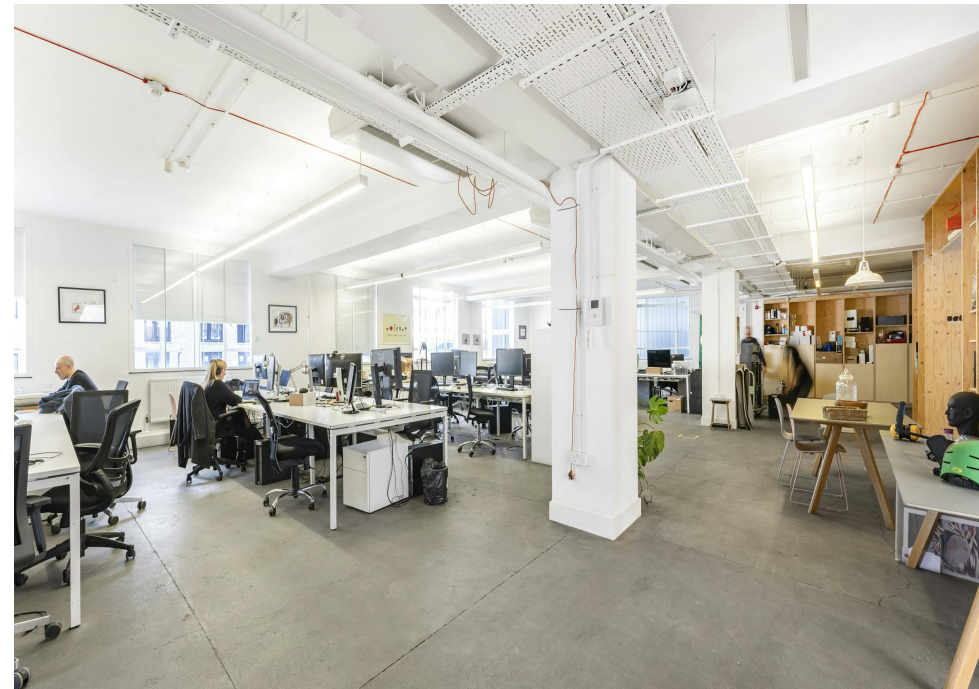

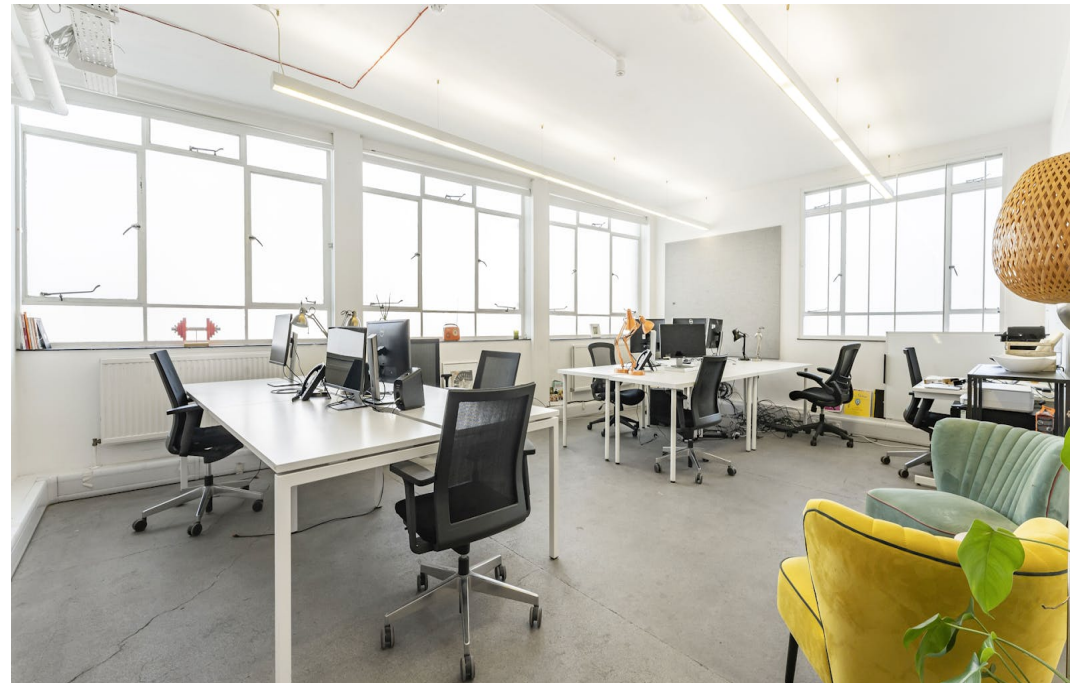
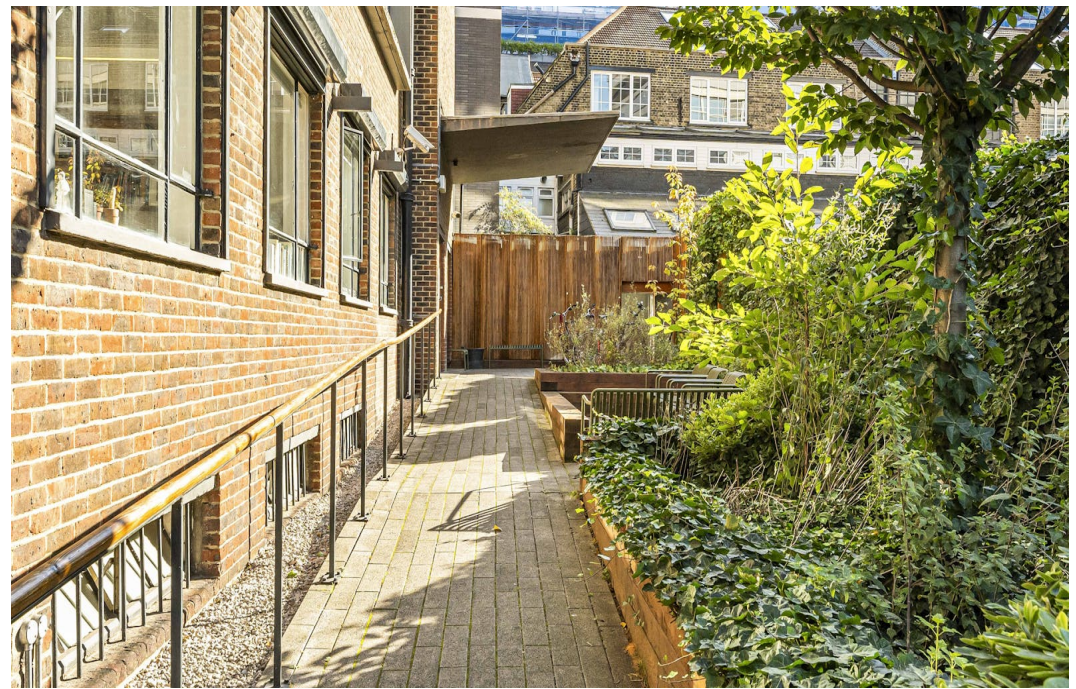
Location
