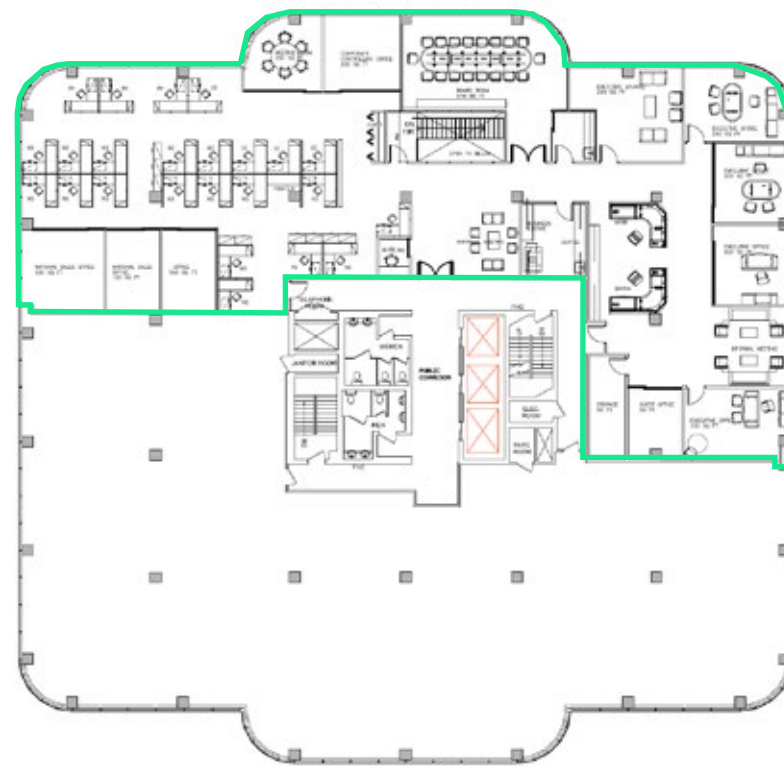
Floor Plans

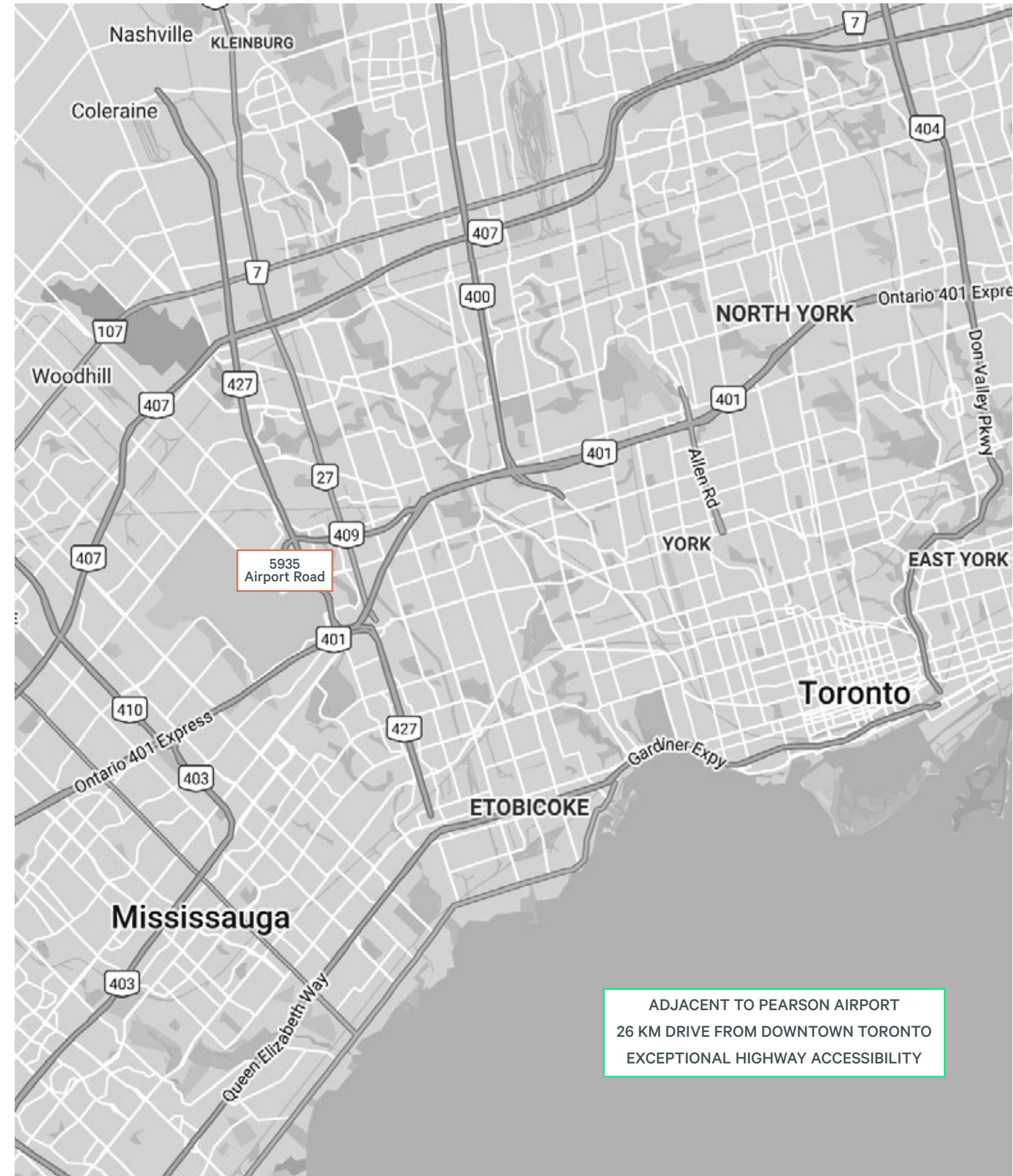
