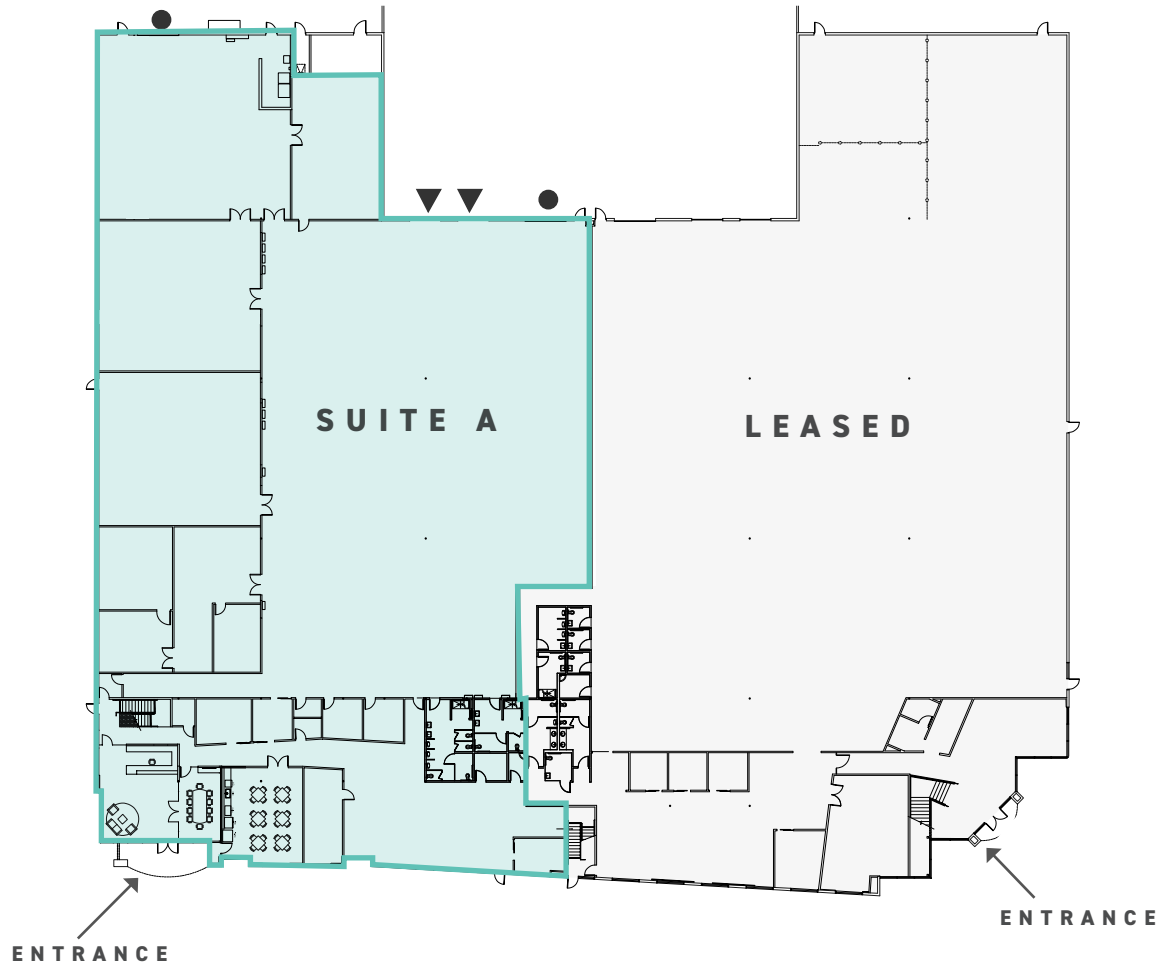

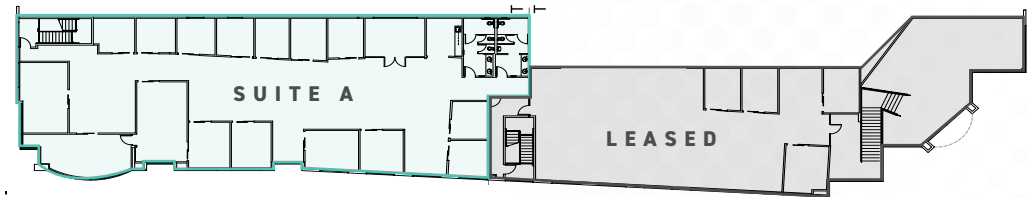

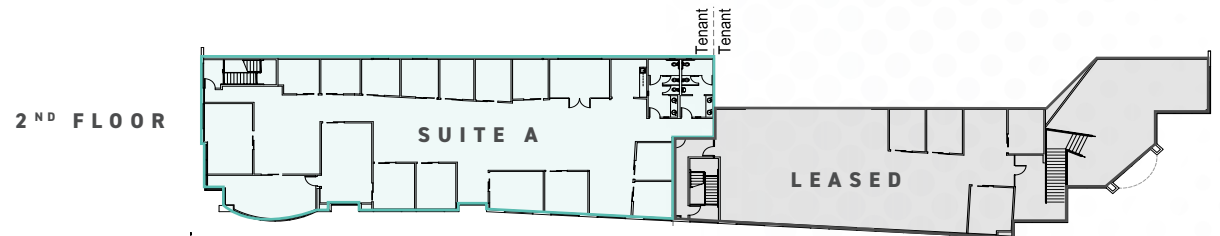
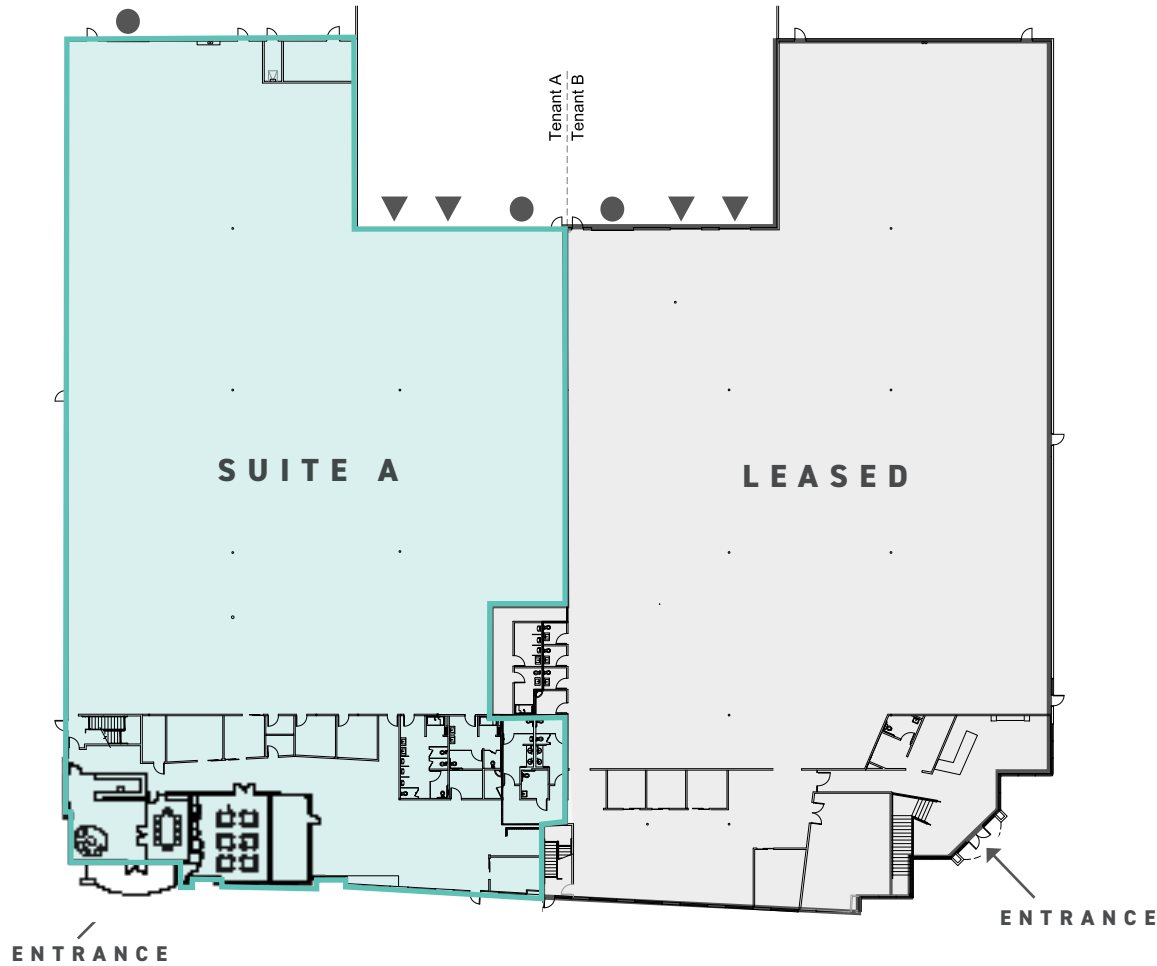


CONCEPT IMPROVEMENT PLAN

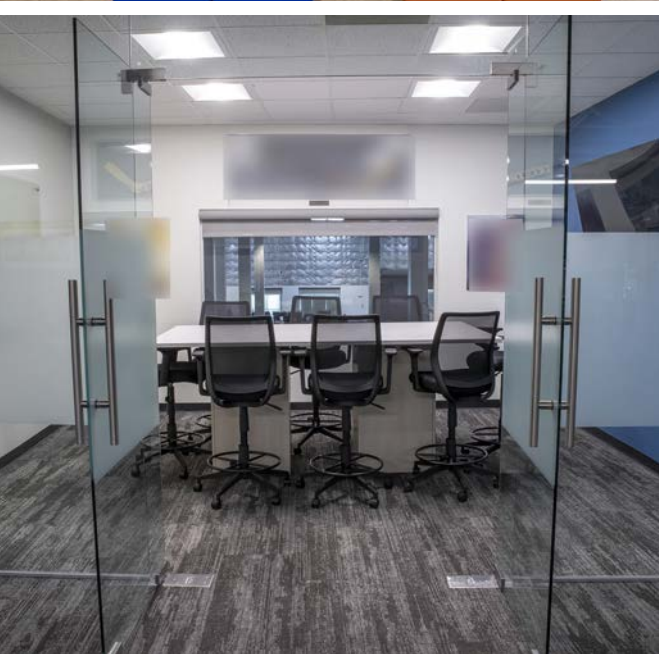
