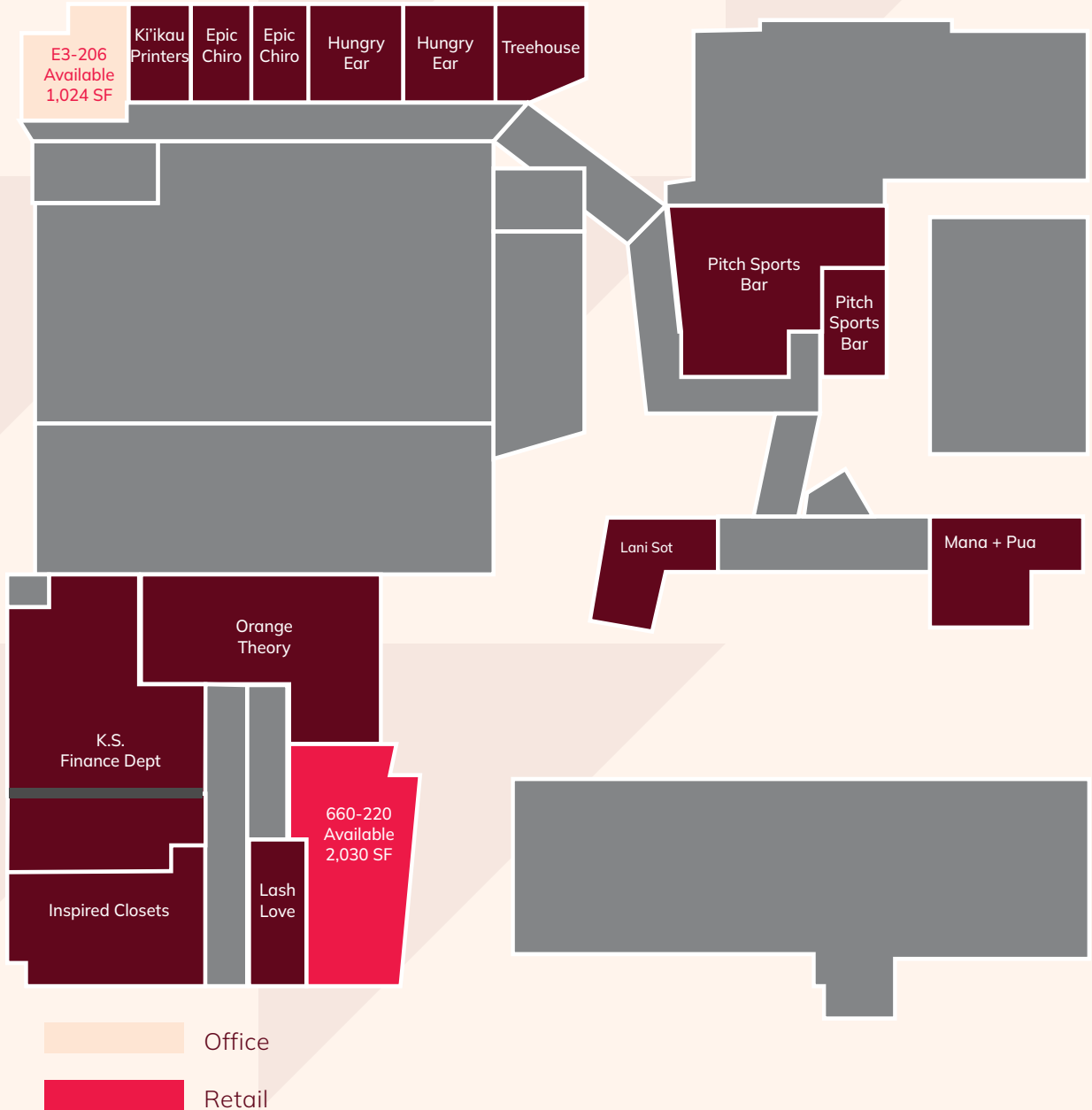
GROUND FLOOR

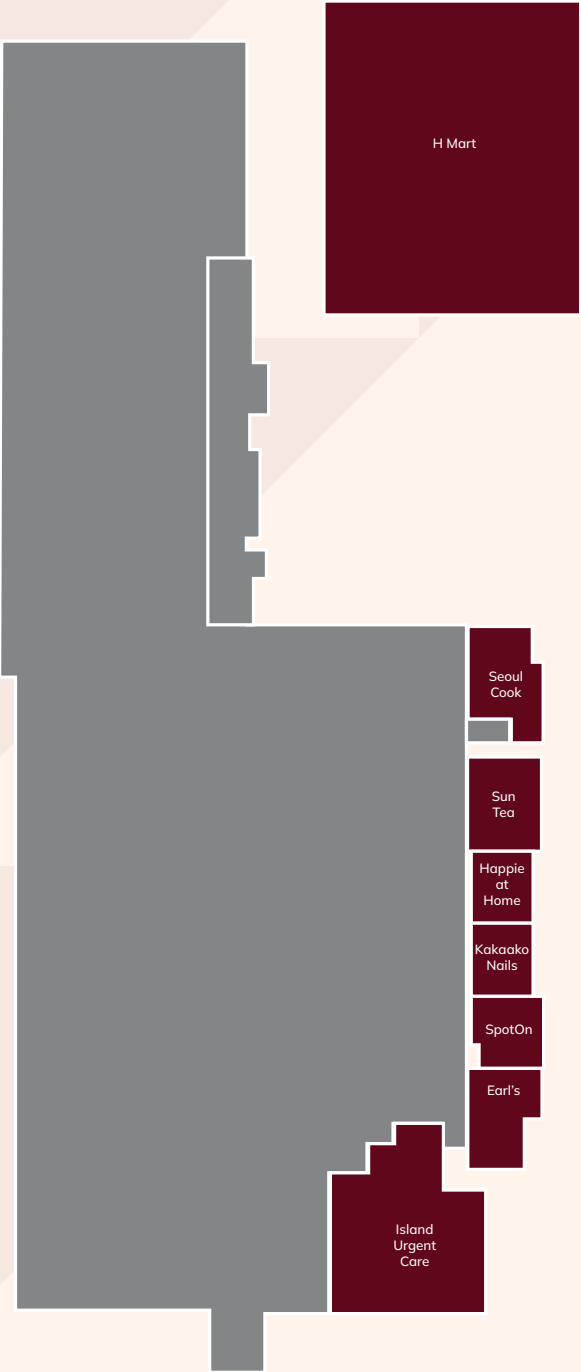

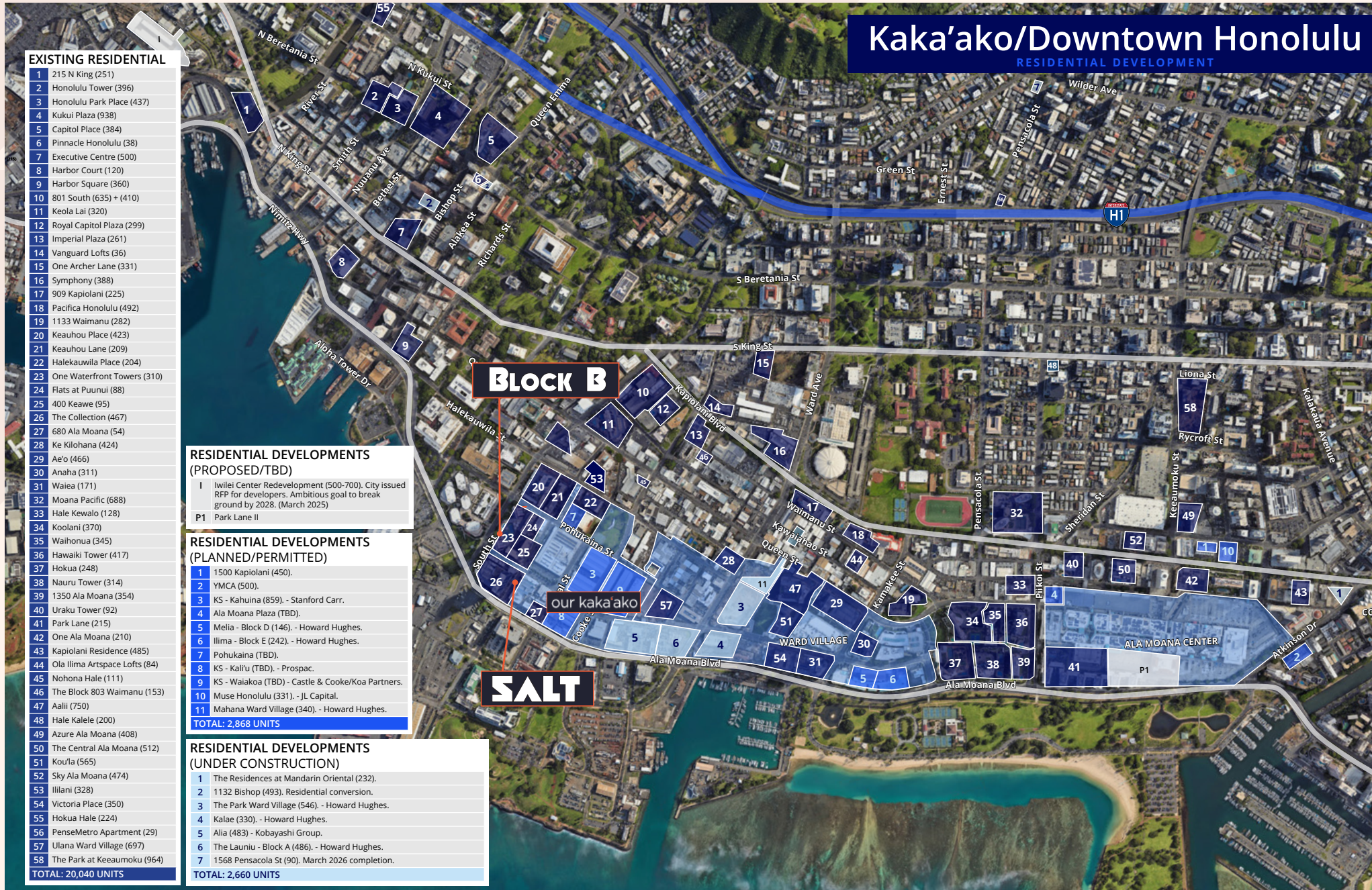
