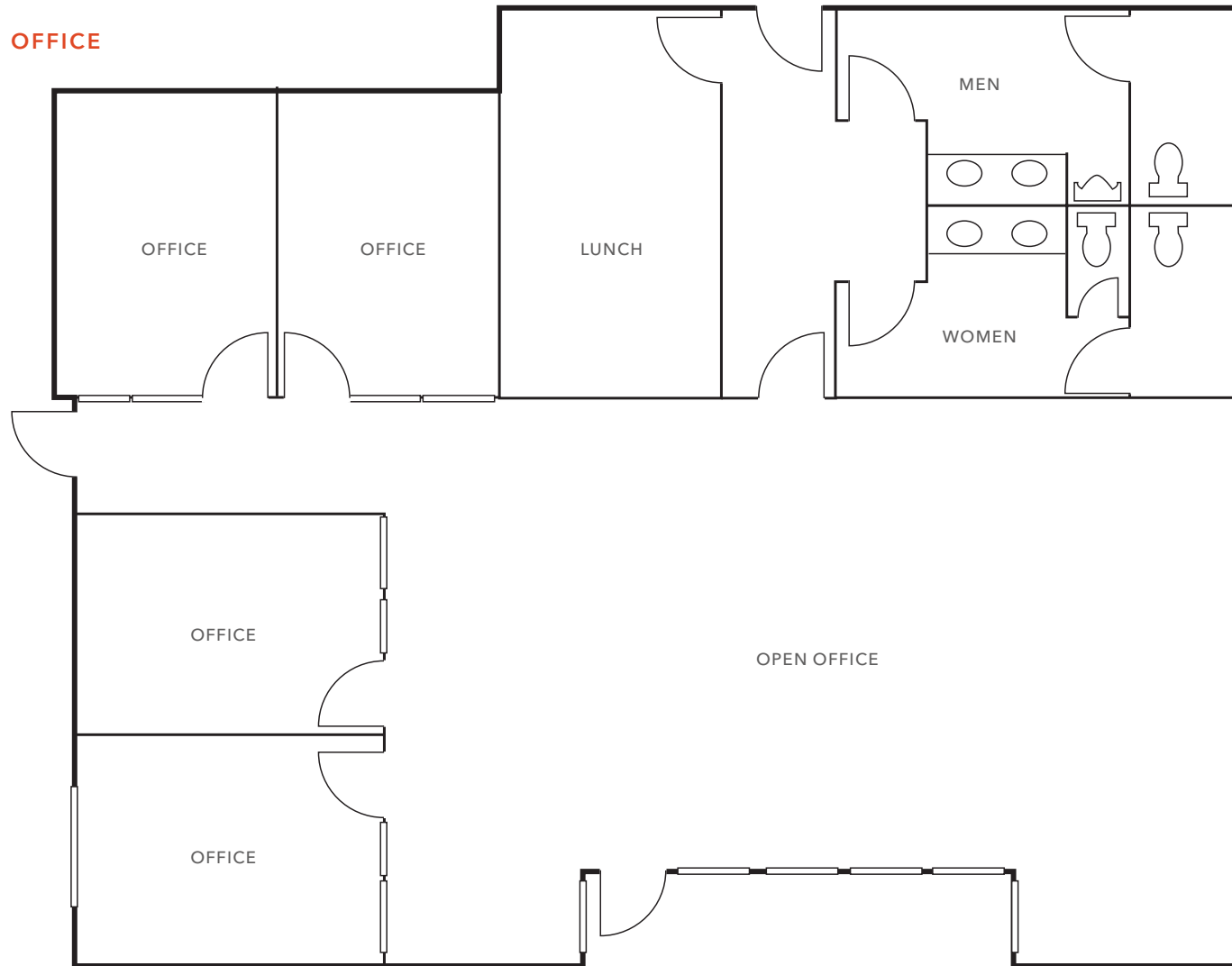

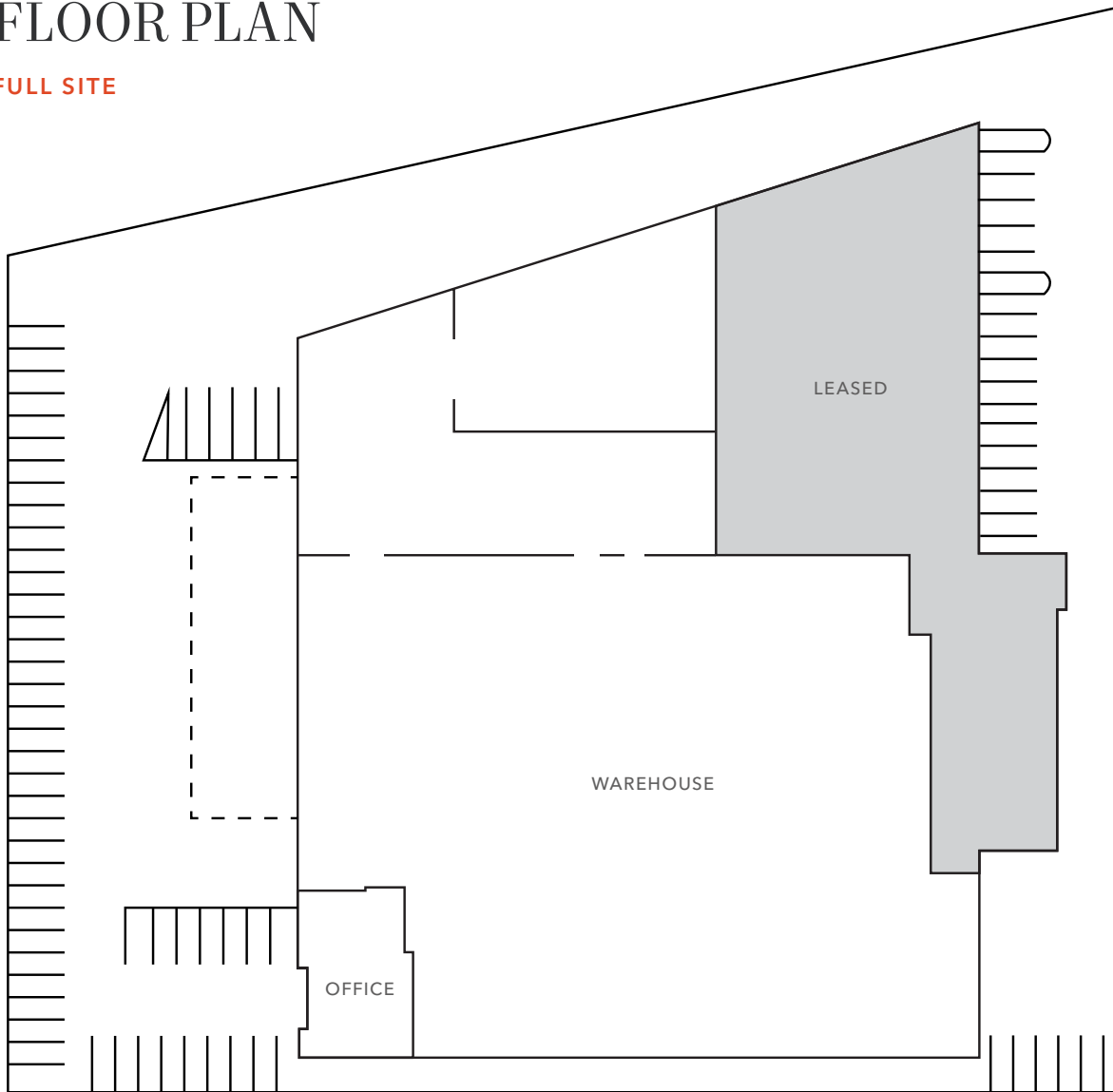

FLOOR PLAN

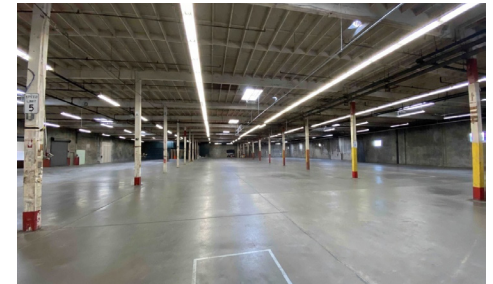
FULL SITE
