- Attractive landscaped grounds.

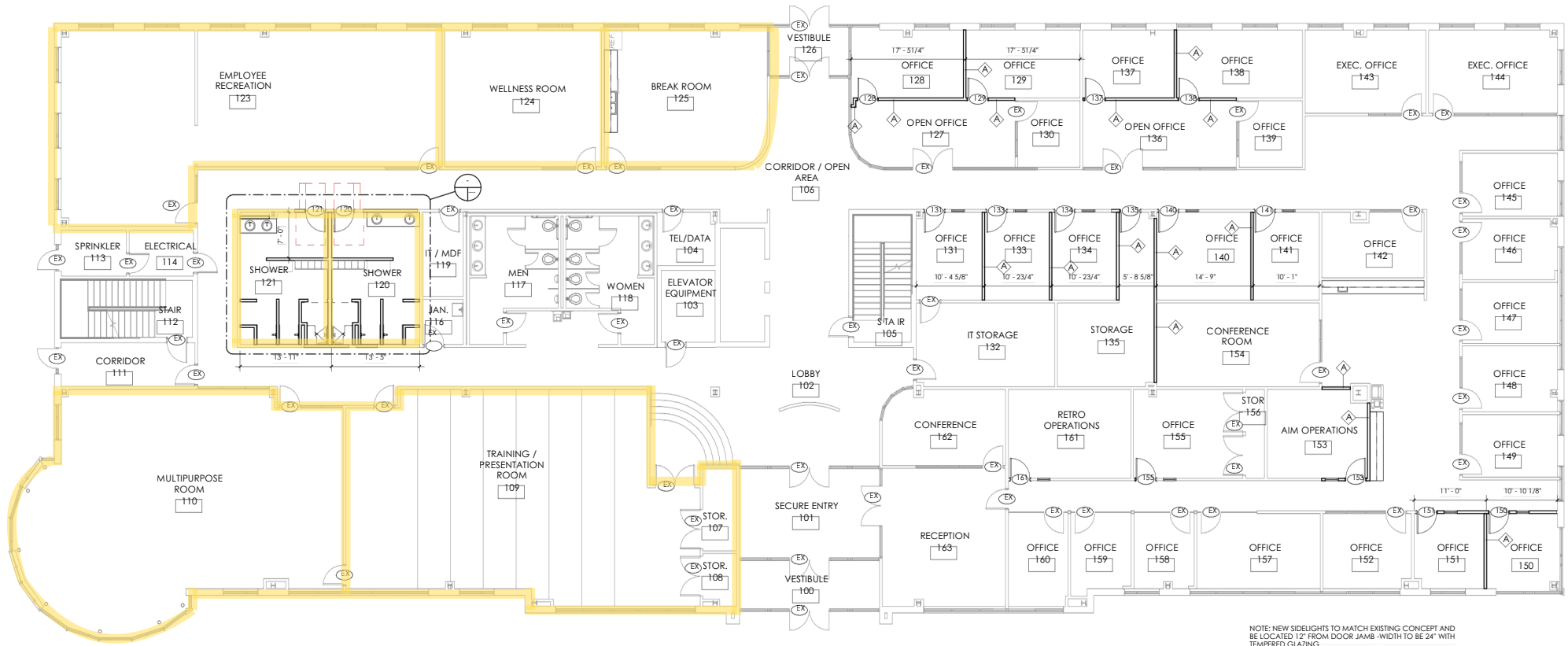
