The property represents an opportunity to purchase a commercial strata unit in first phase of the Cedar Park Plaza. The subject unit has a total gross leasable area of 1,364 sq.ft., including 771 sq.ft. of ground floor commercial space and 593 sq.ft. of lower floor office space. The property is zoned C5 and the City of Abbotsford designates the property as "Urban Centre." The intent of this designation is to enable a mix of multifamily and commercial uses to strengthen existing hubs that serve a city-wide function. Buildings typically include a mix of retail and/or office space on lower floors and residential units on upper floors. Uses include multi unit residential, commercial and mixed use (residential and commercial).

The property is located on the north side of Hillcrest Avenue just east of Clearbrook Road in The City of Abbotsford's Clearbrook area. The property has easy access to the TransCanada Highway, all amenities, and the rest of the Lower Mainland.
