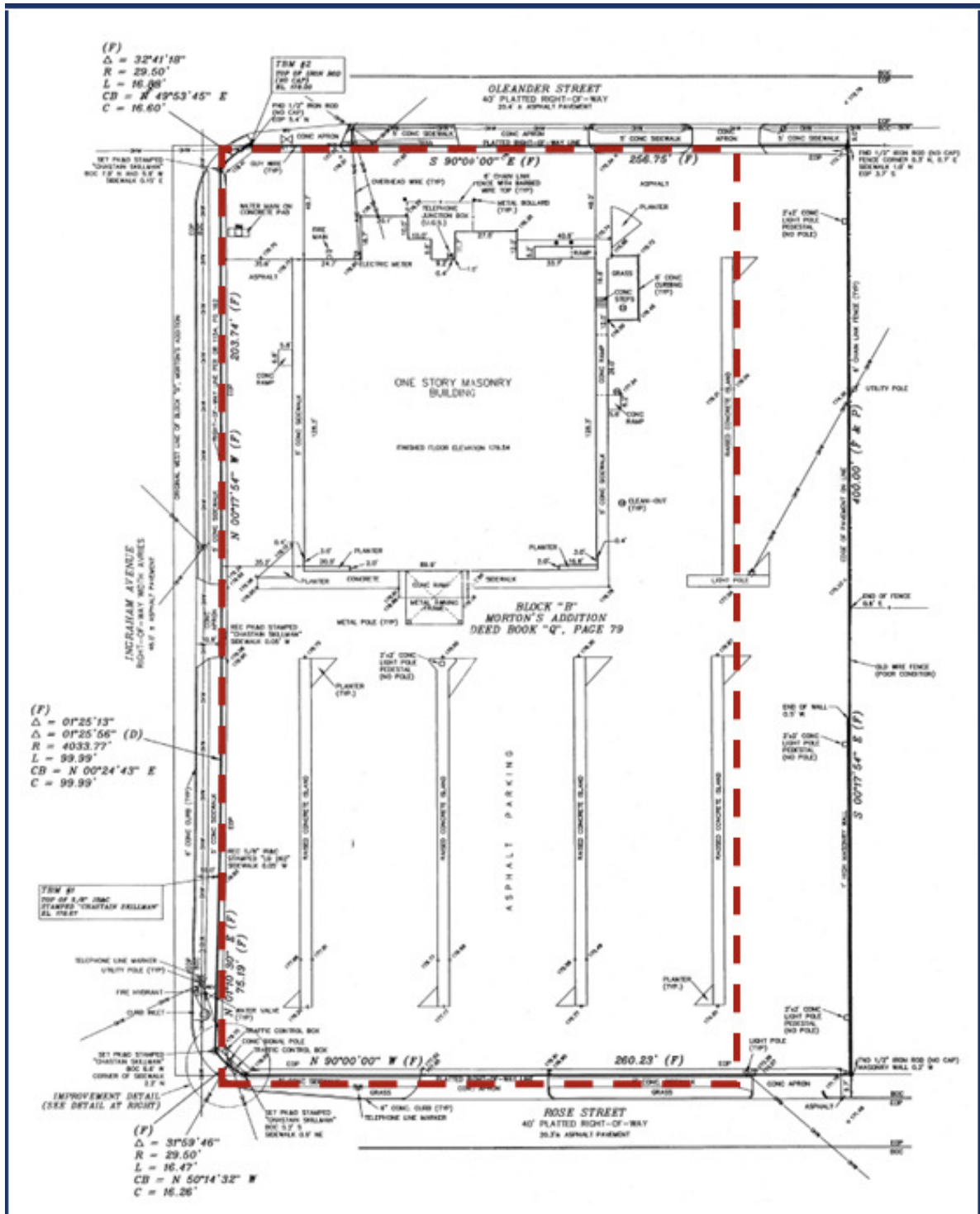


Office Layout



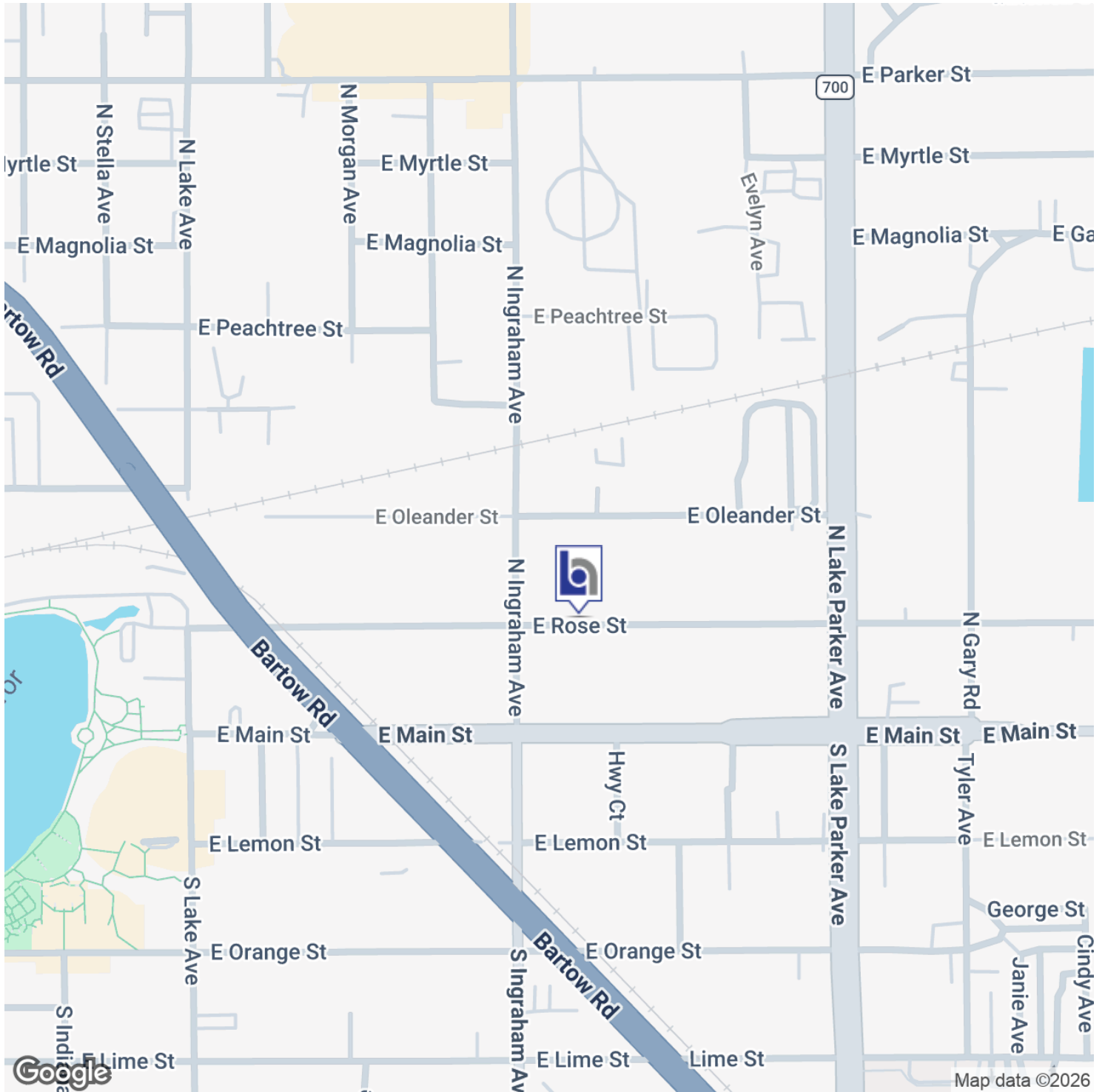


Site Plan
