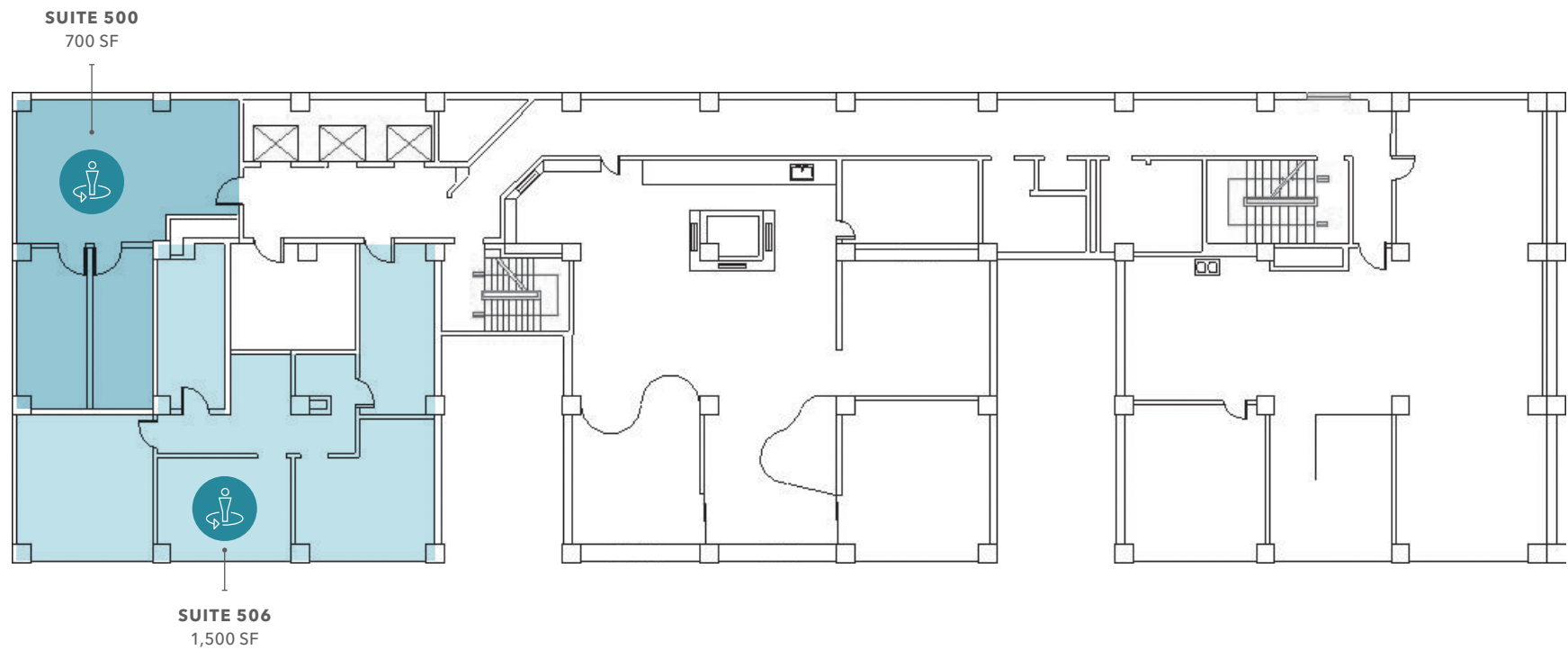

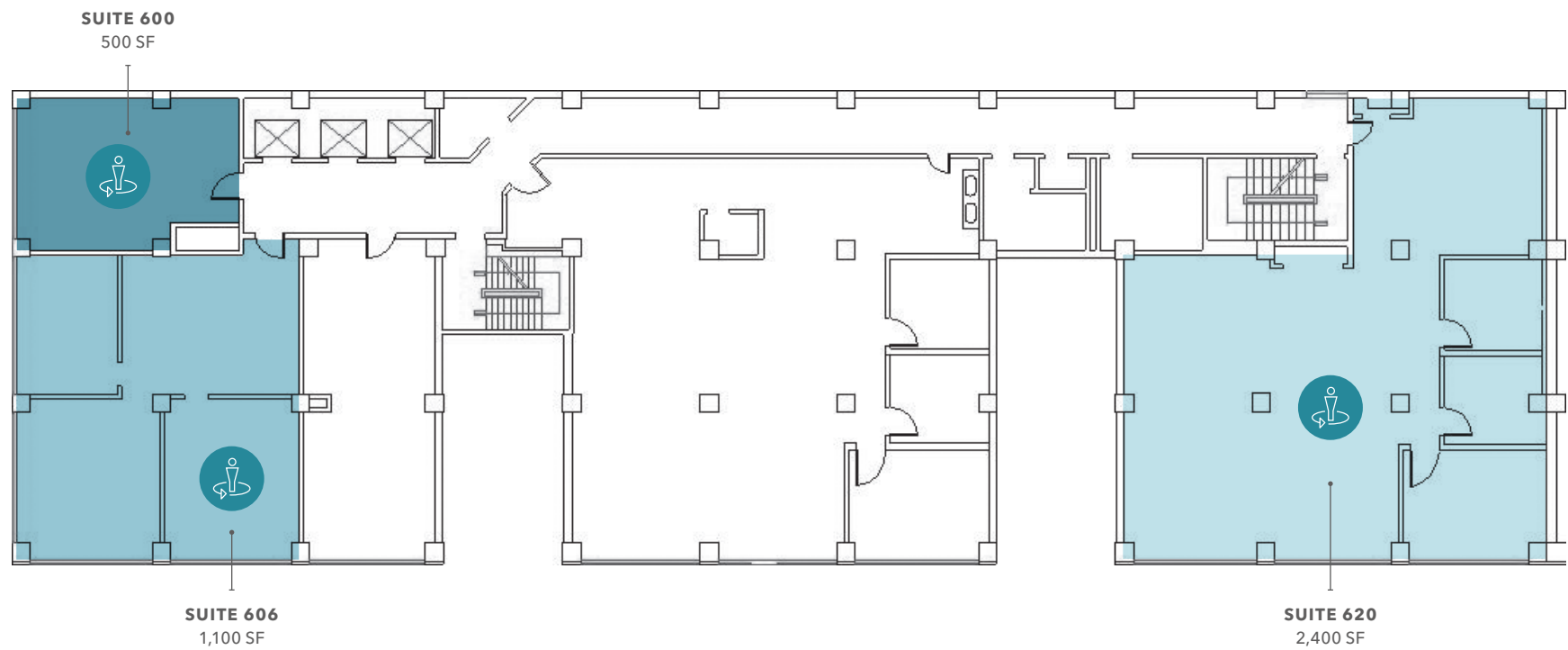
SECOND FLOOR PLAN

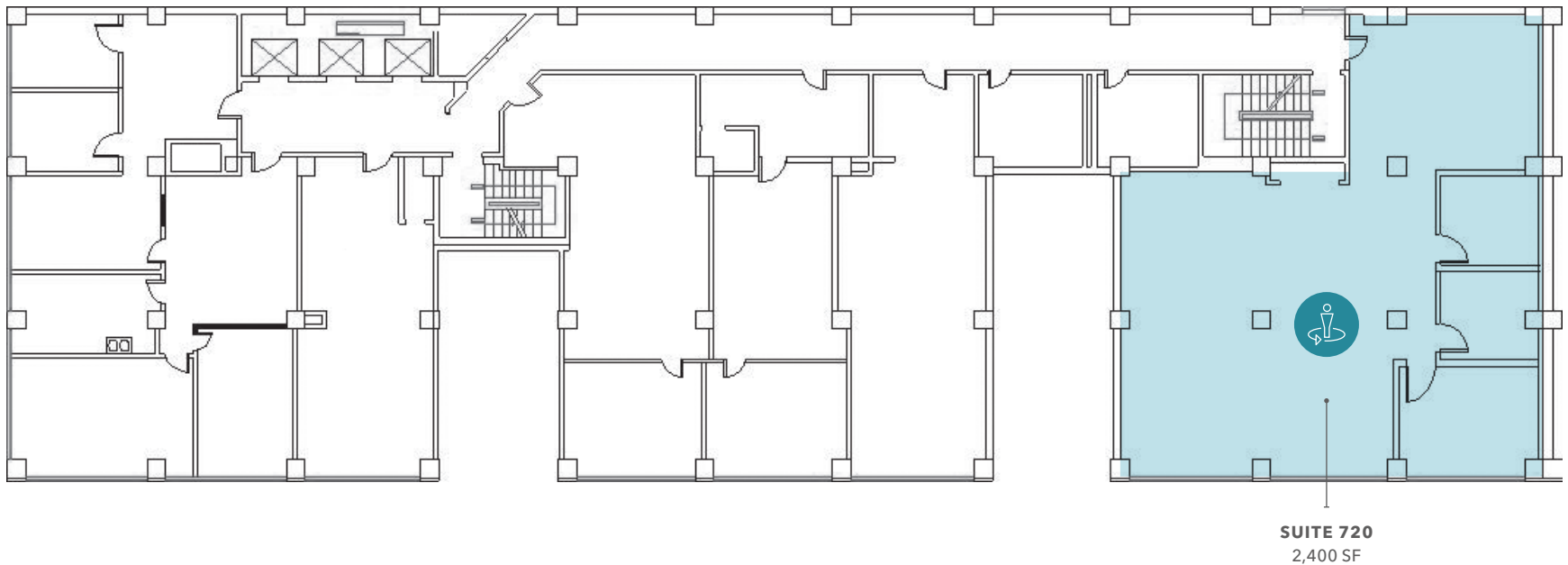
FIFTH FLOOR PLAN

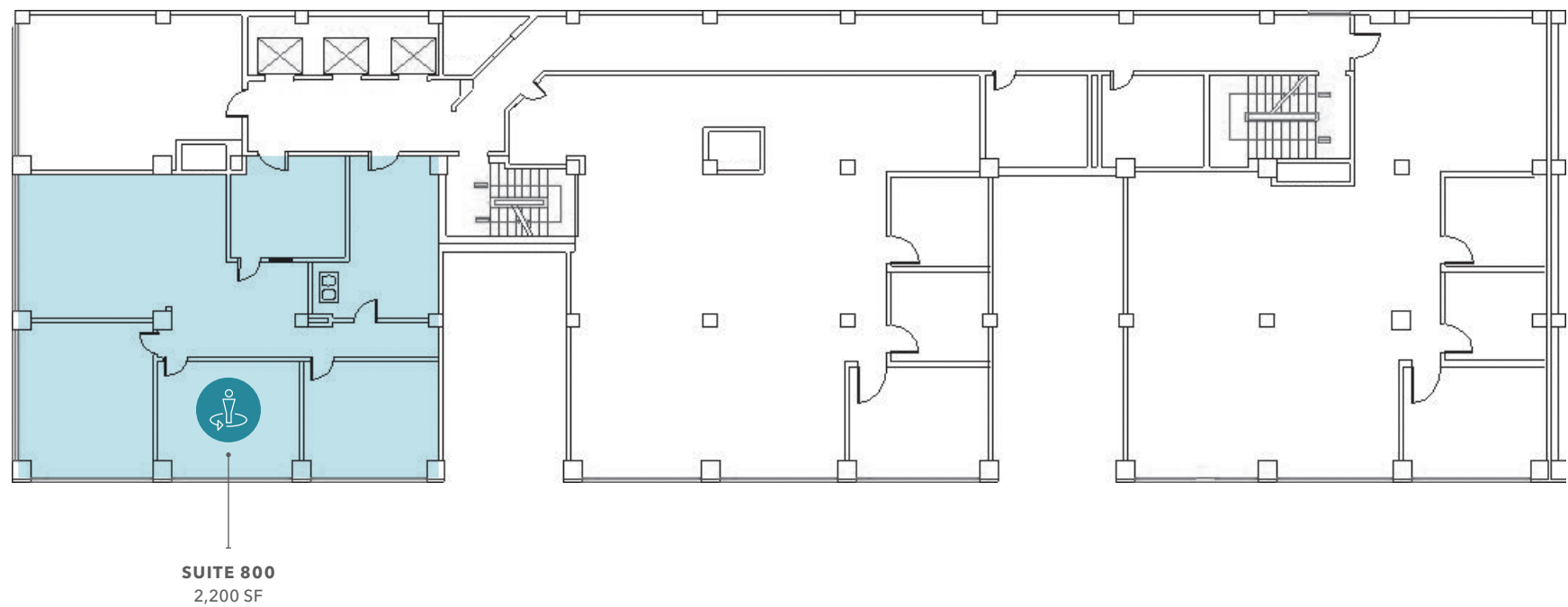

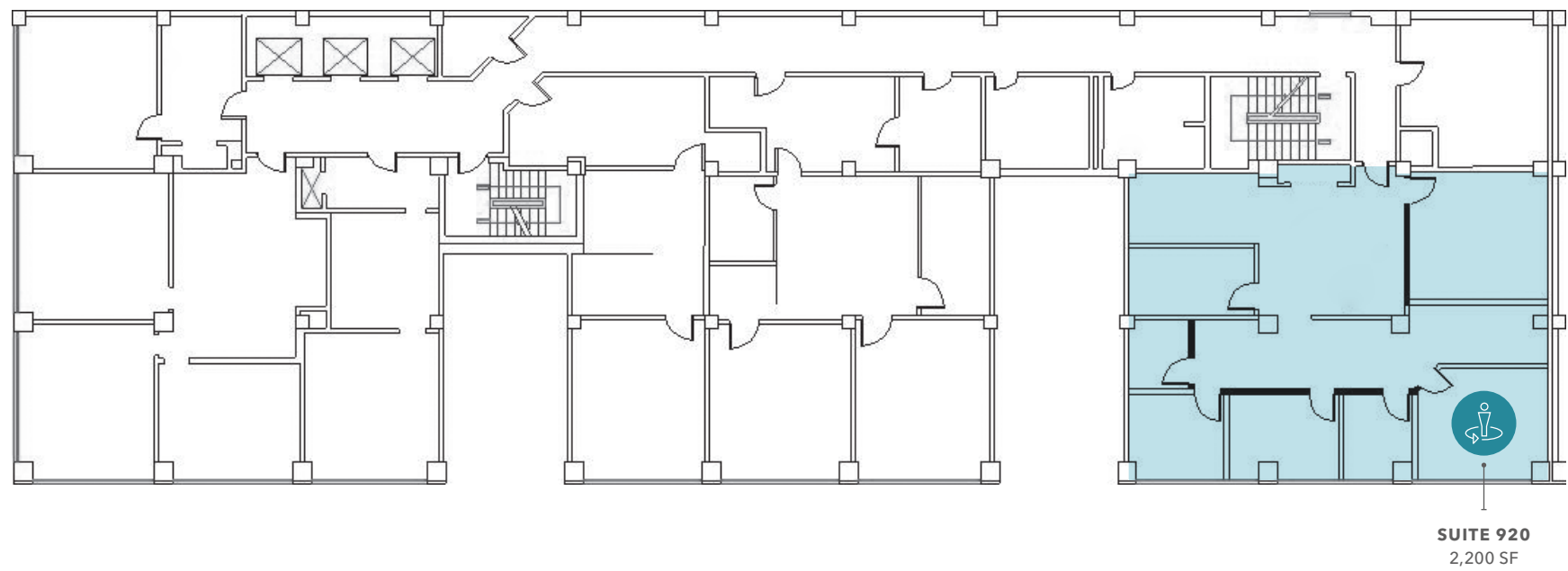
SEVENTH FLOOR PLAN

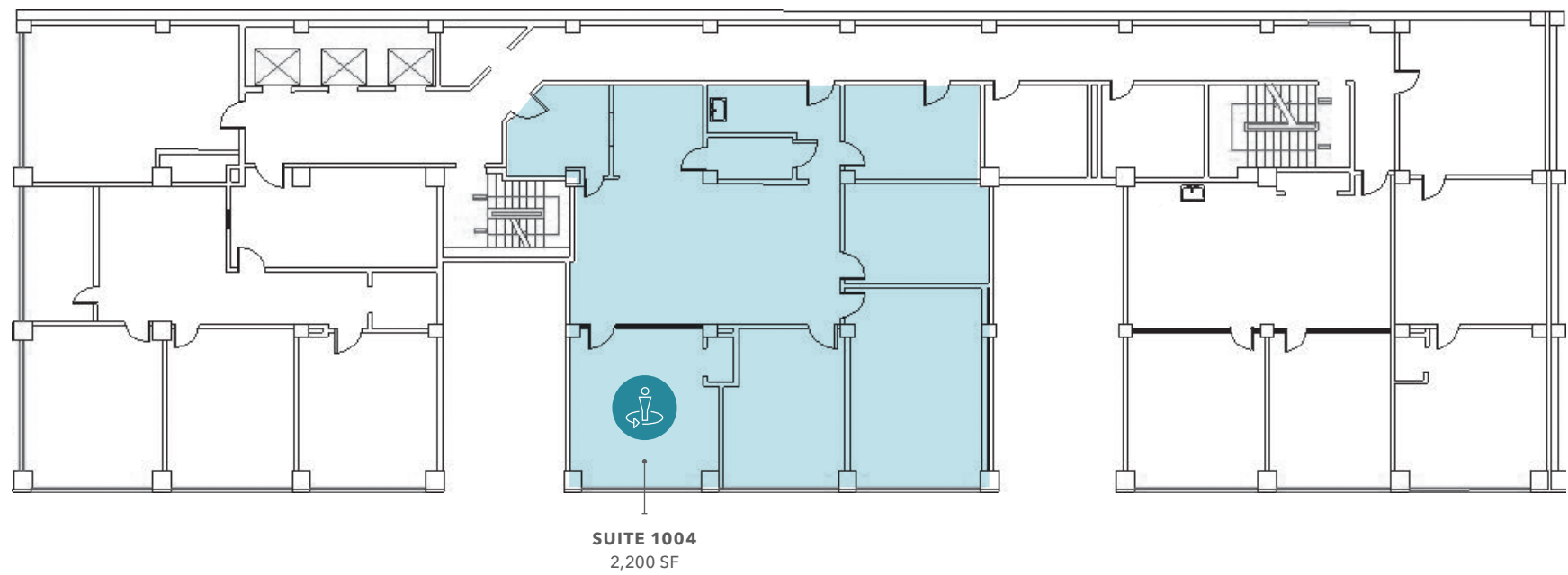
EIGHTH FLOOR PLAN
