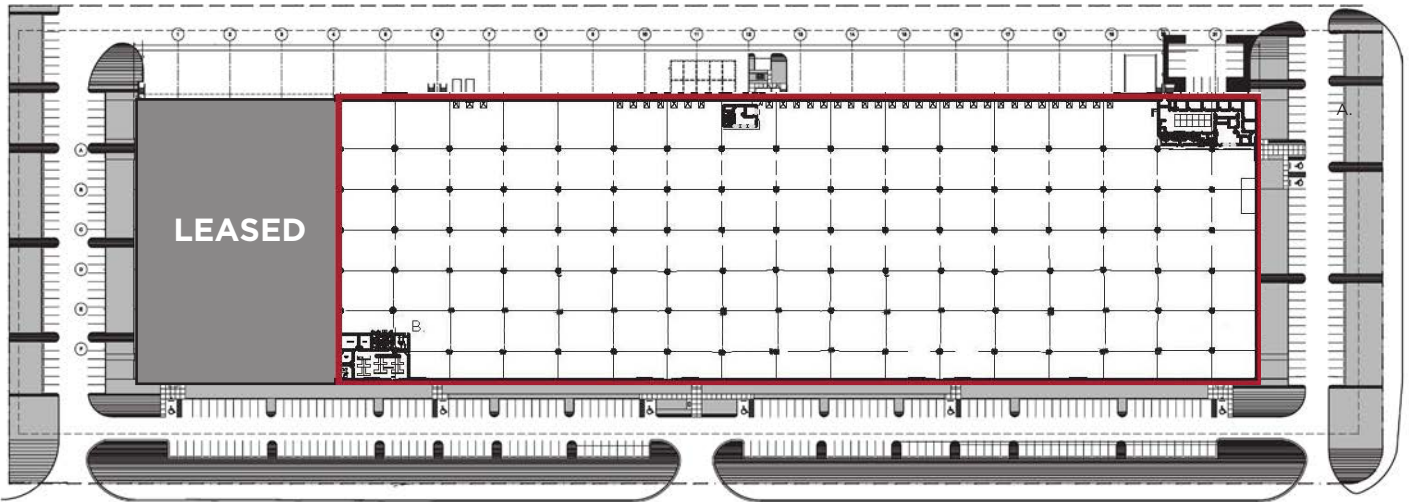

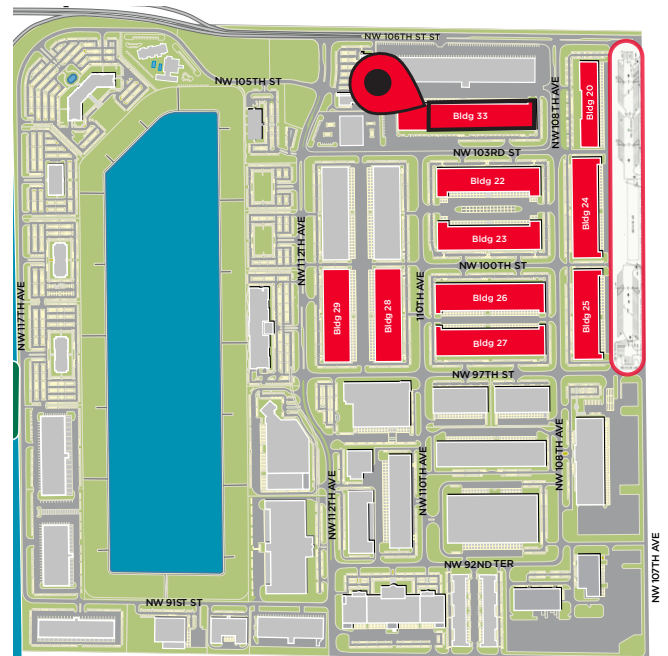
Site Plan

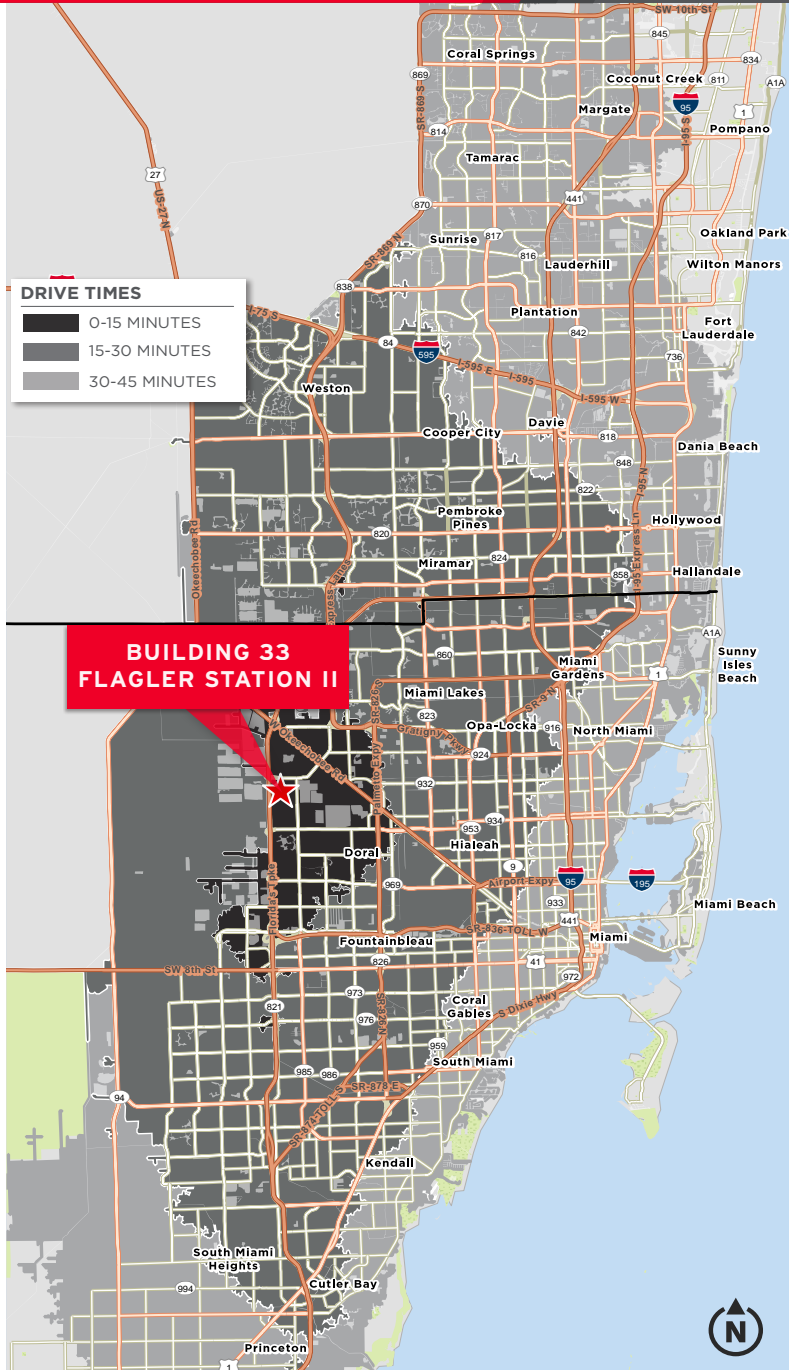
