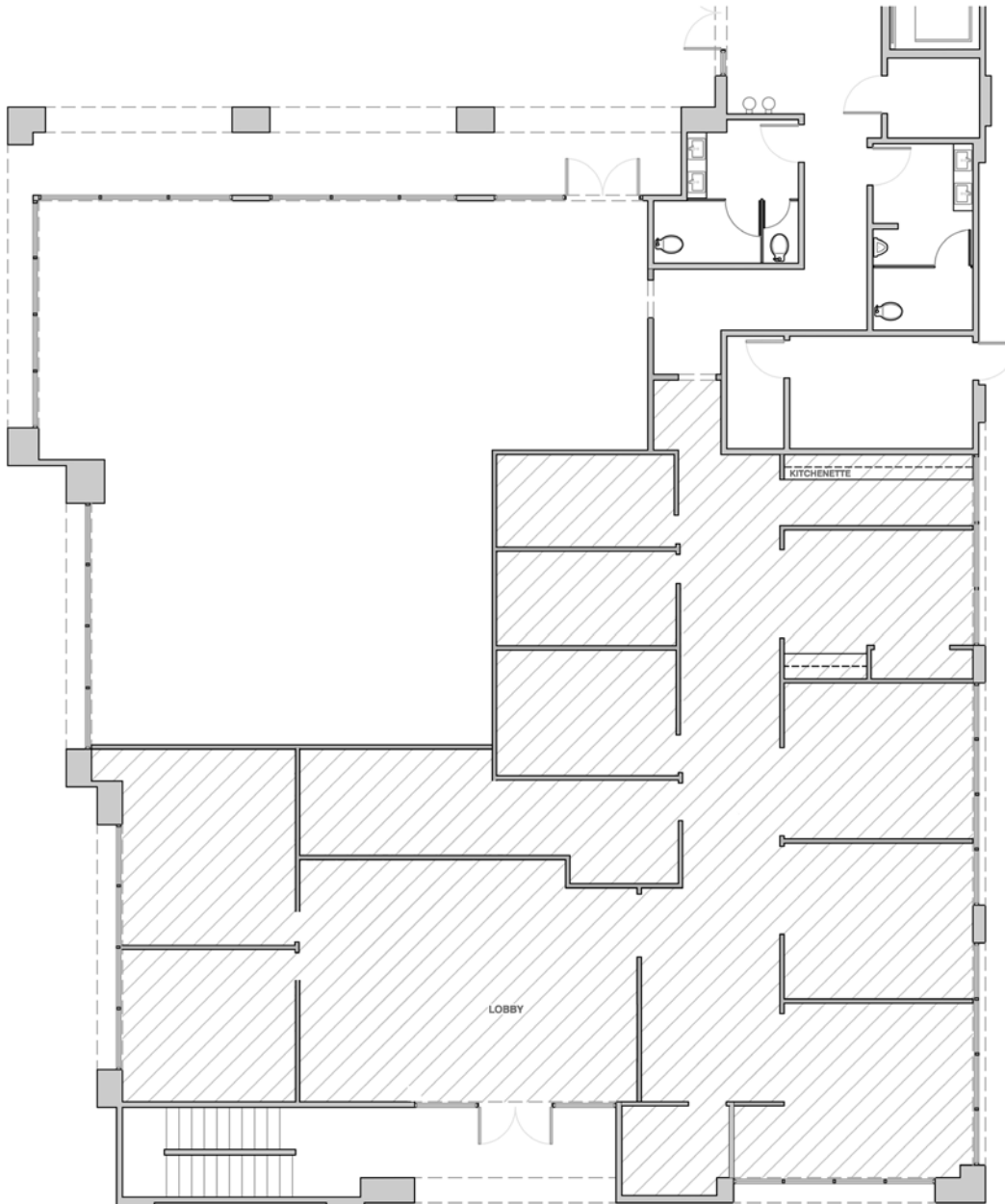

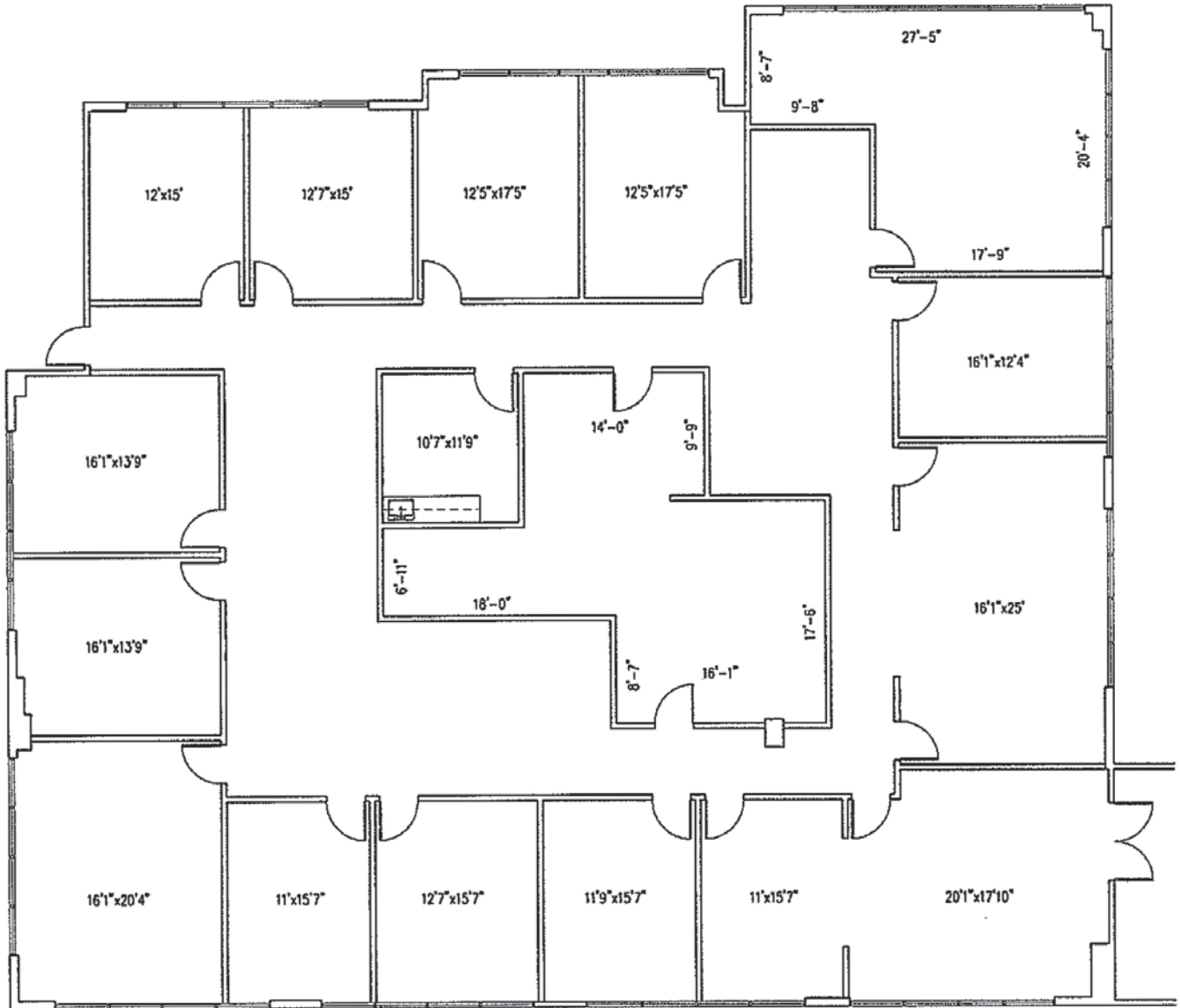

Flexible Demising Pan: $\pm 2,500$ SF - $\pm 3,210$ SF



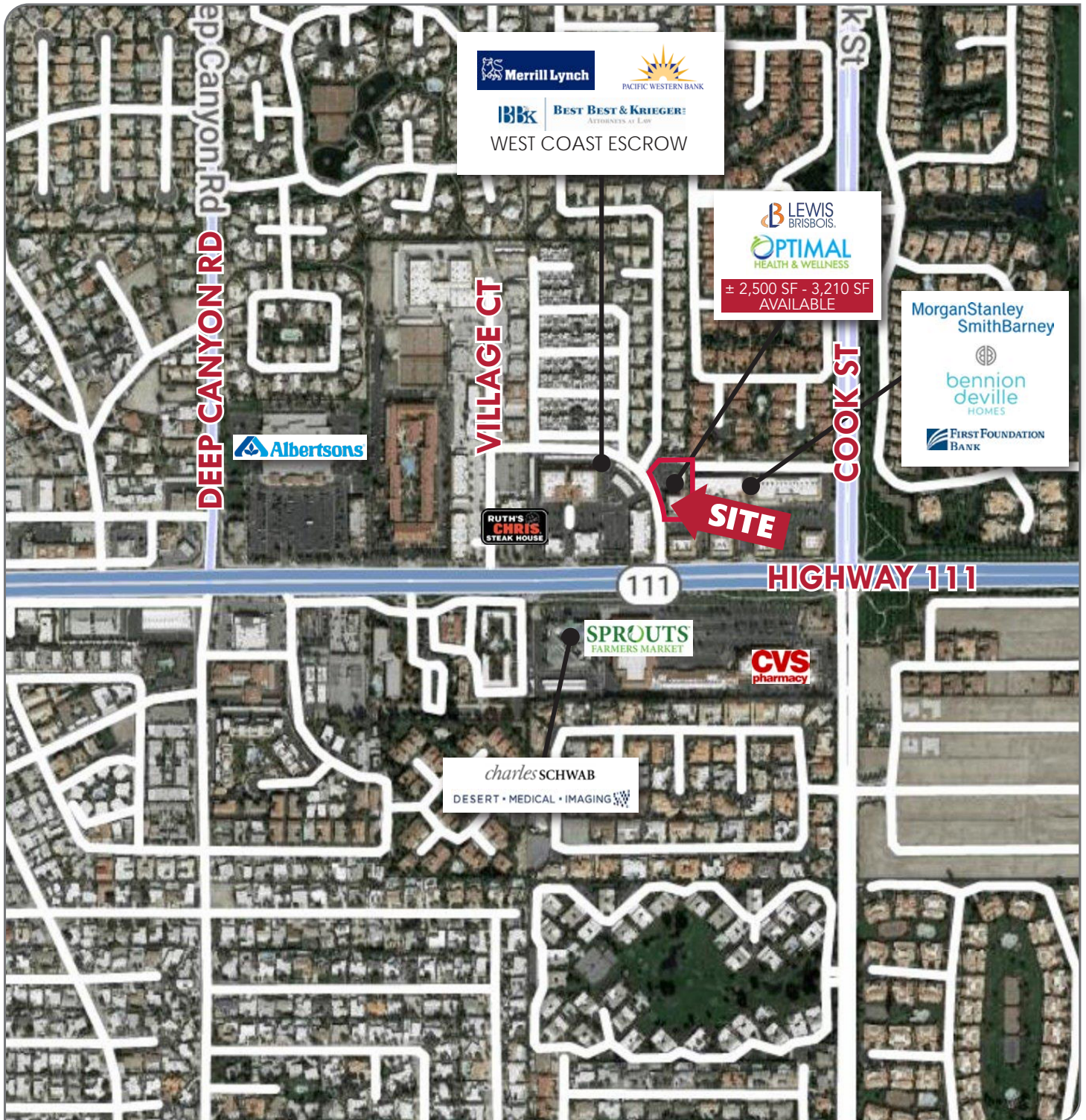
