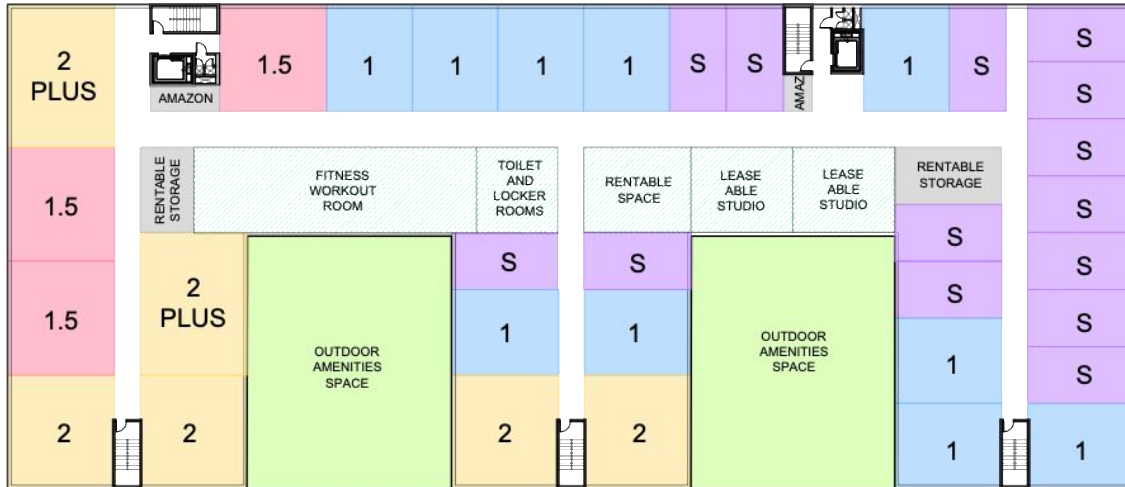

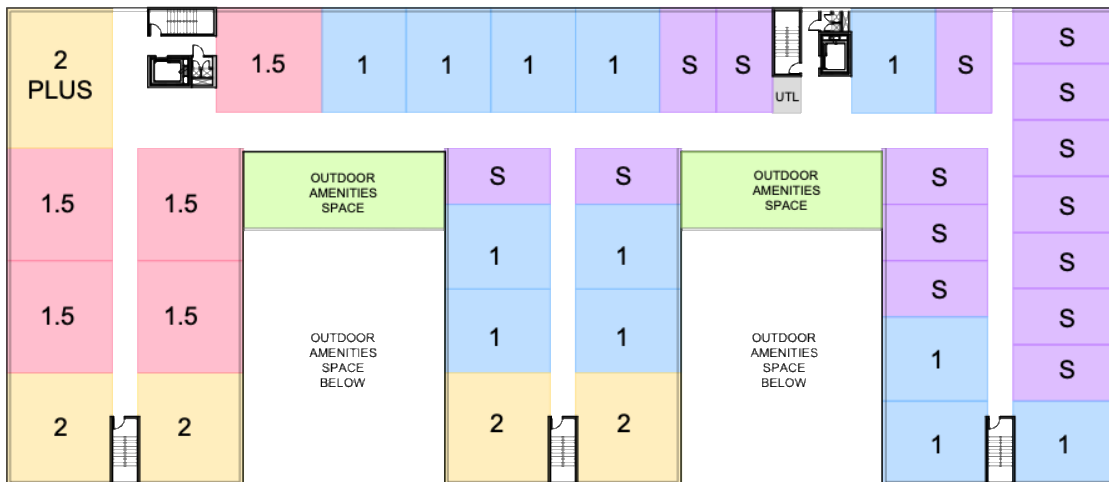

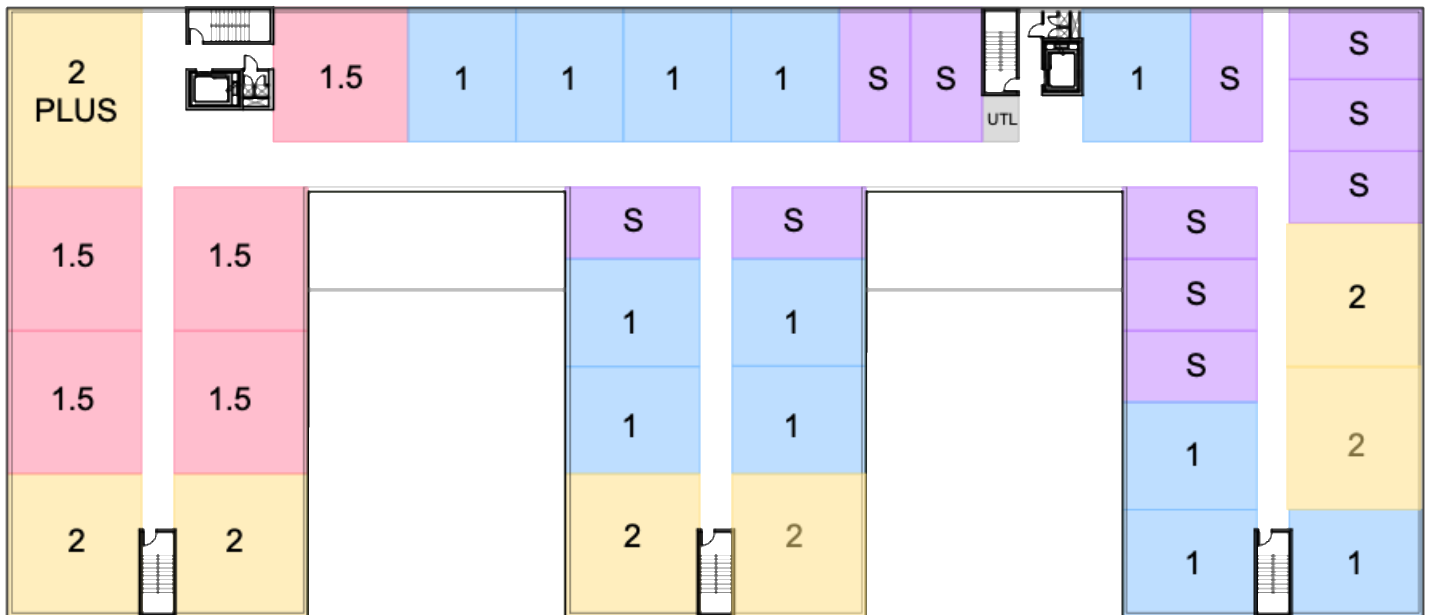
LEVEL 2

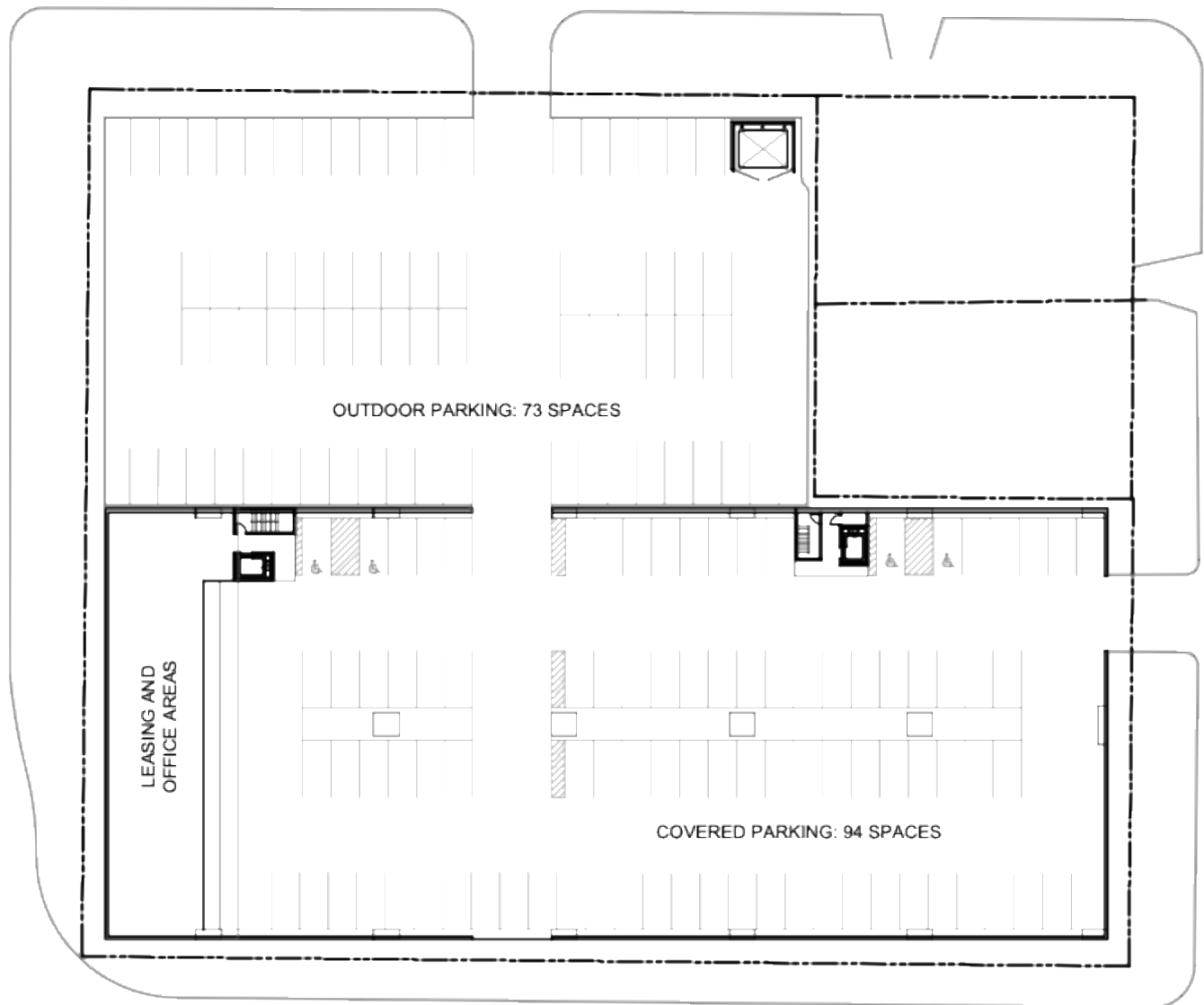
LEVELS 3-4

PARKING LAYOUT PLAN

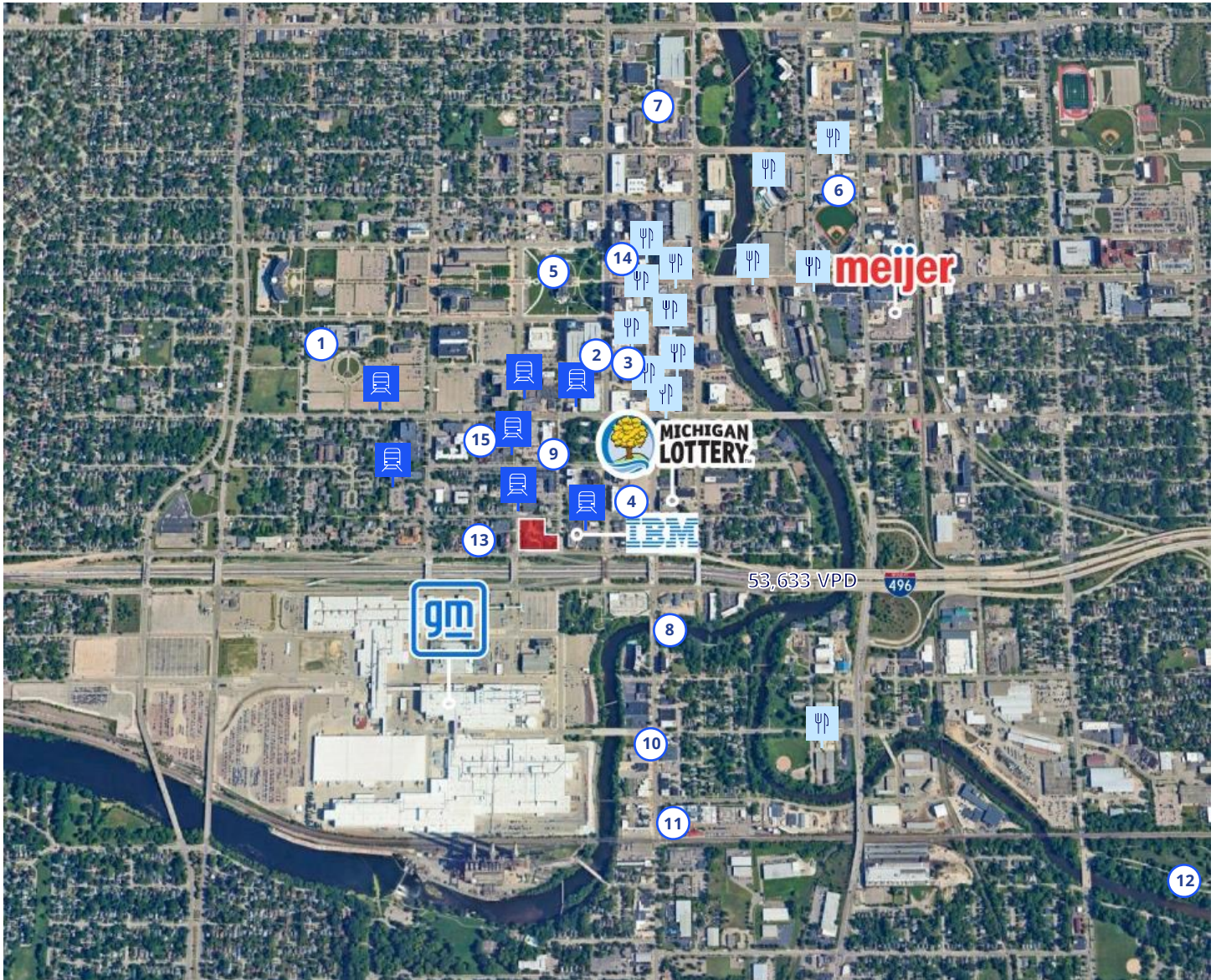
