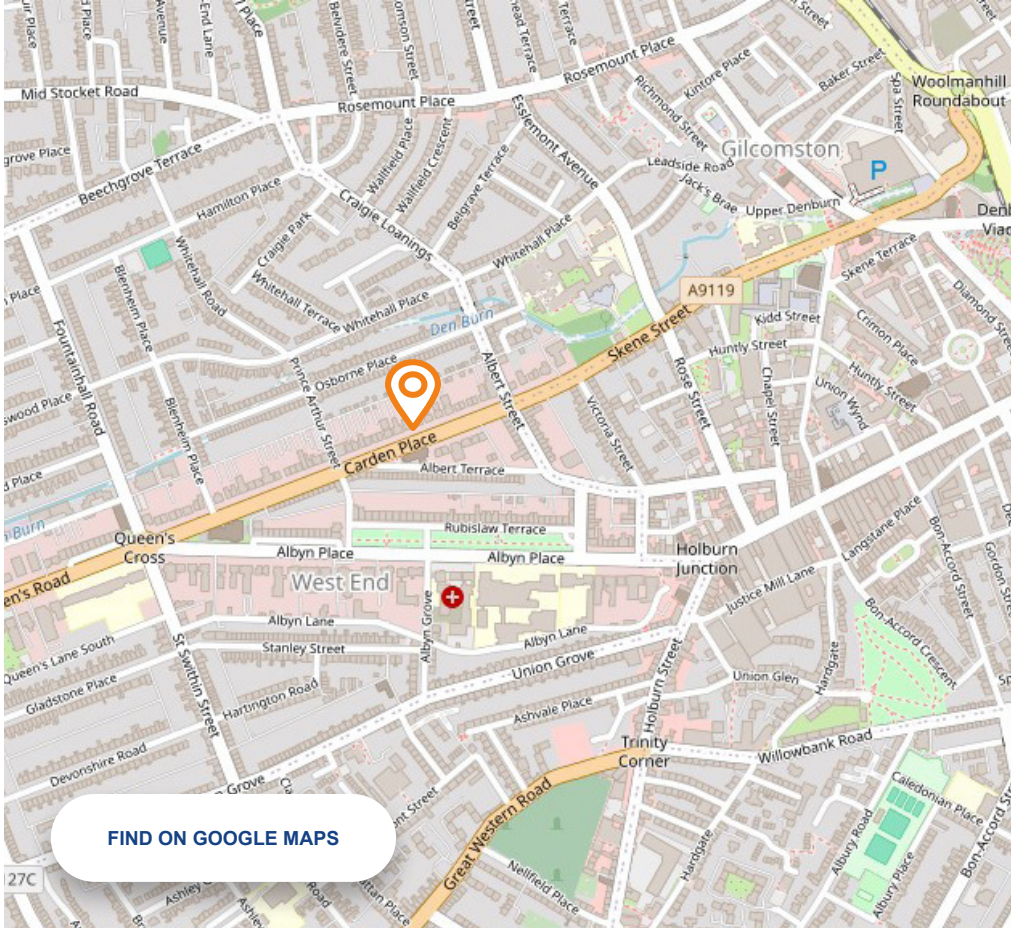

LOCATION

17 Carden Place has a prominent south facing setting on a busy arterial route in the centre of Aberdeen's prime West End district.

It is located less than a mile from the city centre and also less than a mile from the city's main ring road, Anderson Drive (A92), providing easy access to all parts of the city.

Nearby occupiers include; Cognito at the Cross, Parx Cafe, Abrdn, Johnston Carmichael, The Albyn and No. 10.

DESCRIPTION

The building comprises a detached office building of granite construction under a pitched slated roof. Arranged over three floors and incorporating a modern two-storey extension to the rear, the property is in excellent condition throughout.

Internally, the office includes a mix of open plan and cellular accommodation finished to a high standard.

At first floor level there is one large open plan office suite contained within the original granite building.

At ground floor the property benefits from an impressive vestibule entrance including; reception area, boardroom and two further meeting rooms. To the rear the ground floor benefits from a large open plan suite, as well as toilets and tea prep facility.

At lower ground floor the property benefits from an open plan suite within the original building and a further open plan suite within the extension, with additional toilets, tea prep area and fully air conditioned comms room.

It should be noted that access can also be gained from the rear.

There are 18 car parking spaces to the rear, as well as a further 6 spaces to the front.
