Dean Court is a fully refurbished, air-conditioned office building providing occupiers with a light, secure, comfortable and convenient workplace on one of the most sought-after commercial streets, in the heart of Newcastle city centre.

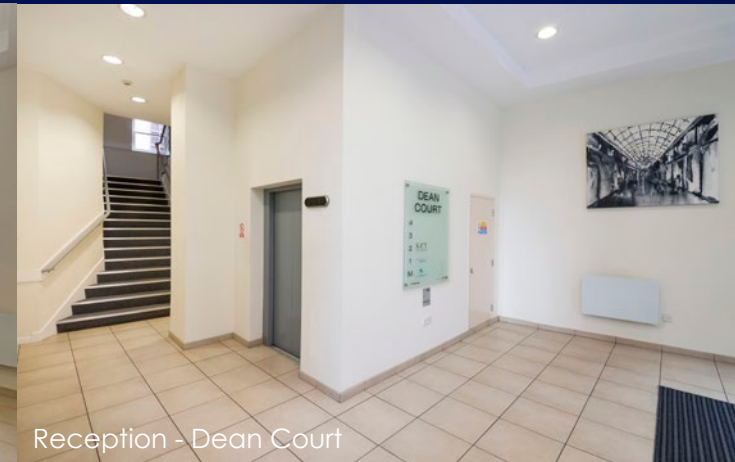
The offices have solid concrete floors with carpet covering, plastered painted walls and suspended ceilings with LG3 compliant recessed lighting.

Each floor benefits from a small kitchen area and heating and there are male and female WCs on all office floors, with a disabled WC on the ground.

The building benefits from having an energy efficient heat recovery VRV system capable of simultaneous heating and cooling, as well as three compartment perimeter trunking.

There is an impressive entrance area, audio visual door entry system and fob reader security system to all floors. There is also a DDA compliant lift to all floors.

The accommodation is generally open plan in nature. Accommodation could be reconfigured to suit a new tenant's specification.

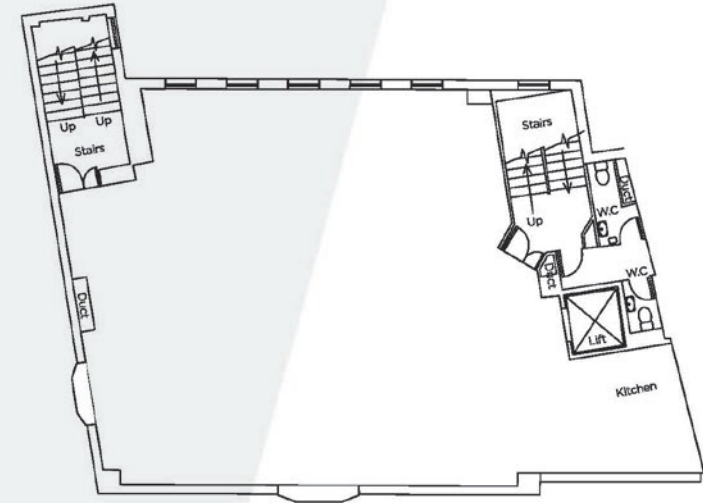
This third floor office offers 2,037 sq. ft of available space within Dean Court.

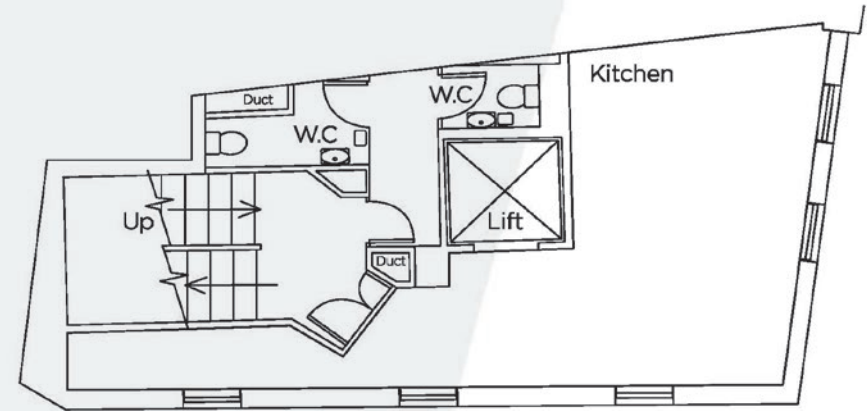

Dean Court is in a prominent location on the east side of Dean Street, the principle commercial link between the city centre, Grey Street and Newcastle's vibrant Quayside.

The immediate surrounding area is characterised by mixed land uses to include offices, leisure, retail and residential.

Public transport is readily accessible with both the Tyne and Wear Metro System and East Coast Main Line Rail services within a 5 minute walk at Newcastle Central Station.

The Quaylink Electric Bus Service which passes the building also provides links to Gateshead, Quayside, Newcastle Central Station and Haymarket.

There is a 272 space multi-storey car park nearby which is part of the City Council's Alive After Five scheme, meaning the car park is free from 5pm every day. The car park has manned CCTV security to the rear of Dean Court and is accessed from Dean Street.
