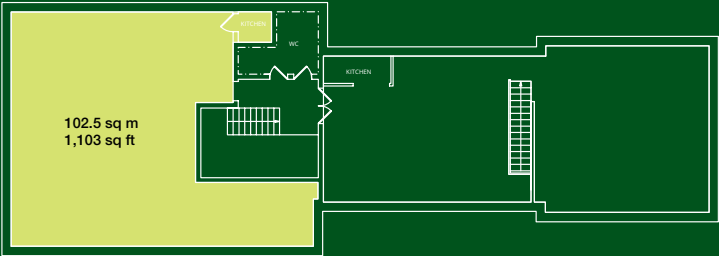

ABOUT BROTHERSWOOD COURT

Brotherswood Court is a purpose built office development, which was developed around three existing farm buildings in the early 1990's, and comprises eight office buildings and a restaurant. The site also benefits from a Coffee #1 shop and hairdressers which are available for tenant and public use.

The park stands out for its attractive and mature landscaping and use of reconstituted stone for the external elevations of the majority of the buildings.
