Croydon is one of the fastest-changing areas in London, with a £5.3bn regeneration programme planned for the next few years.

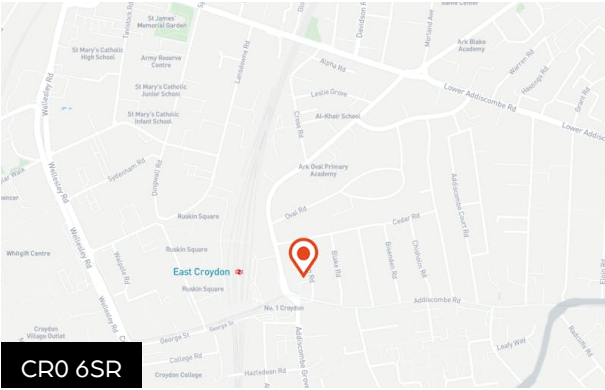
