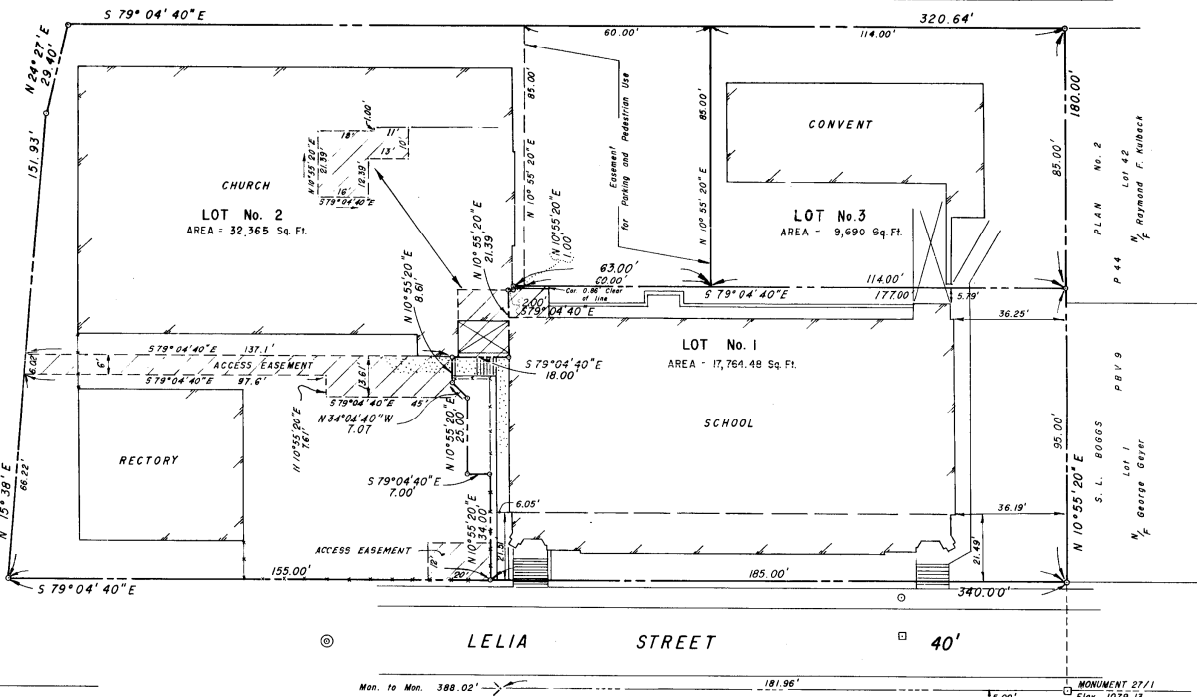

THIS DEDICATION AND RELEASE SHALL BE BINDING UPON US, OUR HEIRS, EXECUTORS, ADMINISTRATORS, AND ASSIGNS.
