The subjects are situated in a prominent secondary location with return frontages onto Upper Craigs and Wellgreen Road, a short distance from the Thistles Shopping Centre and Stirling's mainline Rail and Bus Stations.

Upper Craigs forms one of the main pedestrian routes from Stirling City Centre to the Burghmuir Retail Park, where Waitrose and TK Maxx are located. Puregym is diagonally opposite the subjects.

DESCRIPTION:

The property comprises a Retail Unit on the ground floor of a 3-storey and mansard attic tenement type building of traditional Scottish stone construction.

The premises benefit from Class 1A Consent and are attractively fitted and finished for their previous purpose as a menswear retailer.

According to our calculations from measurements taken on site, we estimate the subjects extend to the following approximate net internal areas:

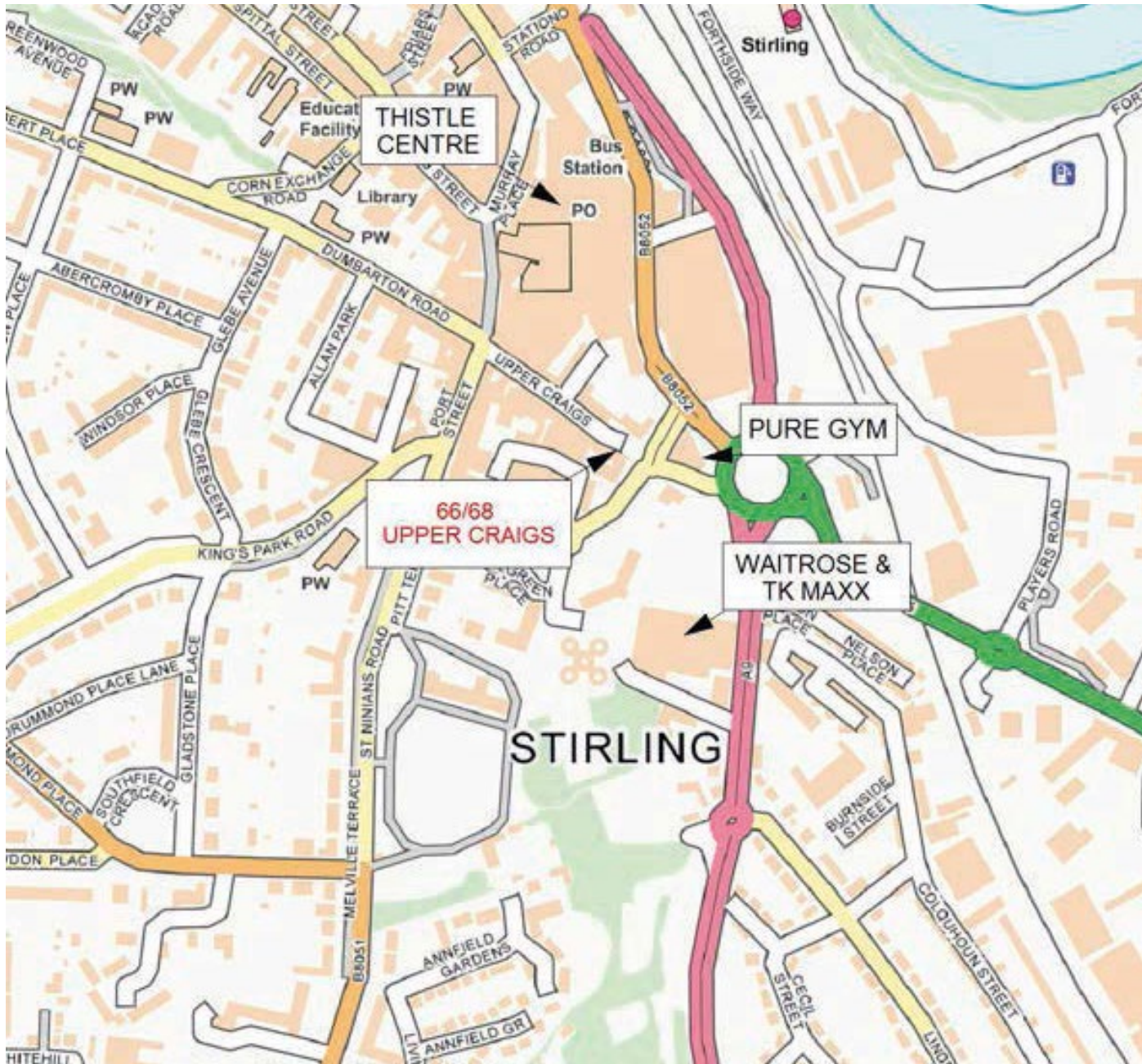
