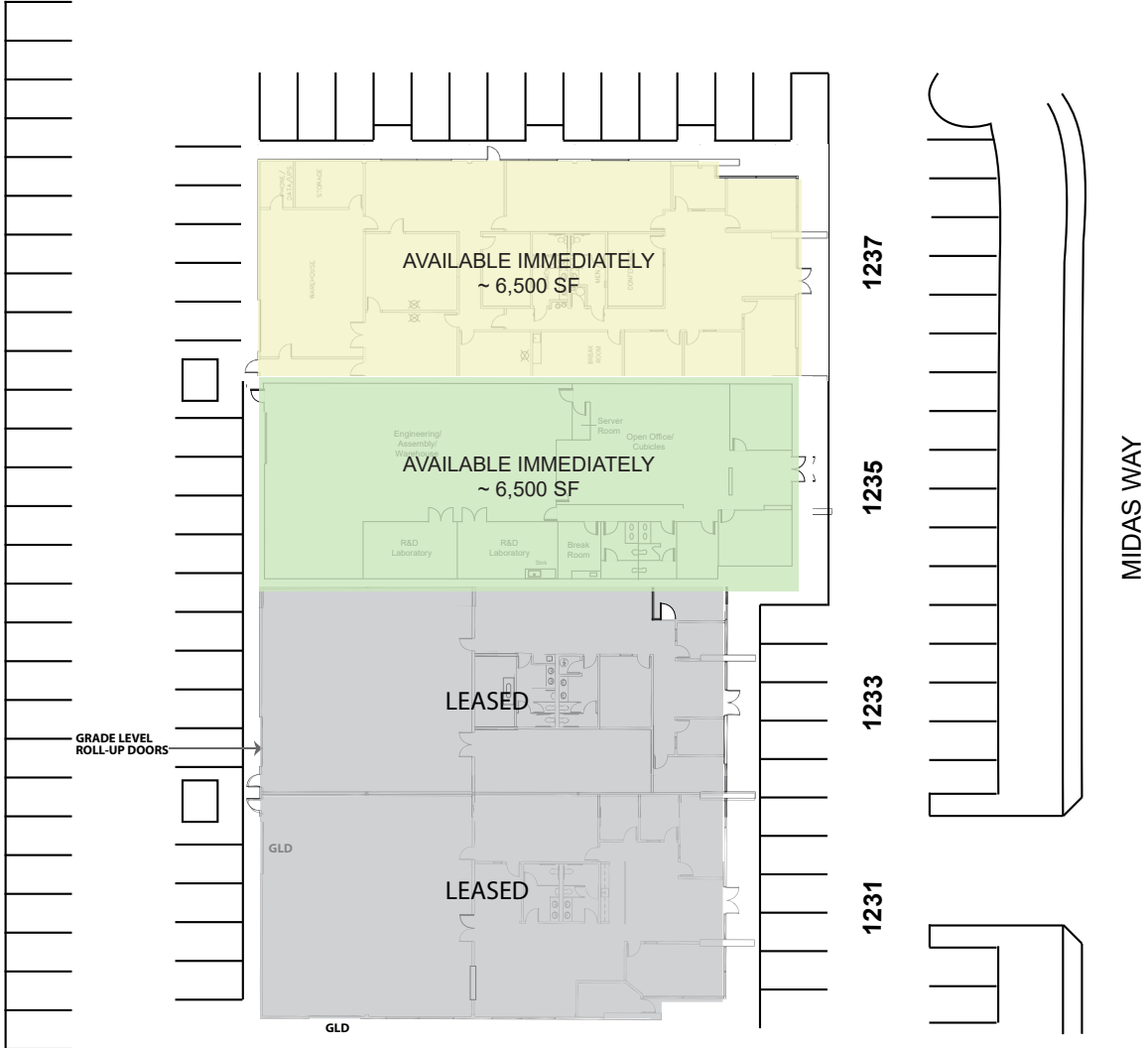

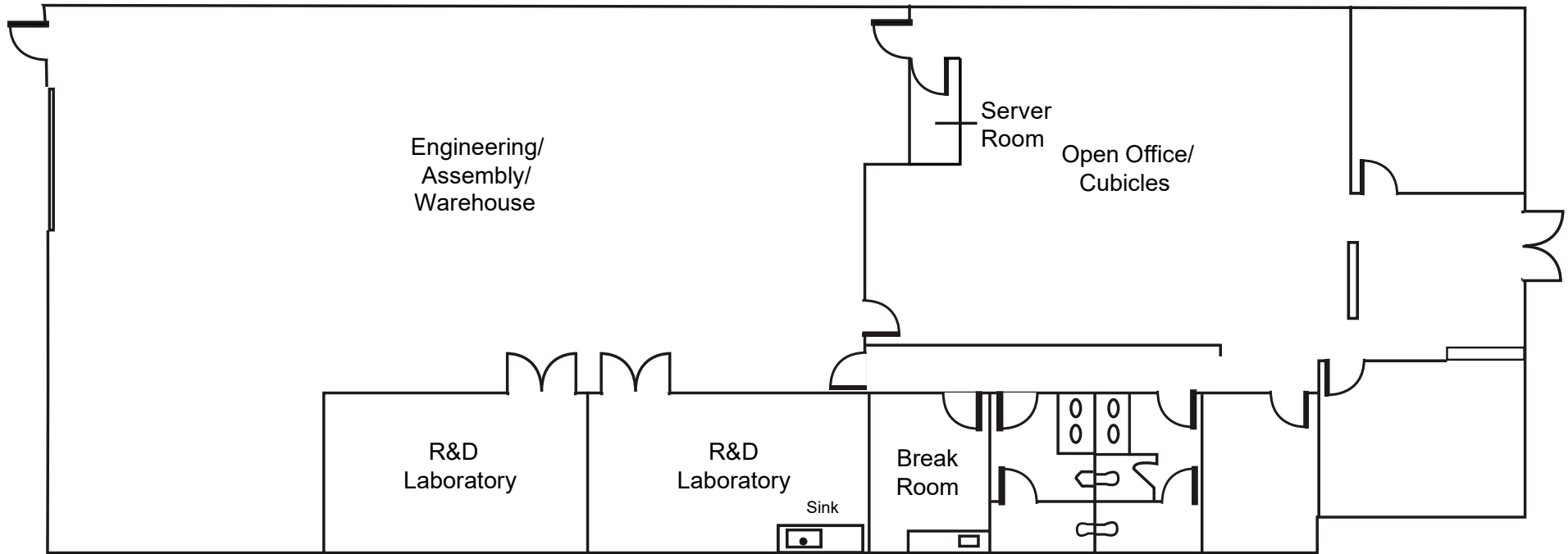


⊗ EXISTING DRAIN LOCATIONS

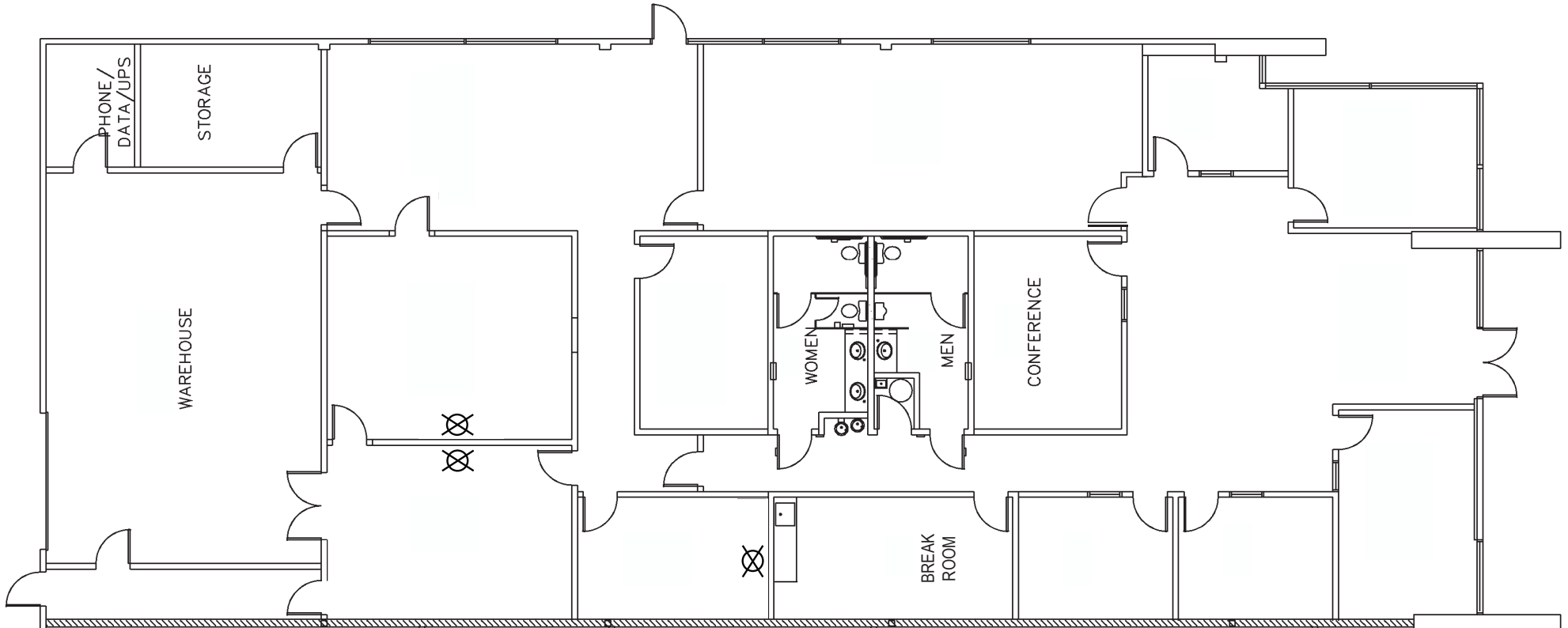
