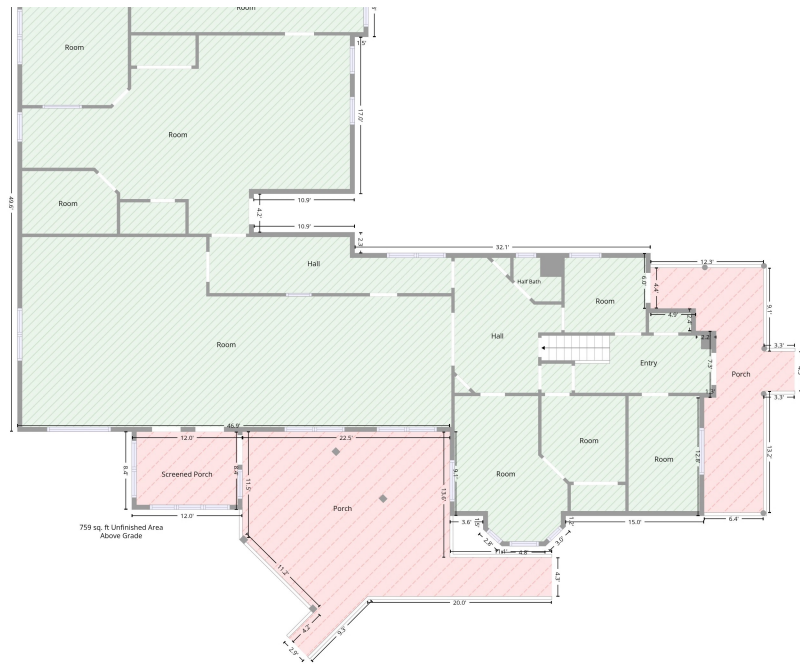
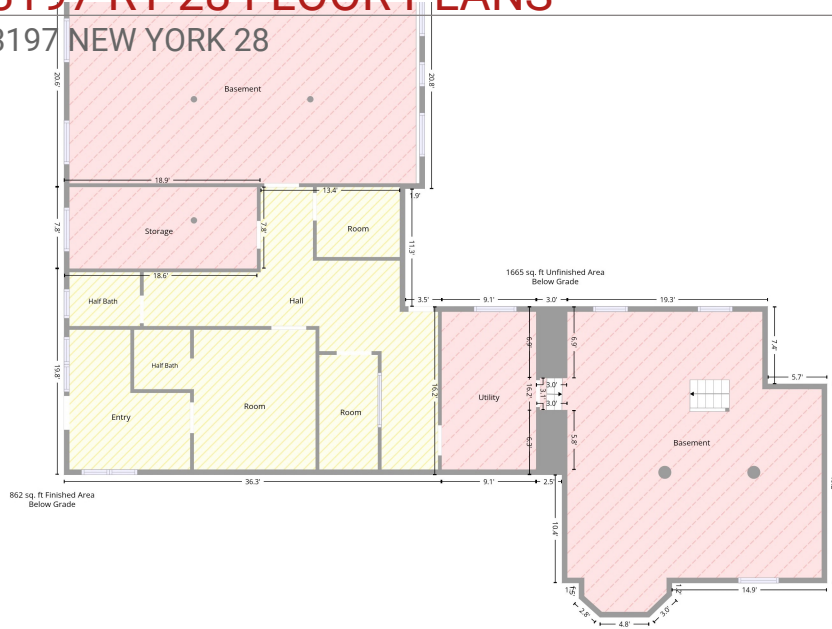

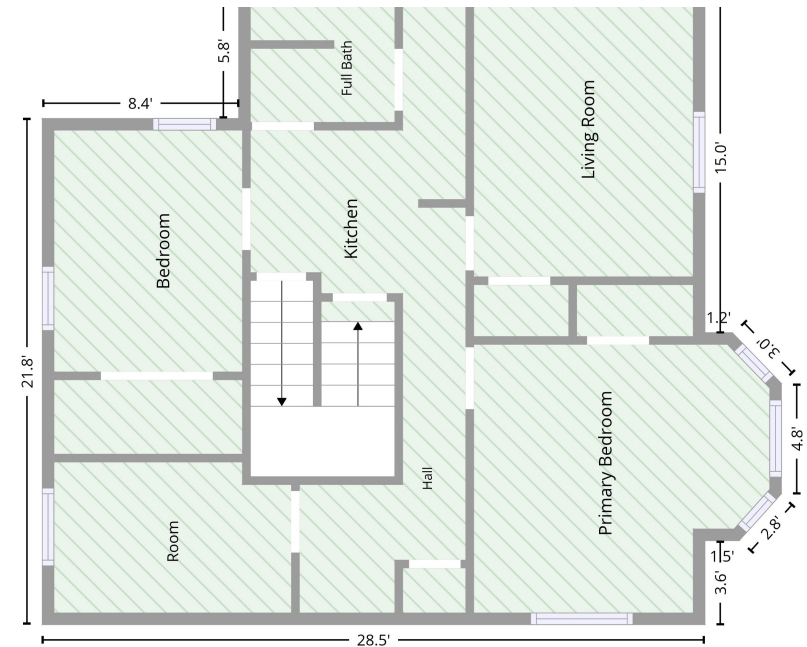
Its functional layout, generous parking, high visibility, and adaptable design make the property suitable for continued specialized use or repositioning to meet evolving market demands.
