PROPERTY OVERVIEW

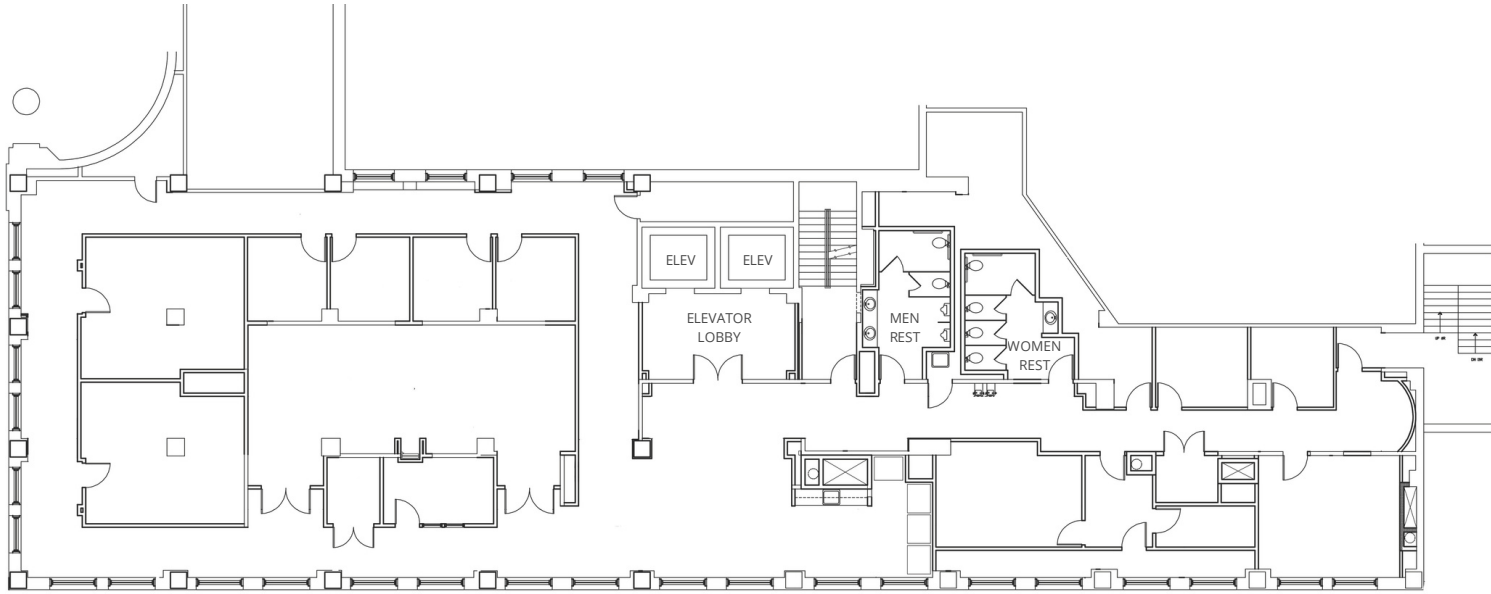

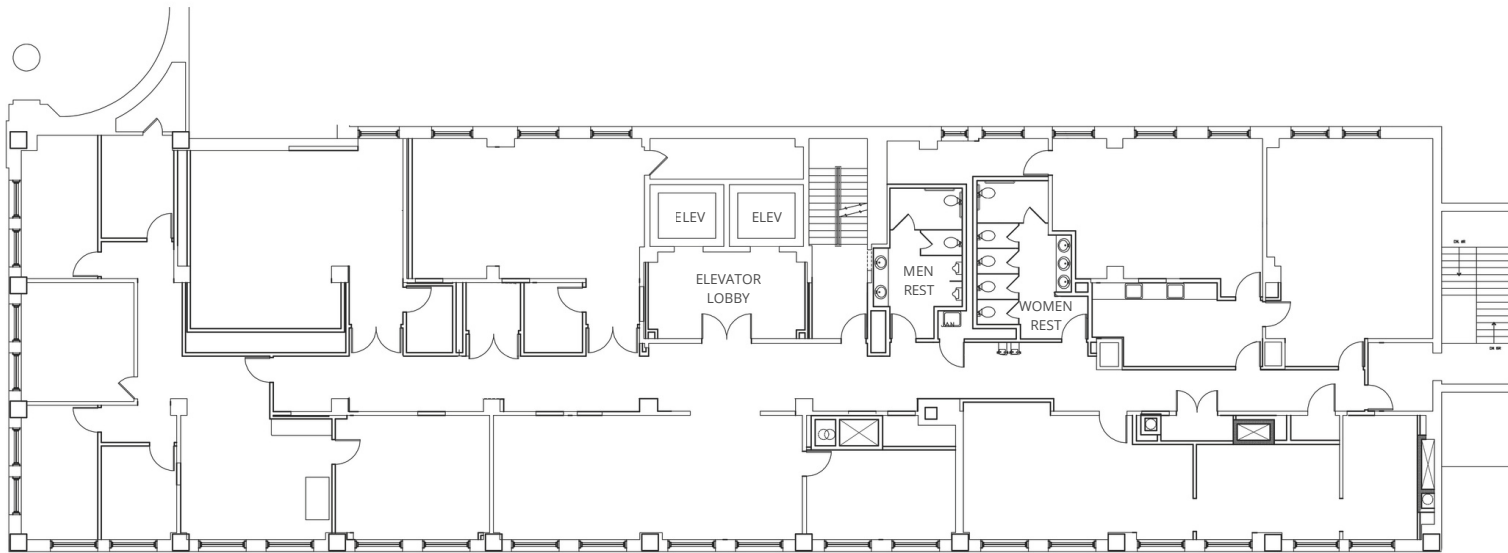

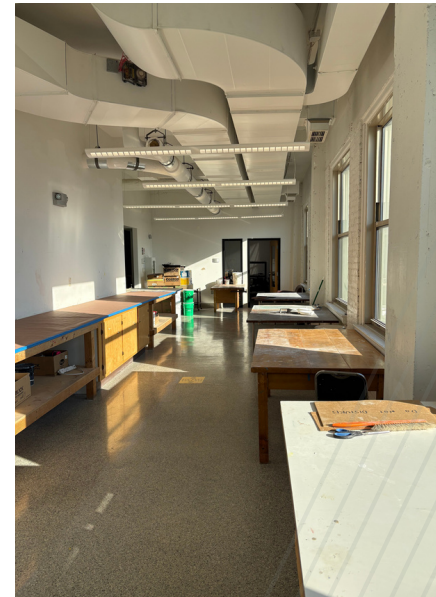
