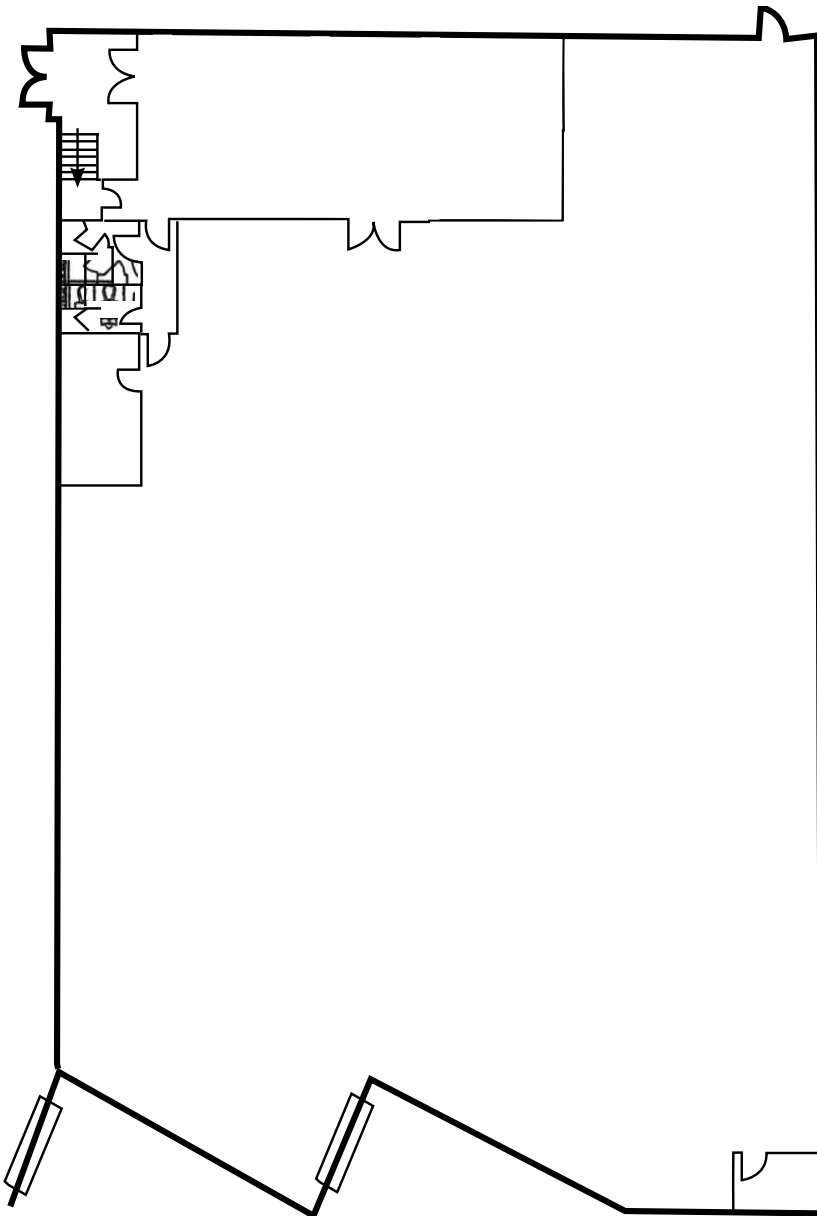


# Floor Plan
