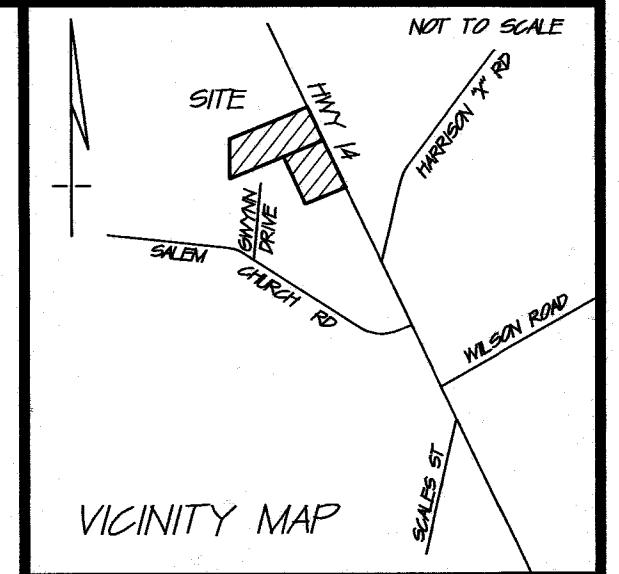


NOTES

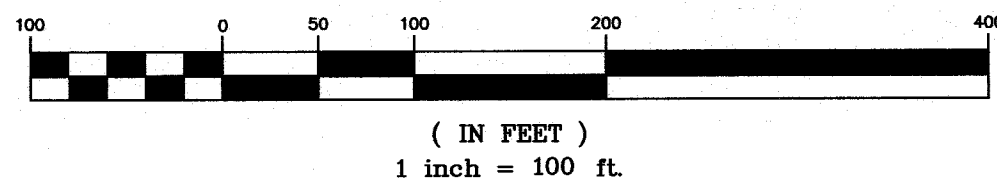

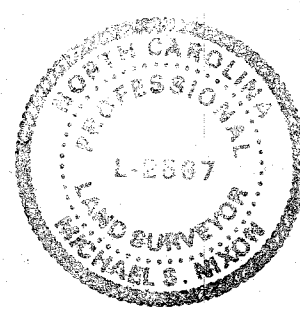
