## LOCATION

Falkirk is a large town in the Central Lowlands of Scotland, historically within the county of Stirlingshire. It lies in the Forth Valley, 23.3 miles north-west of Edinburgh and 20.5 miles northeast of Glasgow.

Falkirk has a resident population of 34,570 according to the 2008 census. The population of the town had risen over the past decade, making it the 20th most populous settlement in Scotland. Falkirk is the main town and administrative centre of the Falkirk council area, which has an overall population of 156,800 and inholds the nearby towns of Grangemouth, Bo'ness, Denny, Larbert and Stenhousemuir.

The subjects are located on the southern western side of Burnbank Road accessed directly from Main Street.

## DESCRIPTION

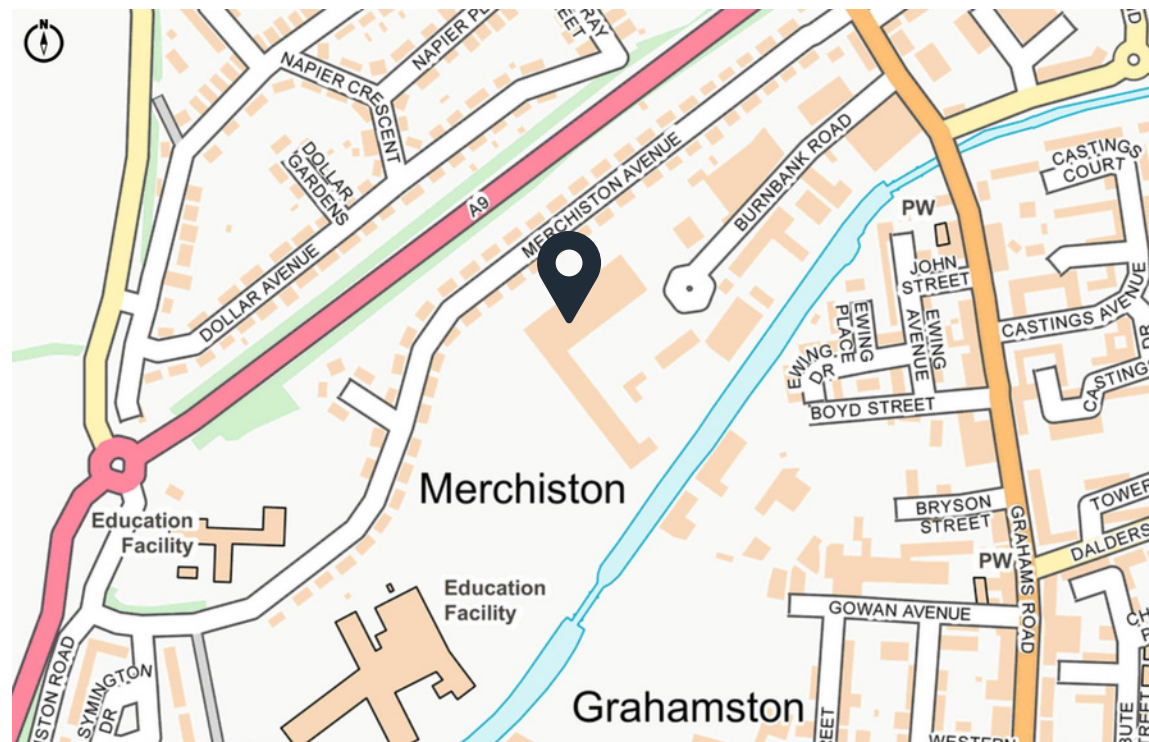
The subjects comprise a mid terraced industrial unit of steel portal frame construction with brick outer walls whilst being surmounted by a pitched roof overlaid in profiled sheet with interspersed translucent panels.

Internally the property provides a large open plan workshop accessed by a large roller shutter door with separate pedestrian access. To the rear of the unit there are w.c facilities.

The property benefits from having a minimum 5.3m eaves height and private parking.
