Crystal Peaks is a major regional shopping destination 7 miles south east of Sheffield City Centre with an annual footfall of approx. 13 million. The 635,000 sq ft centre is anchored by a 90,000 sq ft **Sainsbury's** and 56,000 sq ft **Marks & Spencer**, other key retailers include **Next**, **B&M**, **Deichmann** and **New Look**. The Centre also benefits by being adjacent to Crystal Peaks Retail Park and Drakehouse Retail Park.

A four-screen cinema is due to open adjoining **McDonalds**, opposite **Costa** and **Subway** in early 2026

The premises are located on the external elevation of East Mall and front onto a large free of charge surface car park and are capable of being traded outside normal centre hours.
