LOCATION

The city of Perth has a resident population of approximately 46,000 persons, with the population of the surrounding catchment area estimated to be in the region of 130,000. Perth is situated approximately 20 miles west of Dundee, 40 miles north of Edinburgh and 60 miles north east of Glasgow lying at the hub of Central Scotland's road network.

More precisely, the subjects occupy a prominent corner location on Charlotte Street, at its junction with Charlotte Place. The surrounding area is mixed commercial in its nature, home to a number of professional and financial services. The attractive North Inch is within easy walking distance.

The approximate location is shown by the OS plan.



DESCRIPTION

The subjects comprise a ground floor Class 1a unit contained within an attractive stone and slate building. The property benefits from a sizeable and prominent glazed display frontage directly onto Charlotte Street and its return with Charlotte Place.

Access to the property is directly off Charlotte Street. Internally accommodation is a mixture of open plan and cellular, including kitchen and WC's.

Accommodation is bright and modern suitable for a variety of commercial uses, subject to the required consents.
