LOCATION

Rainham is located in the Medway area of Kent with a local population of approximately 34,000. Rainham is situated 3.5 miles south east of Chatham and 7.5 miles north east of Maidstone. The town is well connected, being located just off the A2 and within easy reach of the M2 motorway, it provides good transport links to London, the Channel ports and the wider area. Rainham railway station offers regular services to London Victoria, St Pancras International and Dover.

The subject property is located within Rainham Shopping Centre, adjacent to **The Pet Shop** and **Marie Curie** and opposite **Boots Pharmacy**. The scheme is anchored by **Tesco** and **B&M** with other occupiers of note such as **Greggs** and **Boots Opticians**.

There is an adjoining 193 space public car park to the rear of the scheme.
