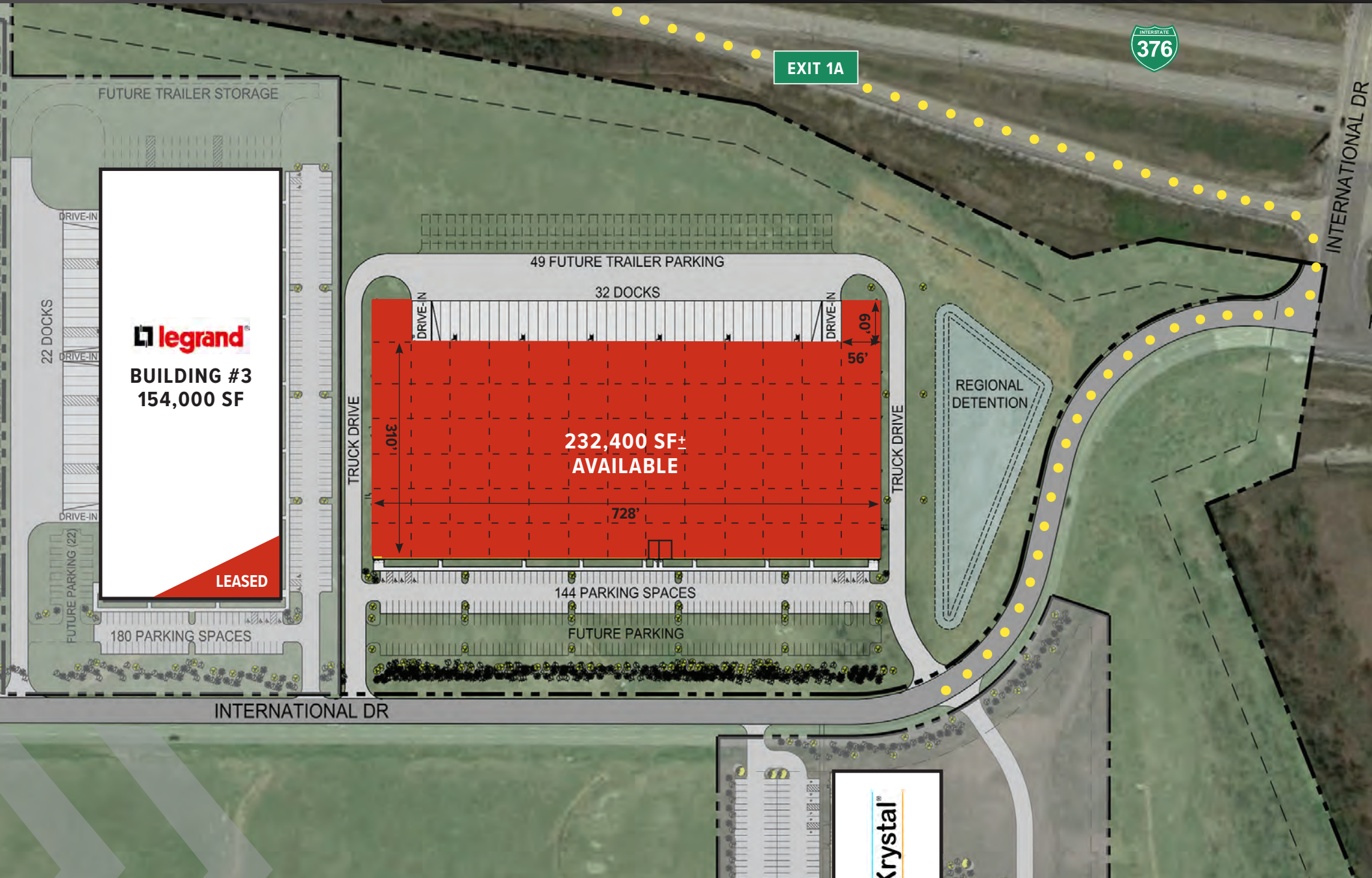

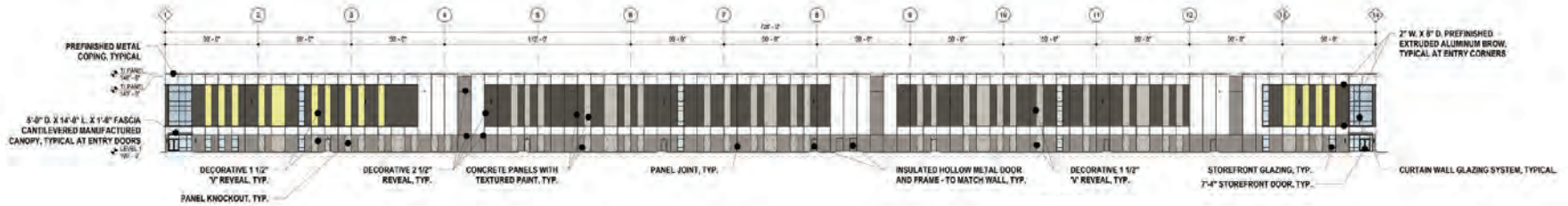

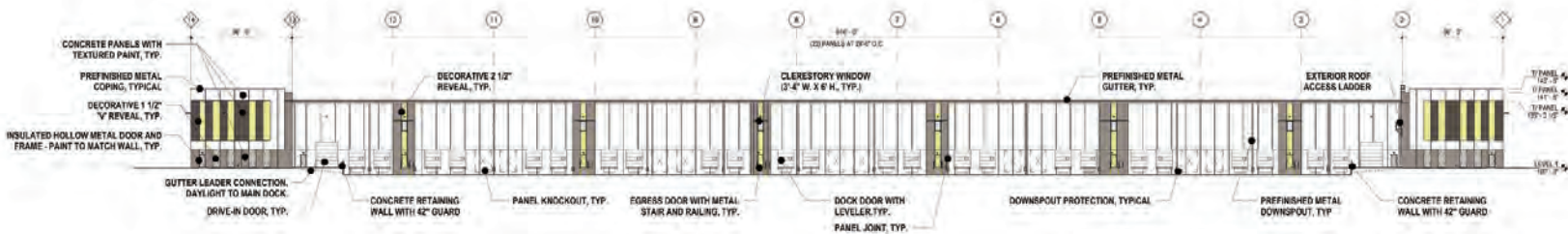
EAST ELEVATION
