PROPERTY SUMMARY

This is the opportunity to acquire the 7-Eleven at 11421 State Hwy 64 in Tyler, Texas — a single-tenant convenience and fuel asset located in Tyler, the seat of Smith County. The property comprises a 2,520-square-foot building on 0.646 acres (Smith CAD parcel R041389), with State Highway 64 frontage.

The property is secured by an absolute NNN lease with zero landlord responsibilities, corporately guaranteed by 7-Eleven — an investment-grade rated national convenience and fuel retailer. The lease runs through June 30, 2035, with 7.5% rent increases every five years and three five-year renewal options, providing investors with a durable, passive income stream backed by a leading national credit in income tax-free Texas.

LOCATION DESCRIPTION

TYLER, TX

The Tyler MSA is a vital East Texas economic corridor, generating over a \$15 billion GDP from a population of approximately 249,000. Its formidable industrial and healthcare base includes regional leaders UT Health East Texas and CHRISTUS Trinity Mother Frances Health System, alongside massive manufacturing operations for Trane Technologies and Tyler Pipe. The region's economic power is amplified by its medical sector, which commands a \$1.2 billion annual economic impact and directly supports 25,000 full-time jobs.

Strategically located roughly 95 miles east of Dallas, the MSA leverages its proximity to Interstate 20 for direct regional market access. This highway connectivity is enhanced by a local logistics network featuring U.S. Highway 69, Toll 49, and the Tyler Pounds Regional Airport. For investors, this infrastructure provides access to a broad consumer base, as Tyler acts as the premier retail and commercial hub for a sprawling seven-county trade area, ensuring resilient supply chains and high-volume traffic potential.

Investment appeal is bolstered by a growing consumer base, with median household income rising to \$67,486 in 2024. The market is stabilized by institutional anchors like Tyler Junior College, with nearly 12,000 enrolled students, and the University of Texas at Tyler, serving over 11,000 students, alongside the city's major medical centers providing essential, non-cyclical employment. With recent MSA GDP growth consistently outpacing the national average, the region's powerful economy and strategic infrastructure offer a compelling case for long-term retail investment growth and stability.

MAJOR EMPLOYERS

The employment landscape surrounding the 7-Eleven at 11421 State Hwy 64, Tyler, TX is anchored by a broad mix of sectors, demonstrating notable economic diversity and resilience. Key employers include CHRISTUS Mother Frances Hospital and UT Health East Texas—regional healthcare systems employing thousands—alongside higher education through The University of Texas at Tyler and Tyler Junior College, all of which drive stable institutional employment. Brookshire Grocery Company's headquarters and Target's distribution center anchor the region's grocery and logistics base, while manufacturers such as Trane Technologies and John Soules Foods support industrial daytime population. Proximity to major corridors including US-69, Loop 323, and State Highway 64 enhances workforce mobility across the six-store trade area. Collectively, these institutions and corporations underpin traffic durability for convenience retail through the remaining lease term (expiration 6/30/2035).

Information About Brokerage Services

Texas law requires all real estate license holders to give the following information about brokerage services to prospective buyers, tenants, sellers and landlords.

TYPES OF REAL ESTATE LICENSE HOLDERS:

- A **BROKER** is responsible for all brokerage activities, including acts performed by sales agents sponsored by the broker.
- A **SALES AGENT** must be sponsored by a broker and works with clients on behalf of the broker.

A BROKER'S MINIMUM DUTIES REQUIRED BY LAW (A client is the person or party that the broker represents):

- Put the interests of the client above all others, including the broker's own interests;
- Inform the client of any material information about the property or transaction received by the broker;
- Answer the client's questions and present any offer to or counter-offer from the client; and
- Treat all parties to a real estate transaction honestly and fairly.

A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:

AS AGENT FOR OWNER (SELLER/LANDLORD): The broker becomes the property owner's agent through an agreement with the owner, usually in a written listing to sell or property management agreement. An owner's agent must perform the broker's minimum duties above and must inform the owner of any material information about the property or transaction known by the agent, including information disclosed to the agent or subagent by the buyer or buyer's agent.

AS AGENT FOR BUYER/TENANT: The broker becomes the buyer/tenant's agent by agreeing to represent the buyer, usually through a written representation agreement. A buyer's agent must perform the broker's minimum duties above and must inform the buyer of any material information about the property or transaction known by the agent, including information disclosed to the agent by the seller or seller's agent.

AS AGENT FOR BOTH - INTERMEDIARY: To act as an intermediary between the parties the broker must first obtain the written agreement of *each party* to the transaction. The written agreement must state who will pay the broker and, in conspicuous bold or underlined print, set forth the broker's obligations as an intermediary. A broker who acts as an intermediary:

- Must treat all parties to the transaction impartially and fairly;
- May, with the parties' written consent, appoint a different license holder associated with the broker to each party (owner and buyer) to communicate with, provide opinions and advice to, and carry out the instructions of each party to the transaction.
- Must not, unless specifically authorized in writing to do so by the party, disclose:
 - o that the owner will accept a price less than the written asking price;
 - o that the buyer/tenant will pay a price greater than the price submitted in a written offer; and
 - o any confidential information or any other information that a party specifically instructs the broker in writing not to disclose, unless required to do so by law.

AS SUBAGENT: A license holder acts as a subagent when aiding a buyer in a transaction without an agreement to represent the buyer. A subagent can assist the buyer but does not represent the buyer and must place the interests of the owner first.

TO AVOID DISPUTES, ALL AGREEMENTS BETWEEN YOU AND A BROKER SHOULD BE IN WRITING AND CLEARLY ESTABLISH:

- The broker's duties and responsibilities to you, and your obligations under the representation agreement.
- Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated.
