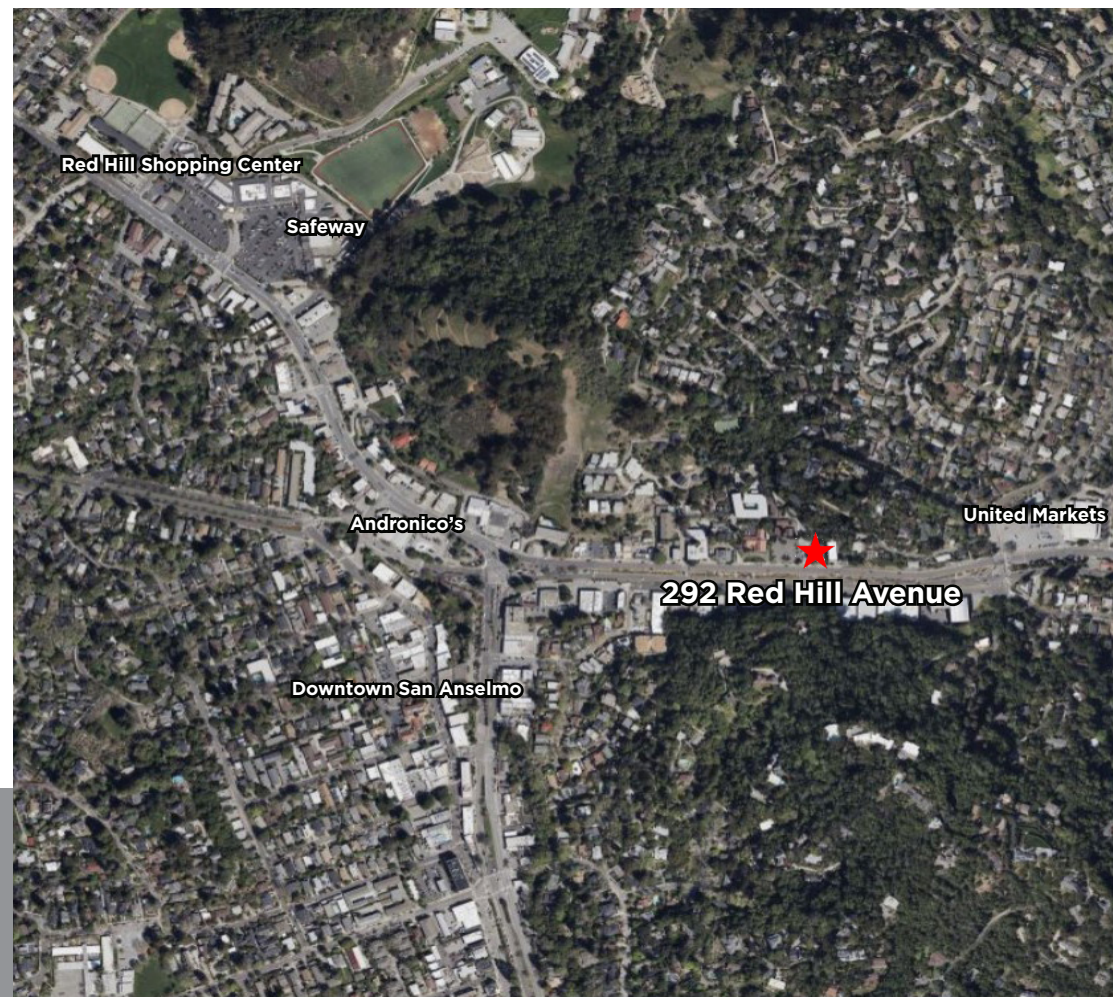
292 Red Hill Avenue is conveniently located approximately one block east of the The Hub intersection in a highly visible location and is a short walk to Downtown San Anselmo.

FLOOR PLAN

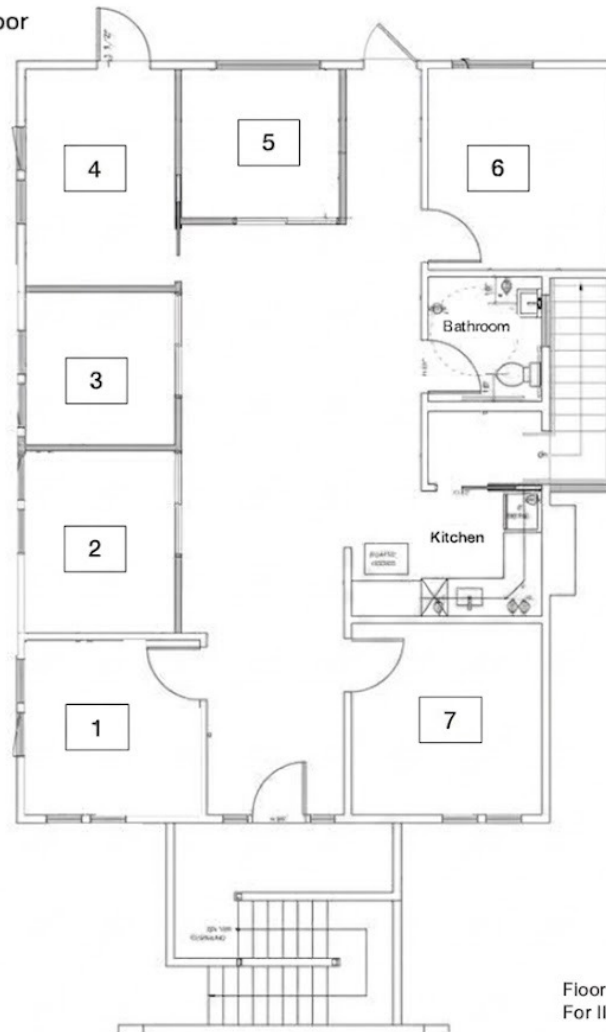
