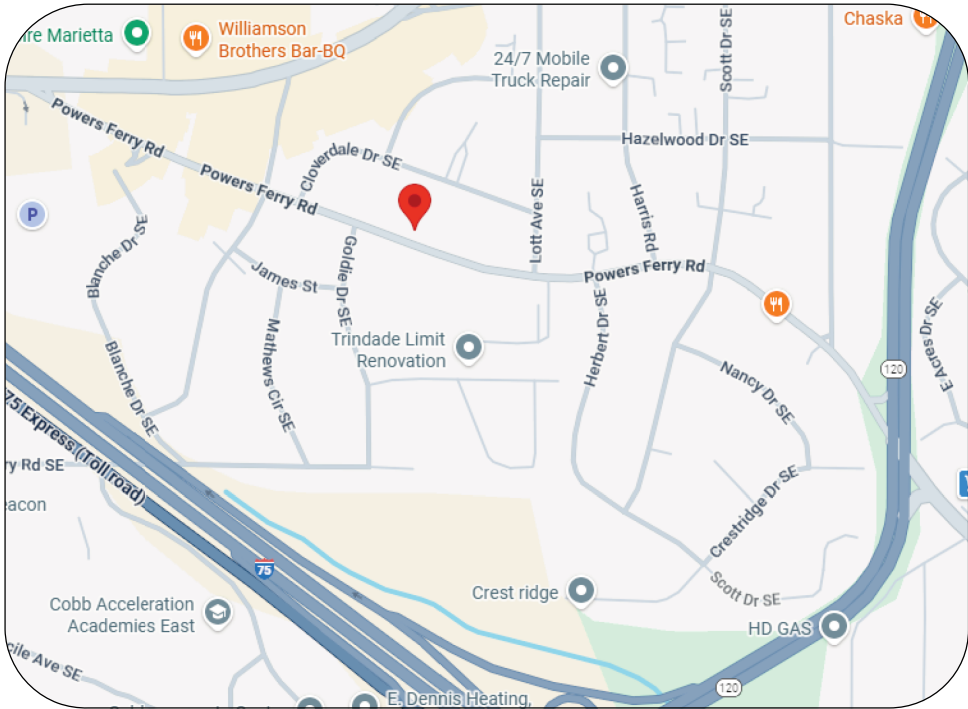
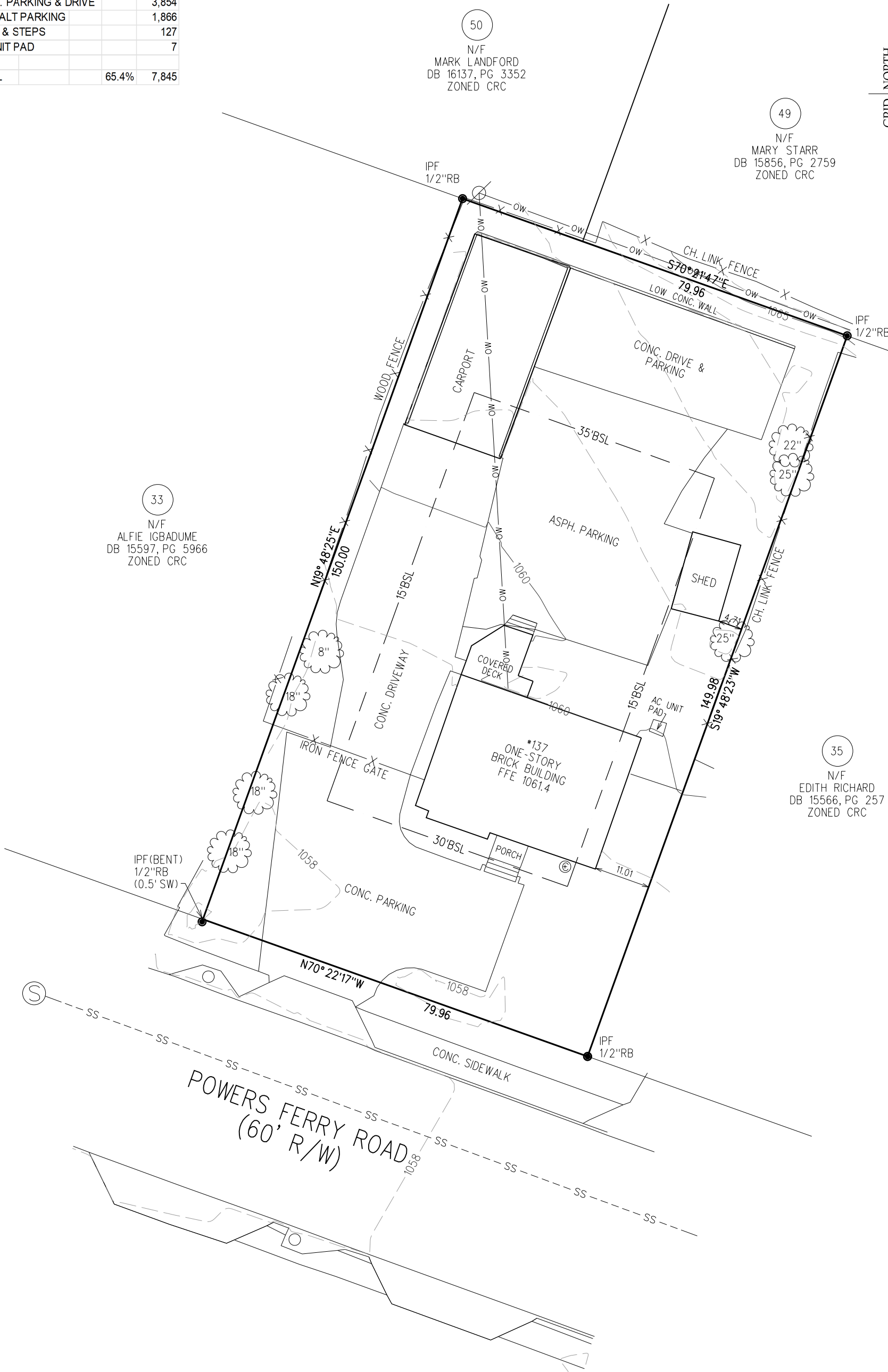

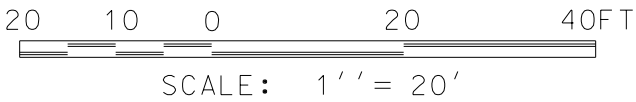


VICINITY MAP

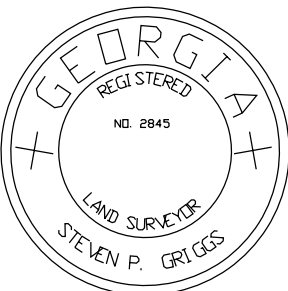
