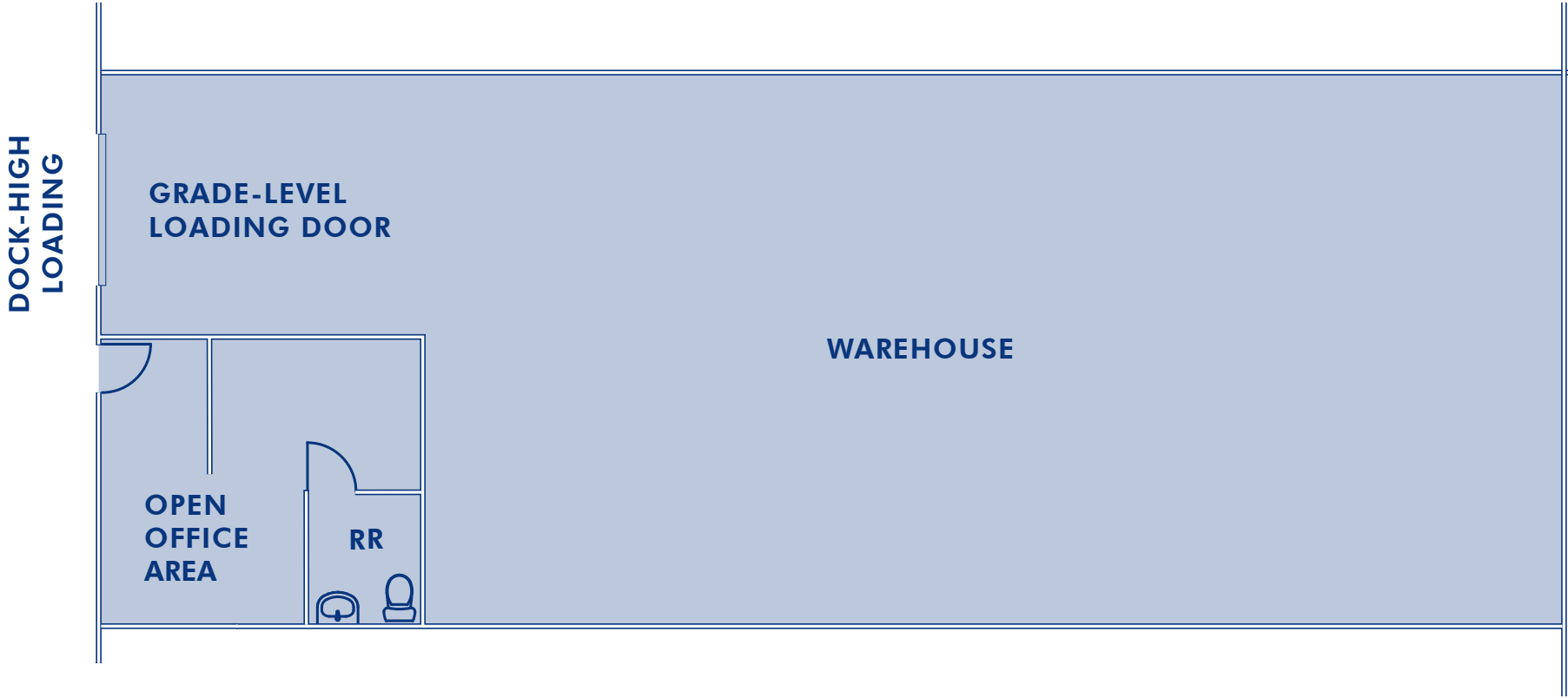

FLOORPLAN

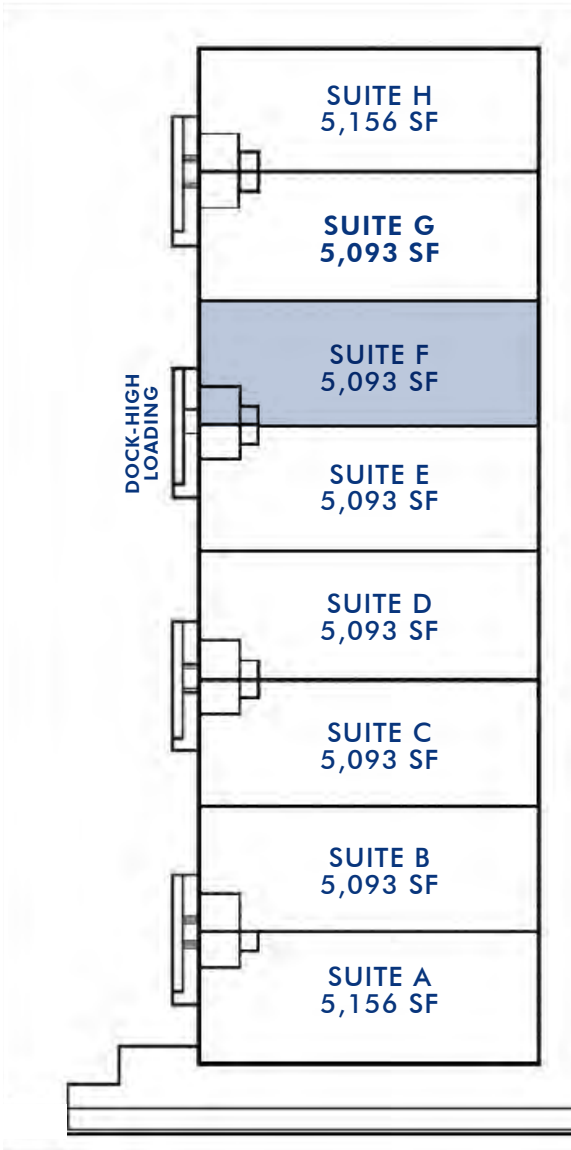
