Description

Unit 82 is a mid-terraced industrial unit set in a landscaped setting, within Gravelly Industrial Estate. The estate covers 32.4 hectares (80 acres) and comprises 78 high-quality production/warehouse units totalling approximately 1,100,000 sq. ft, ranging in size from 2,000 sq. ft up to 285,000 sq. ft. The estate benefits from 24-hour manned security with CCTV and a car registration plate reading system.

Location

Gravelly Industrial Park is strategically located close to Junction 6 M6 (Spaghetti Junction) and the Aston Expressway. Junction 6 provides access to the M6 and the national motorway network, and the Aston Expressway provides quick access to Birmingham and the Ring Road. The estate is accessed via the A38 Tyburn Road or the A47 Heartlands Parkway.

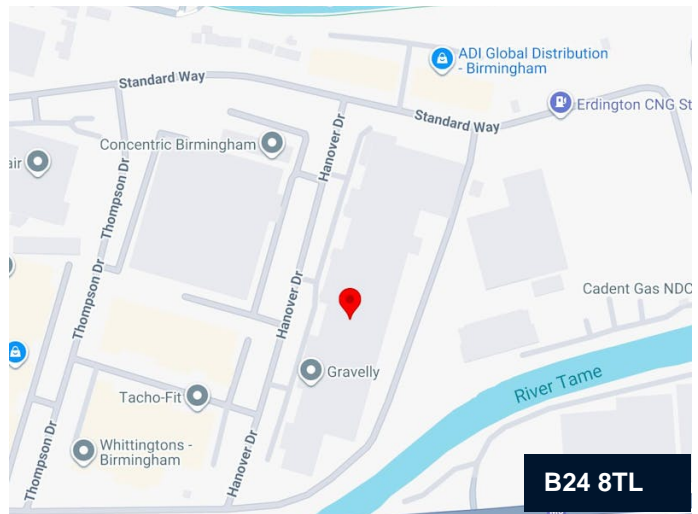
