### CONSTRUCTION DETAIL:

<b>Construction Type:</b>	Exterior painted tilt-up concrete panels
<b>Floor:</b>	7" thick, 4,000 PSI concrete slab on grade with two coats sealer. Floor load designed to average 500 lbs/SF
<b>Roof:</b>	Fully adhered 45 mil EPDM roof with 22 gauge steel decking and R-20 rigid insulation

### BUILDING SYSTEMS:

<b>Fire Protection:</b>	ESFR compliant with NFPA-13 standards.
<b>Electric System:</b>	4,000 amp, 277/480 volt, 3-phase service
<b>Lighting System:</b>	LED energy efficient lights to provide 30 foot candles at 36" above finished floor.
<b>Heating System:</b>	Gas fired space heaters, minimum 8 BTU/SF for freeze protection.
<b>Dock Equipment:</b>	40,000 lb, mechanical pit levelers with "Z" guard door track protection, bumpers and seals
<b>Water:</b>	2" domestic supply
<b>Sewer:</b>	6" gravity flow waste lines under slab
