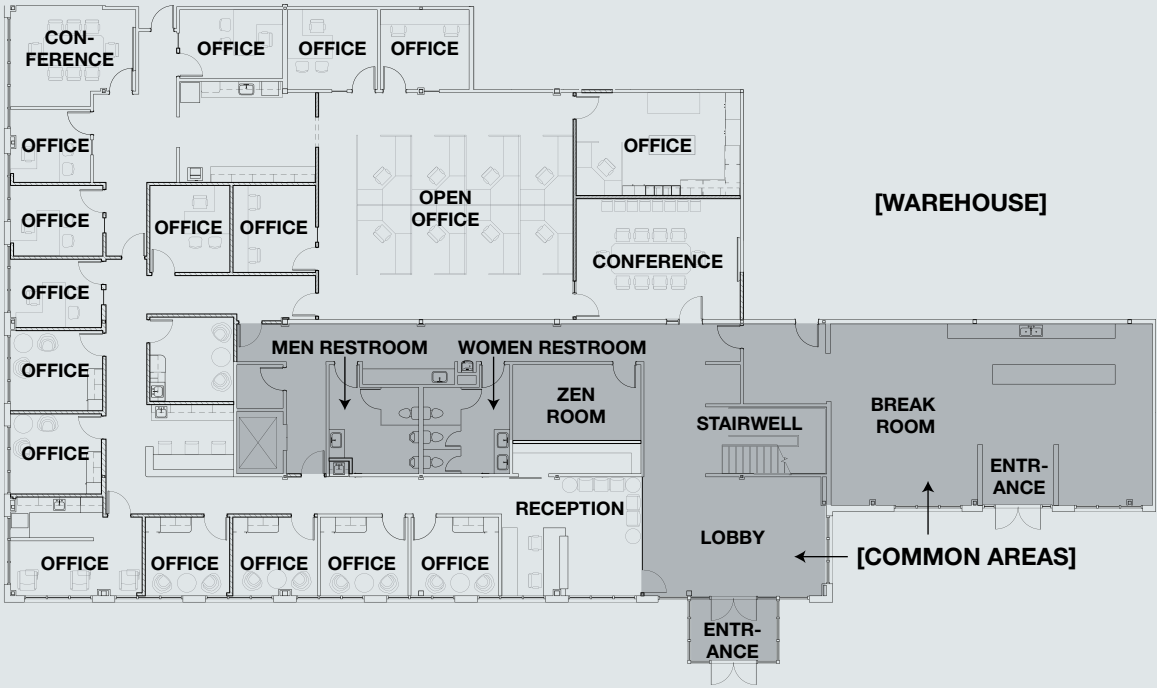

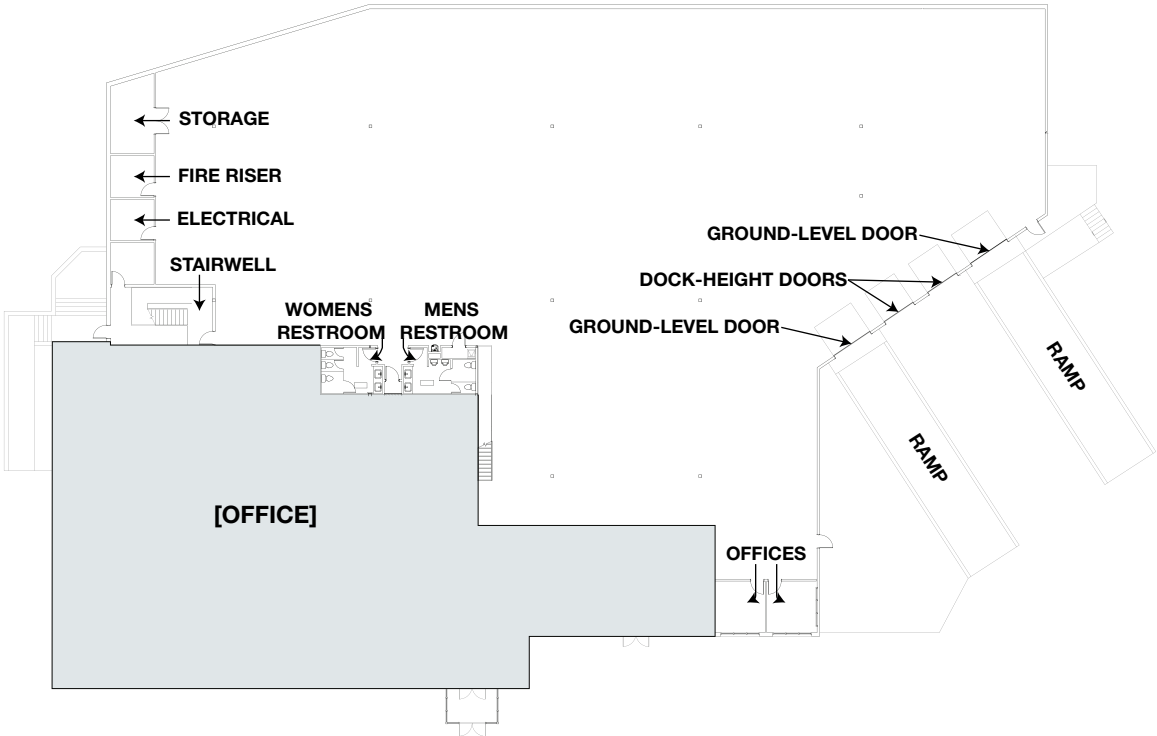

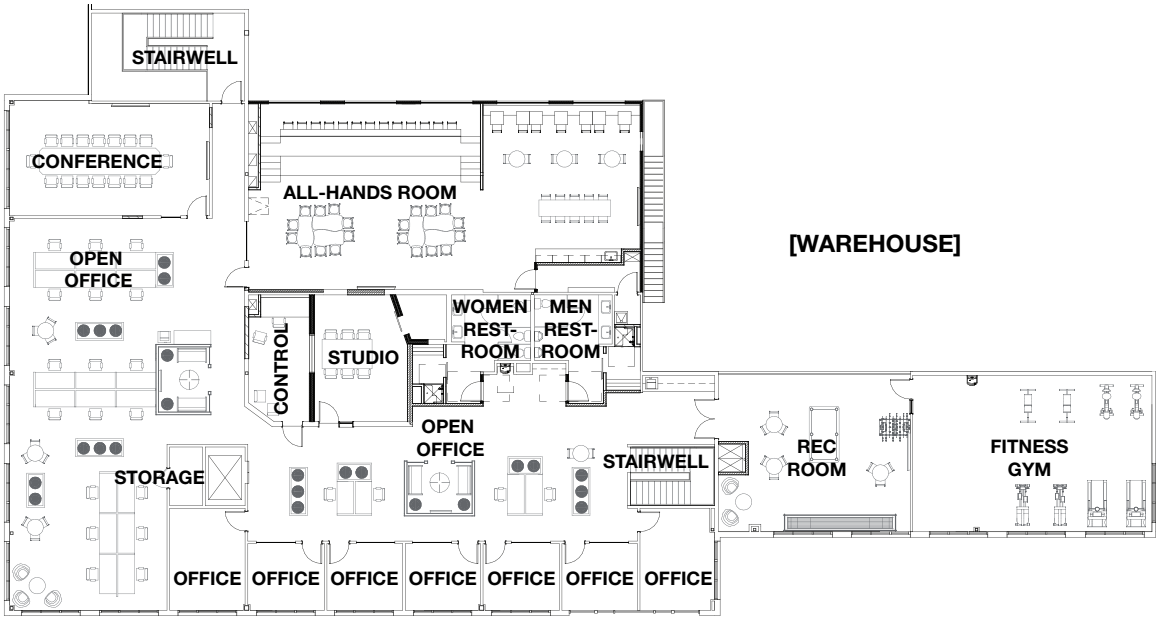
FIRST FLOOR
