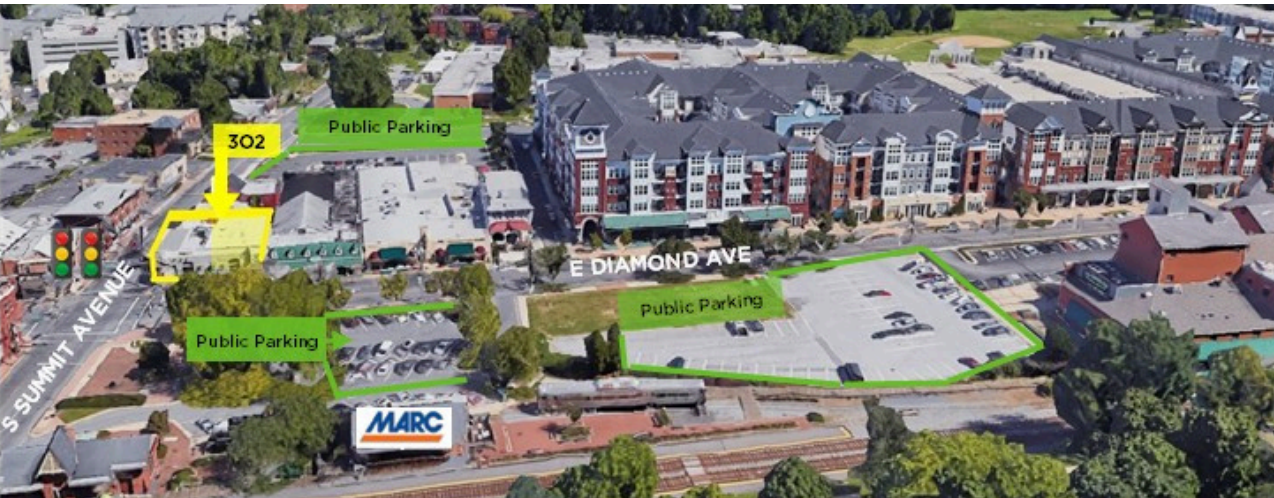

Approximately one block from 302 E. Diamond

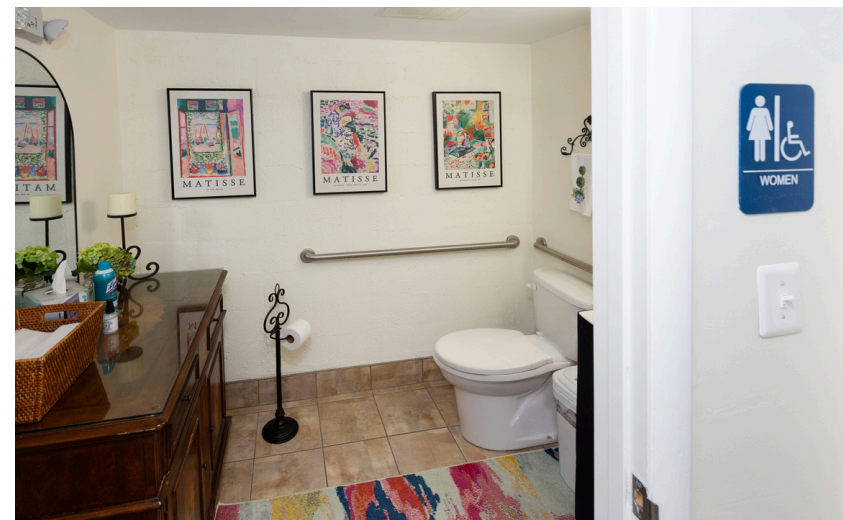

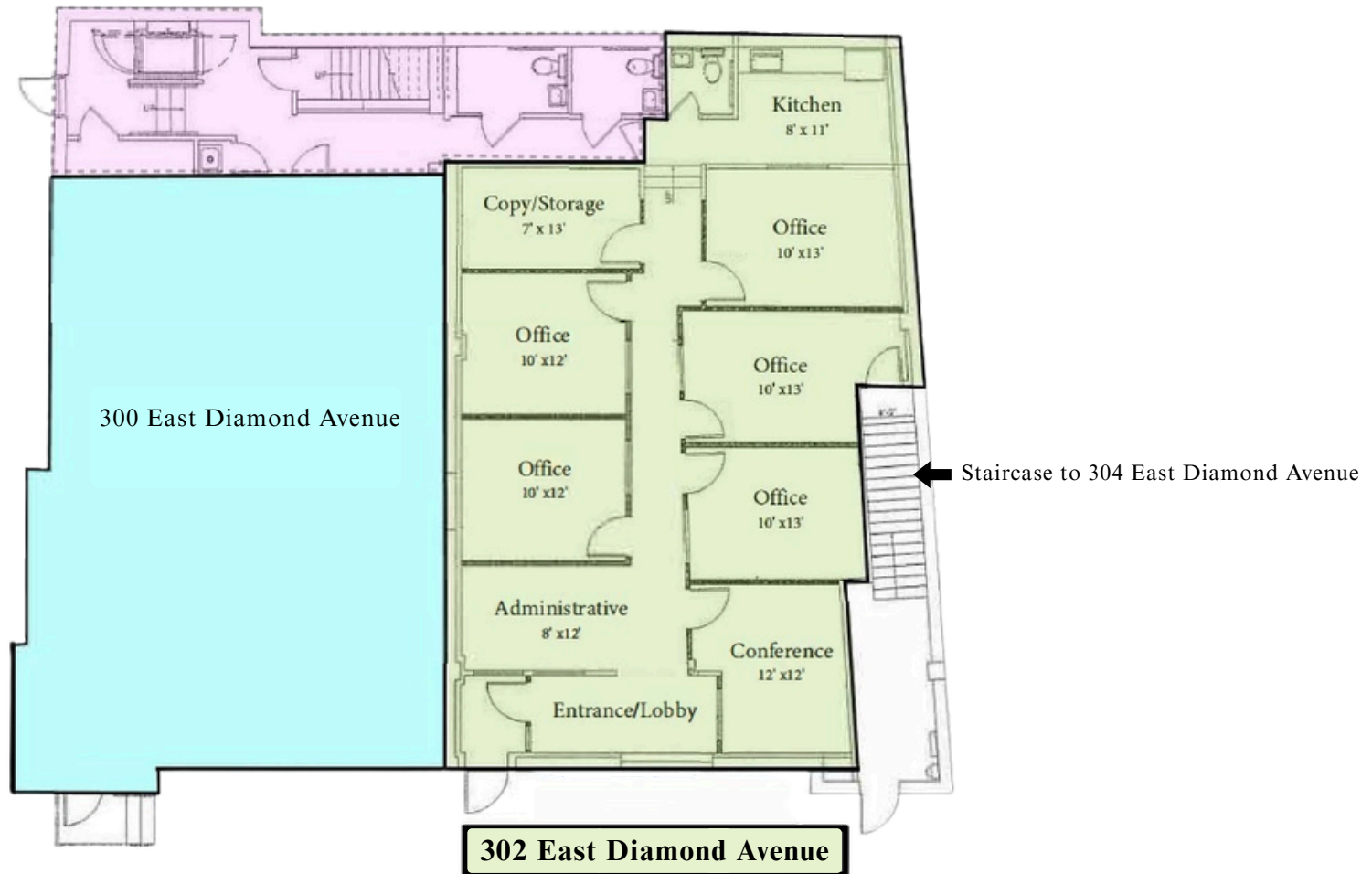
