## Description

The unit will be handed over in shell/core condition and is ready for tenant fit out. A new frontage is due to be installed in November 2023.

## Location

Situated within the new Eastwick and Sweetwater (EWS) development which bridges Hackney Wick and the Queen Elizabeth Olympic Park. The complex comprises a mix of 18 commercial space totalling just under 30,000 square feet of space, alongside a growing residential community too, currently over 1,800 homes have been constructed in addition to schools, nurseries and community hubs.

Directly opposite the unit is the Copper Box Arena, home to London Lions basketball team and the third largest arena in London. Just over the canal is Hackney Wick Station which provides excellent transport links to Stratford and beyond. The area is transformed at weekends with regular markets, artist exhibitions and events, Hackney Wick is an exciting district which is constantly evolving.
