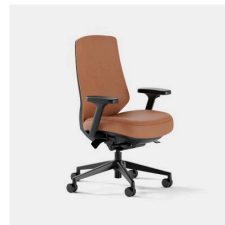

Terms and Conditions for Enterprise Clients

1. Quote: An Enterprise Client may receive a cost outline for the Services from a Branch sales representative (a "Quote"). Quotes/Invoices are valid for 30 days after which product pricing is subject to change.

2. Floorplans: Should there be a predetermined furniture layout ("Floor Plan") for the Client's office space (the "Premises"), all furniture will be assembled and placed in the Premises according to the Floor Plan. Branch is not liable for delivery problems arising from inaccuracies in the Floor Plan. When a discrepancy arises between the Floor Plan and Quote, the Quote will be the source of truth.

3. Payments: Branch must receive payment in full for orders with a total value of less than \$15,000 prior to processing the order. For orders with a total value of greater than \$15,000 a minimum 50% deposit payment is required prior to order processing. A payment shall be deemed to have been received only once the funds are reflected in Branch's bank account. Furthermore, the remaining balance must be paid a minimum of 5 business days prior to delivery. All credit card payments are subject to a 2.9% processing fee. In the case of a Purchase Order, payment terms associated with such Purchase Order shall supersede any standard Branch payment terms. All payment terms must be agreed to in writing prior to processing order.

4. Insurance. Enterprise Clients will ensure that they hold adequate insurance to facilitate furniture delivery & installation in the Premises, as required by building management.

5. Delivery Options. Branch offers Enterprise Clients two delivery options.

a) White Glove Delivery: Services include delivery and installation of products in Client's premises. Standard 15% installation fee applies. Additional fees may apply where union labor, after hours delivery, or movement of furniture up or through stairwells is required. In no case will Branch or its third party partners connect electrical or plumbing services.

b) Standard Delivery: Client agrees to accept receipt of Products via parcel or LTL shipment. Clients who choose Standard Delivery are responsible for assembly of furniture and disposal of packaging. For items delivered by freight or LTL shipment, a delivery team will unload shipment from the truck to a ground-level area outside your office or home (loading dock, building entrance, etc.). Clients will be responsible for transporting item(s), including any shipping pallets, into their Premises.

6. White Glove Installation: Enterprise quotes provided by a Branch representative will include White Glove installation fees, except where Standard Delivery is requested by Client. An additional installation fee may be charged for changes made to an order after it has been placed.

7. Condition of Job Site: Client is responsible for ensuring that the premises is in a condition to receive furniture. Branch may refuse to deliver furniture to Premises that are undergoing construction, with areas that aren't clear, or deemed to be unsafe. Additional fees may be charged when the foregoing has occurred, or for changes made to an order after it has been placed. All additional charges associated with redelivery & furniture storage will be the sole responsibility of the Client.

8. Delivery Information: Client will provide Branch with the correct delivery address, information on building delivery hours, any requirements for union labor in their Premises, elevator booking requirements, and Certificate of Insurance requirements. Failure to provide accurate information on these subjects may result in installation delays, changes in delivery service, or additional fees.

9. Damages Upon Delivery: Client is responsible for inspecting delivery and making note of any missing, incorrect, or damaged items. All damages must be reported to the installation team or to a Branch representative at enterprise@branchfurniture.com within 24 hours of delivery to the client's office, warehouse, freight forwarder, or any other delivery location. Branch will respond with remedy action in a reasonable & timely manner.

10. Returns: Enterprise Clients may return Branch furniture products for a refund within 30 days of purchase. Custom products, shipping fees, and installation fees are non-refundable. Products must be in like-new condition to be accepted for return. The cost of return shipping and a 20% restocking fee will be deducted from the refunded amount. Products shipped outside the contiguous United States or Canadian provinces, be it by Branch or client's freight forwarder are final sale. Certain exceptions to this policy may be found on the Return Policy page of the Website.
