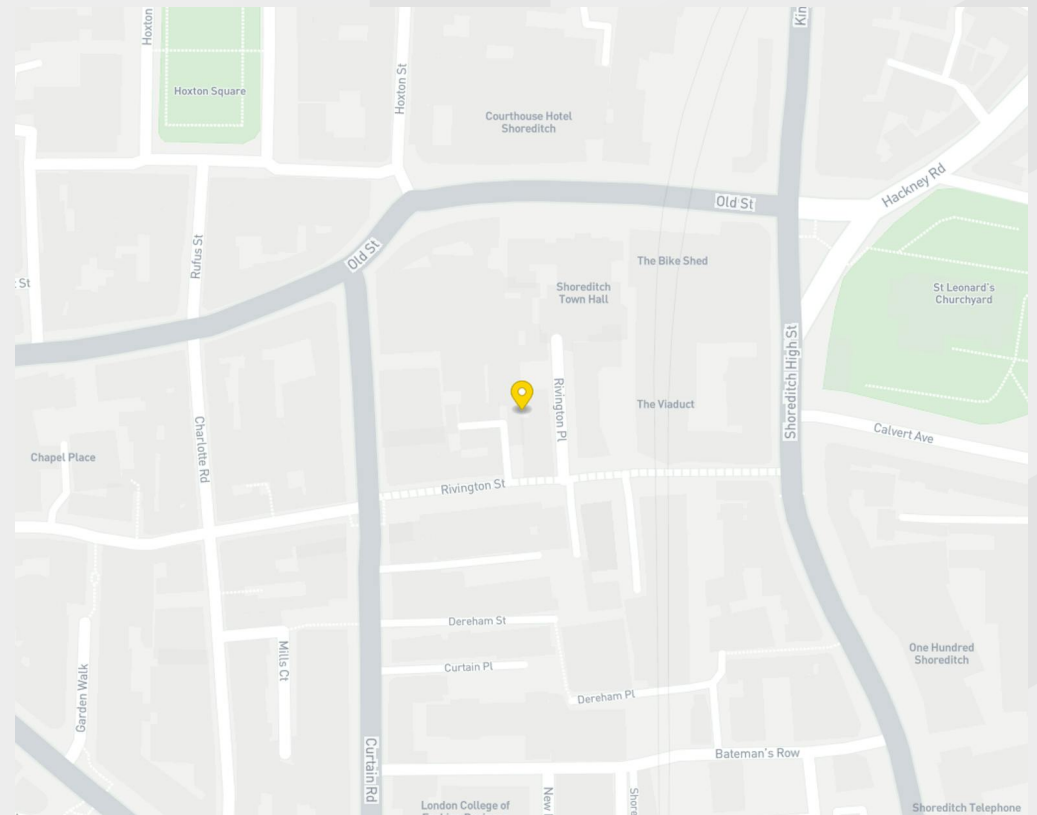


Description
