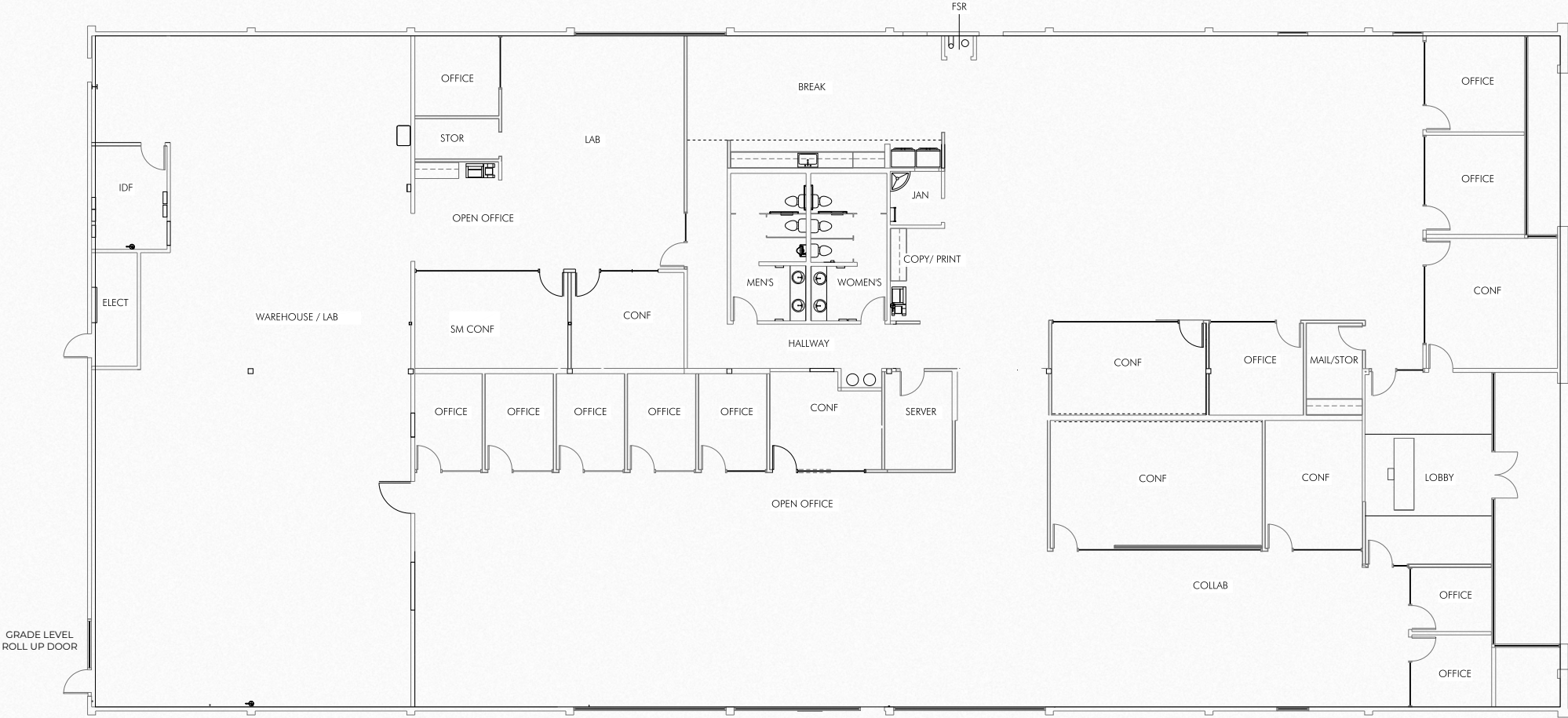

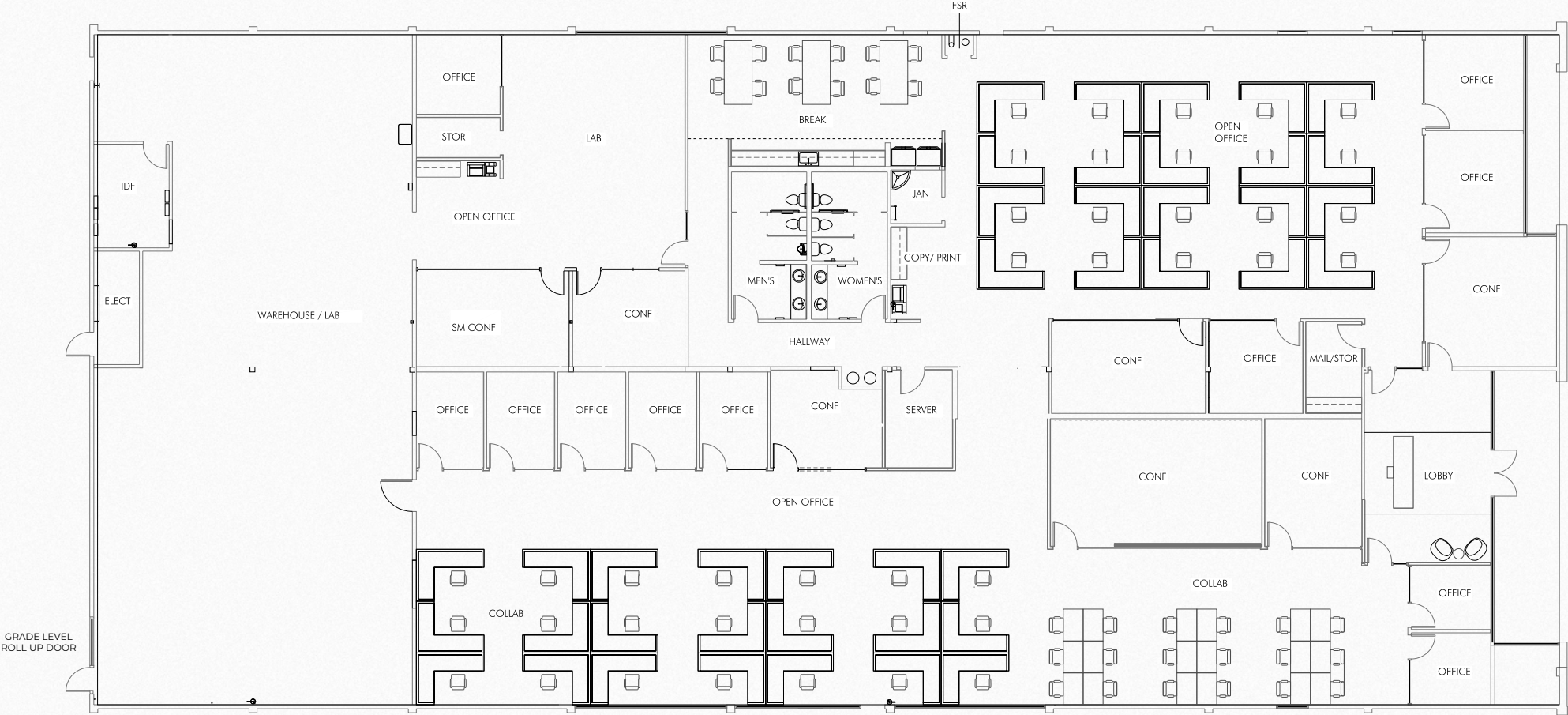

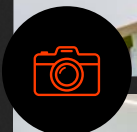
HYPOTHETICAL FURNISHED PLAN

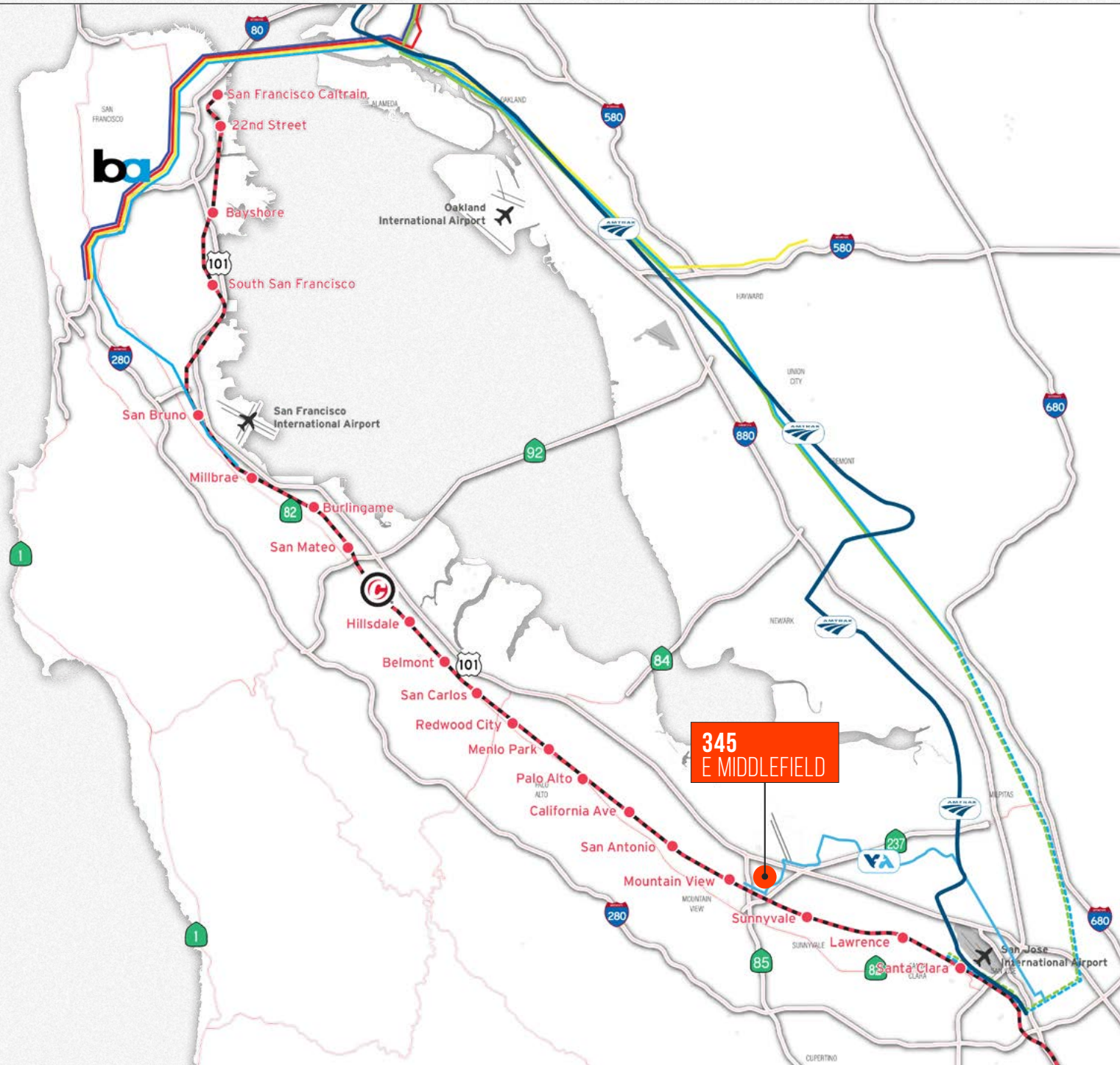

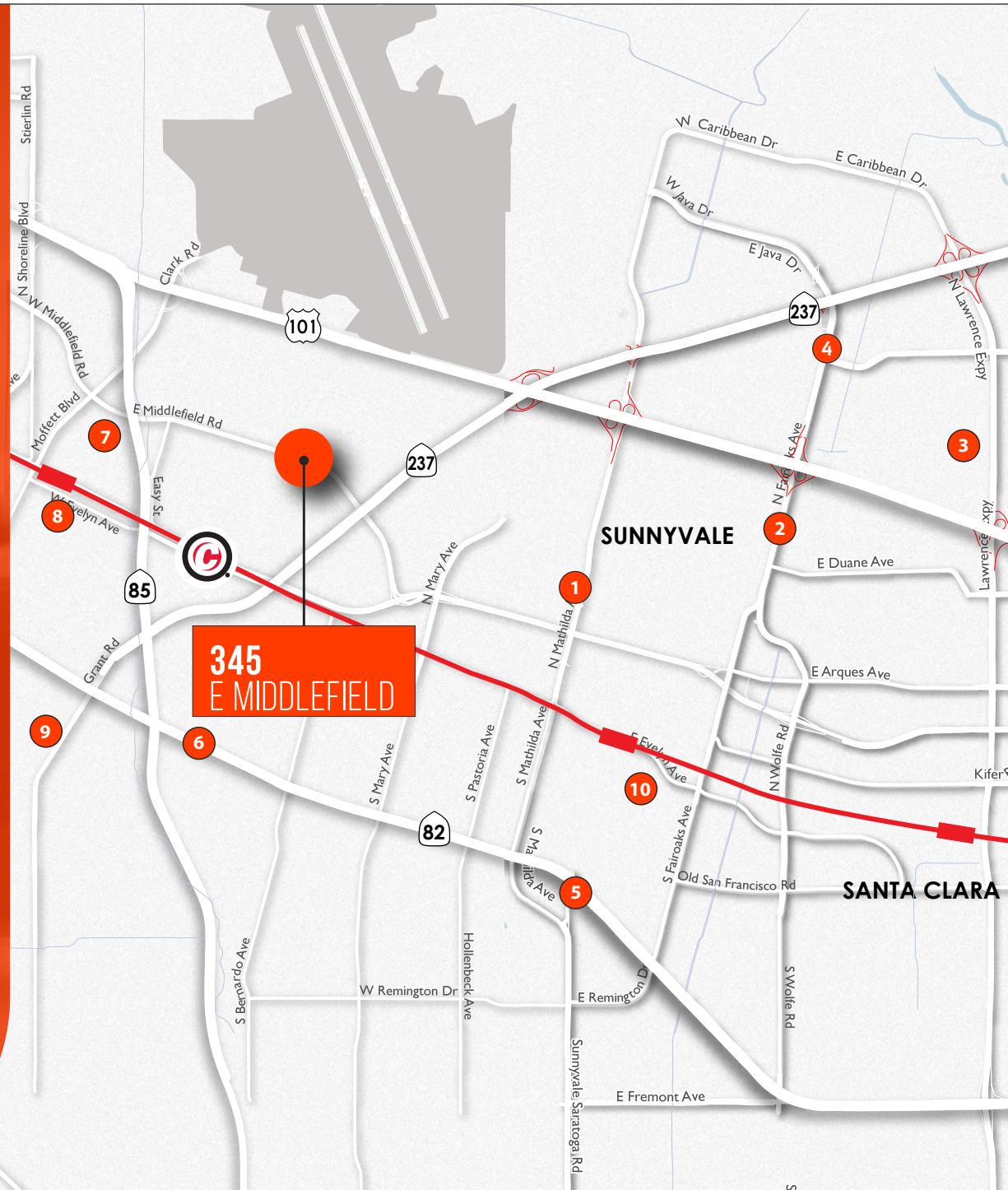
