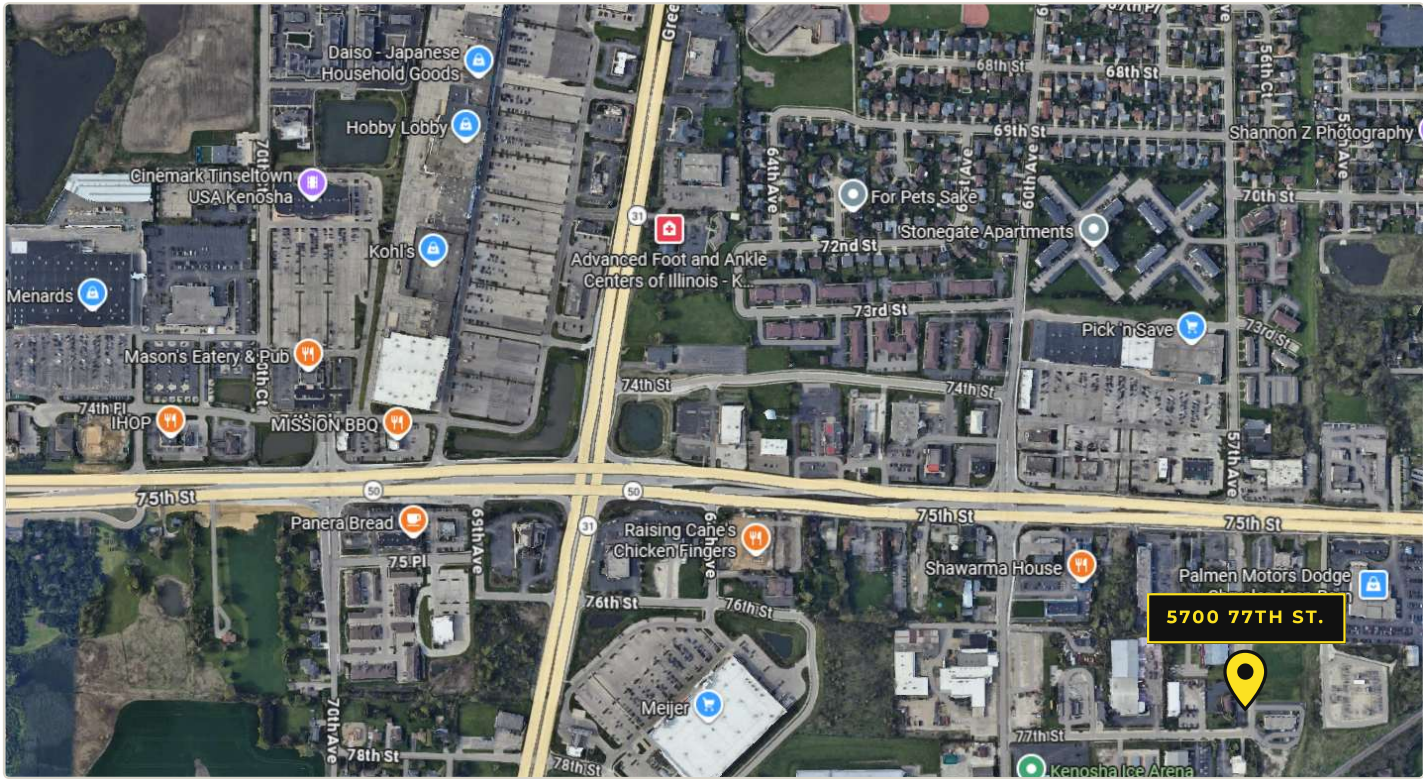

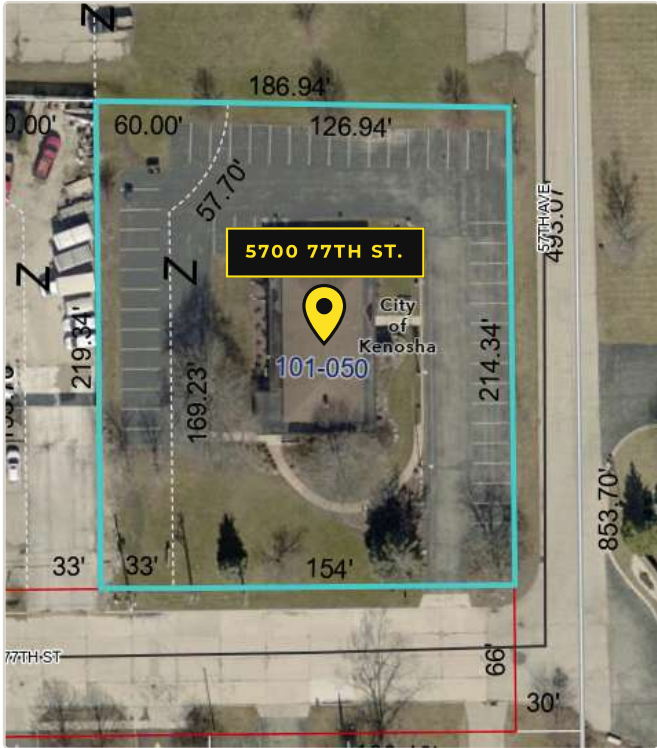

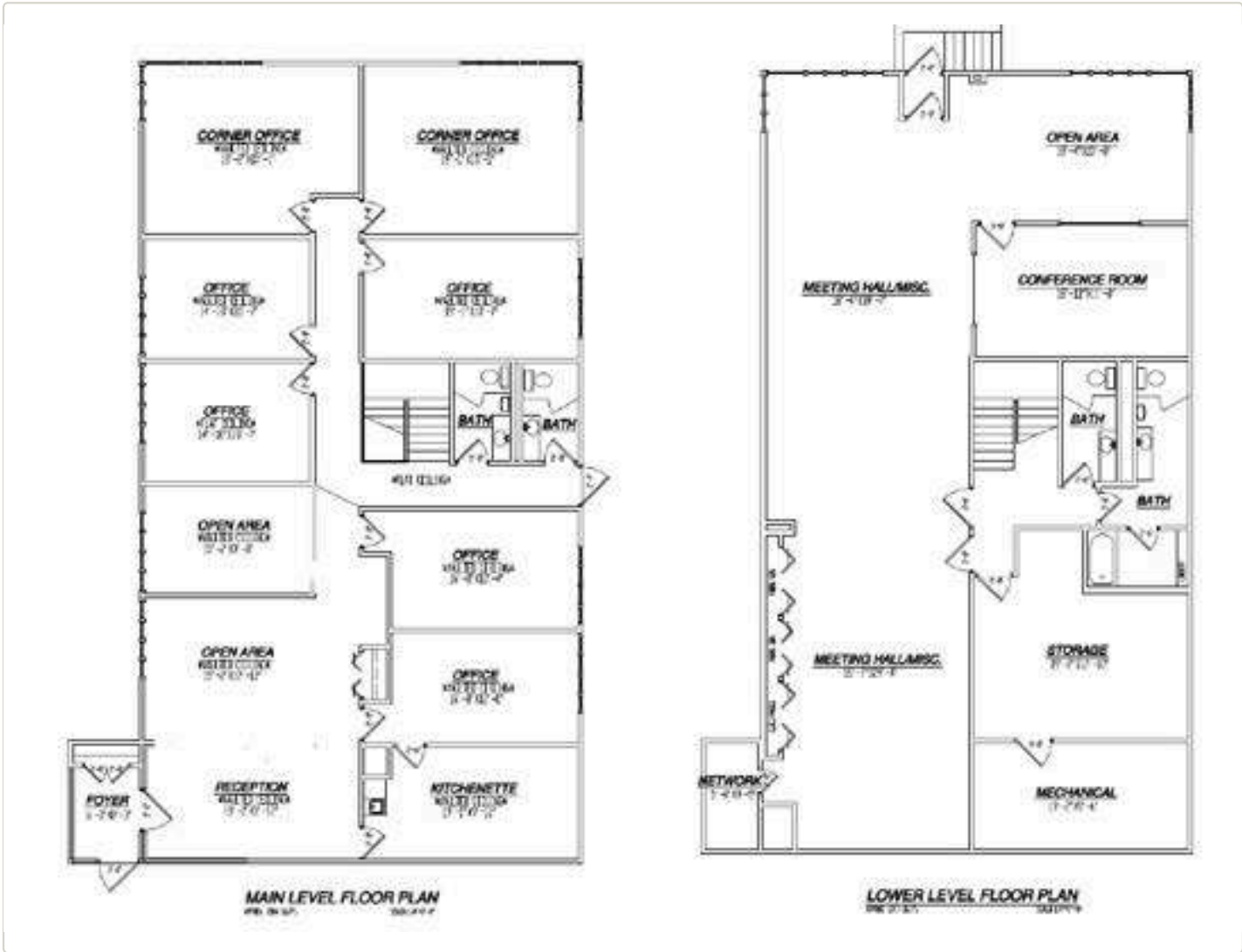

## DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

The duty to provide brokerage services to you fairly and honestly. The duty to exercise reasonable skill and care in providing brokerage services to you. The duty to provide you with accurate information about market conditions within a reasonable time if you request it, unless disclosure of the information is prohibited by law. The duty to disclose to you in writing certain material adverse facts about a property, unless disclosure of the information is prohibited by law. The duty to protect your confidentiality — unless the law requires it, the broker will not disclose your confidential information to other parties. The duty to safeguard trust funds and other property the broker holds. The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

Please review this information carefully. A broker or salesperson can answer your questions about brokerage services, but if you need legal advice, tax advice, or a professional home inspection, contact an attorney, tax advisor, or home inspector. This disclosure is required by section 452.135 of the Wisconsin Statutes and is for information only. It is a plain-language summary of a broker's duties to a customer under section 452.133(1) of the Wisconsin Statutes.

### CONFIDENTIALITY NOTICE TO CUSTOMERS

Broker will keep confidential any information given to the broker in confidence, or any information obtained by the broker that he or she knows a reasonable person would want to be kept confidential, unless the information must be disclosed by law or you authorize the broker to disclose particular information. Broker shall continue to keep the information confidential after the broker is no longer providing services to you. The following information is required to be disclosed by law: (1) Material adverse facts, as defined in section

452.01(5g) of the Wisconsin Statutes; and (2) Any facts known by the broker that contradict any information included in a written inspection report on the property that is the subject of the transaction.

### DEFINITION OF MATERIAL ADVERSE FACTS

A "material adverse fact" is defined in Wis. Stat. 452.01(5g) as an adverse fact that a party indicates is of such significance, or that is generally recognized by a competent licensee as being of such significance to a reasonable party, that it affects or would affect the party's decision to enter into a contract or agreement concerning a transaction, or affects or would affect the party's decision about the terms of such a contract or agreement. An "adverse fact" is a condition or occurrence that a competent licensee generally recognizes will significantly and adversely affect the value of the property, significantly reduce the structural integrity of improvements to real estate, or present a significant health risk to occupants of the property; or information that indicates that a party to a transaction is unable to, or does not intend to, meet his or her obligations under a contract or agreement concerning the transaction.
