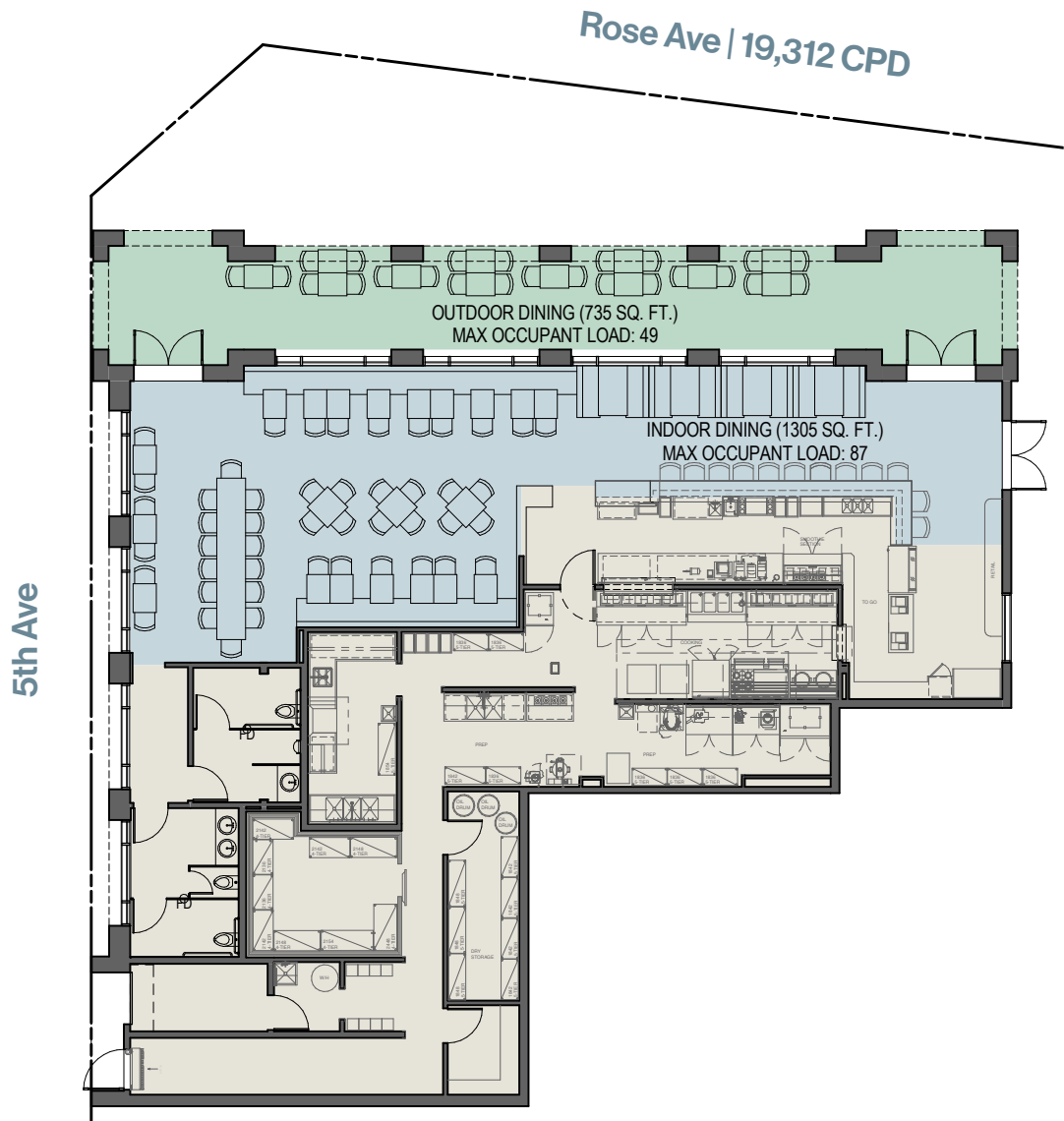
Rose Overview
