## Location

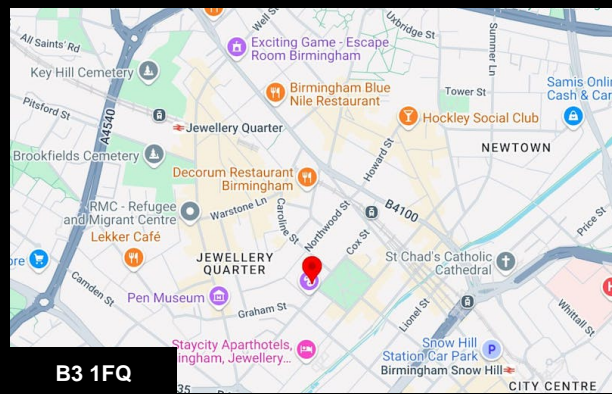
