# LOCATION

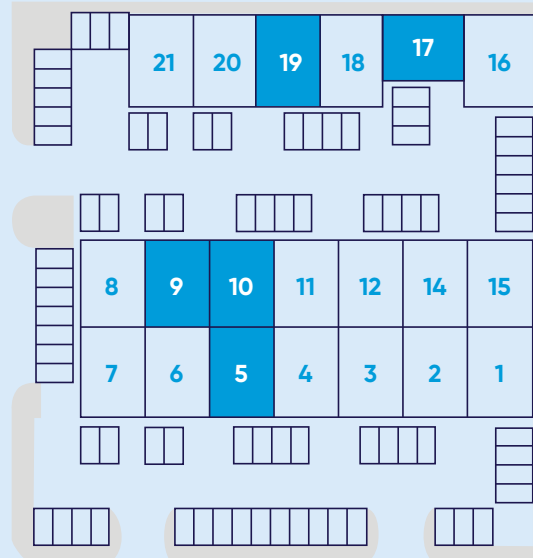
