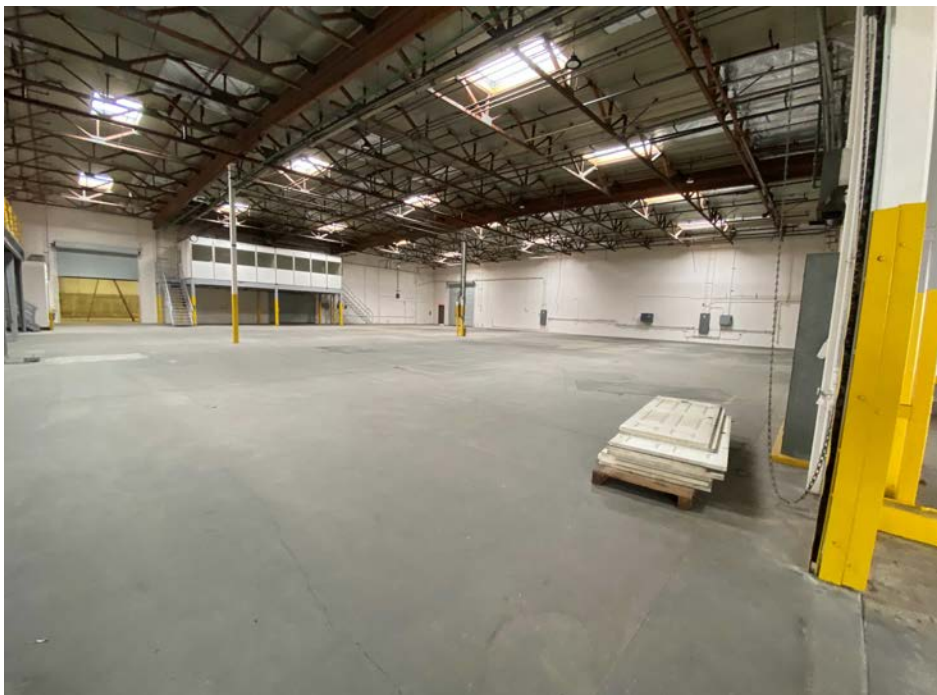

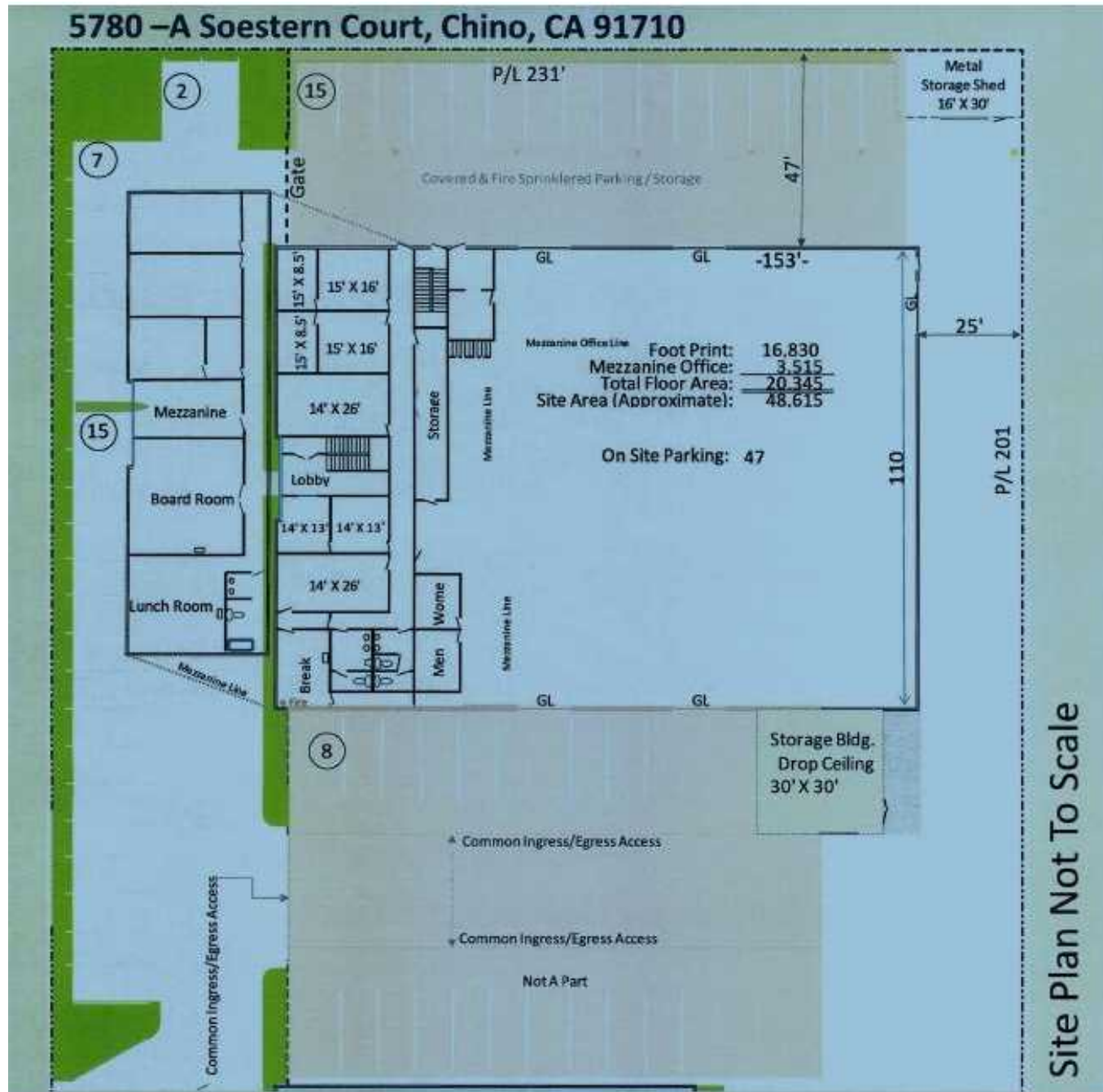

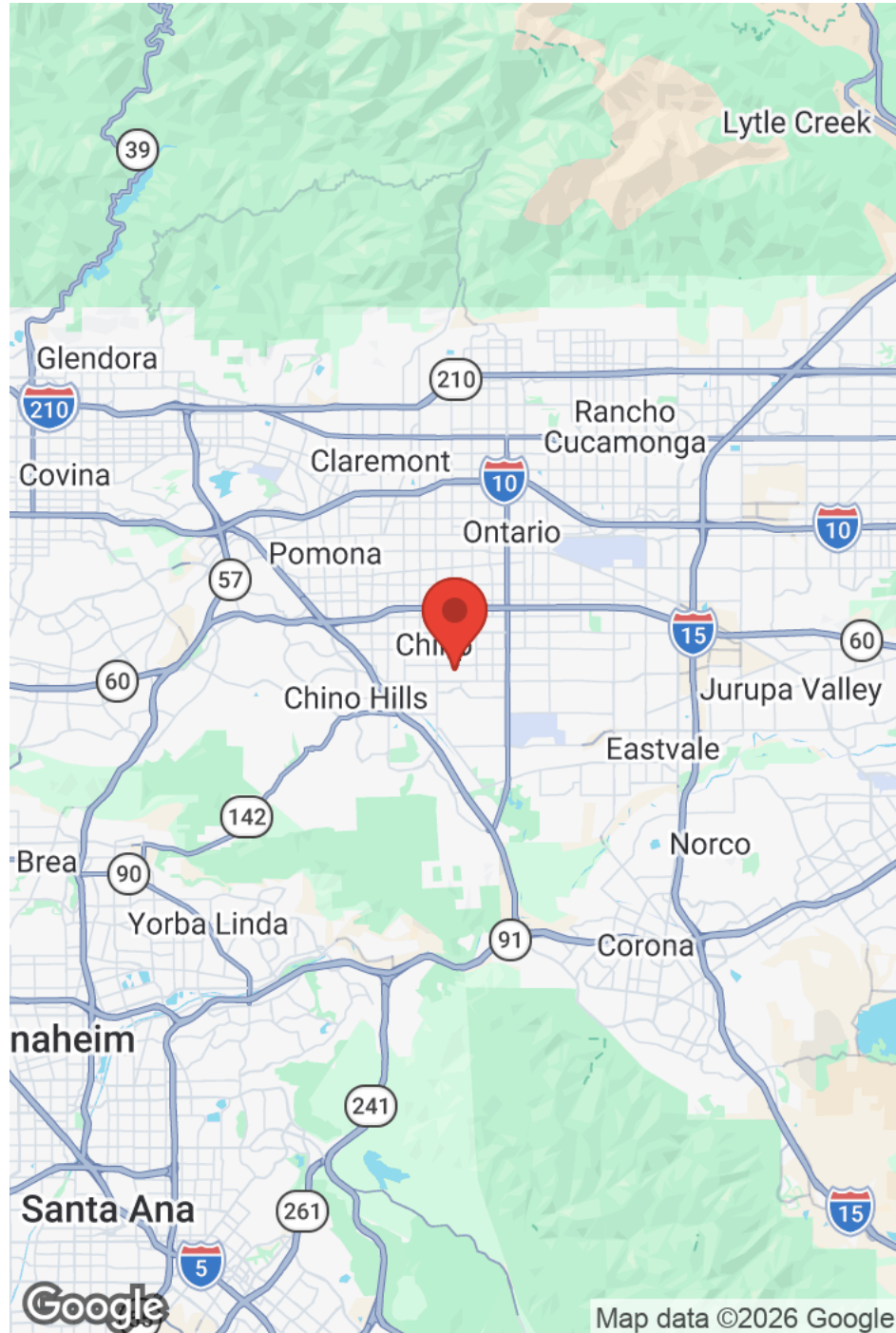

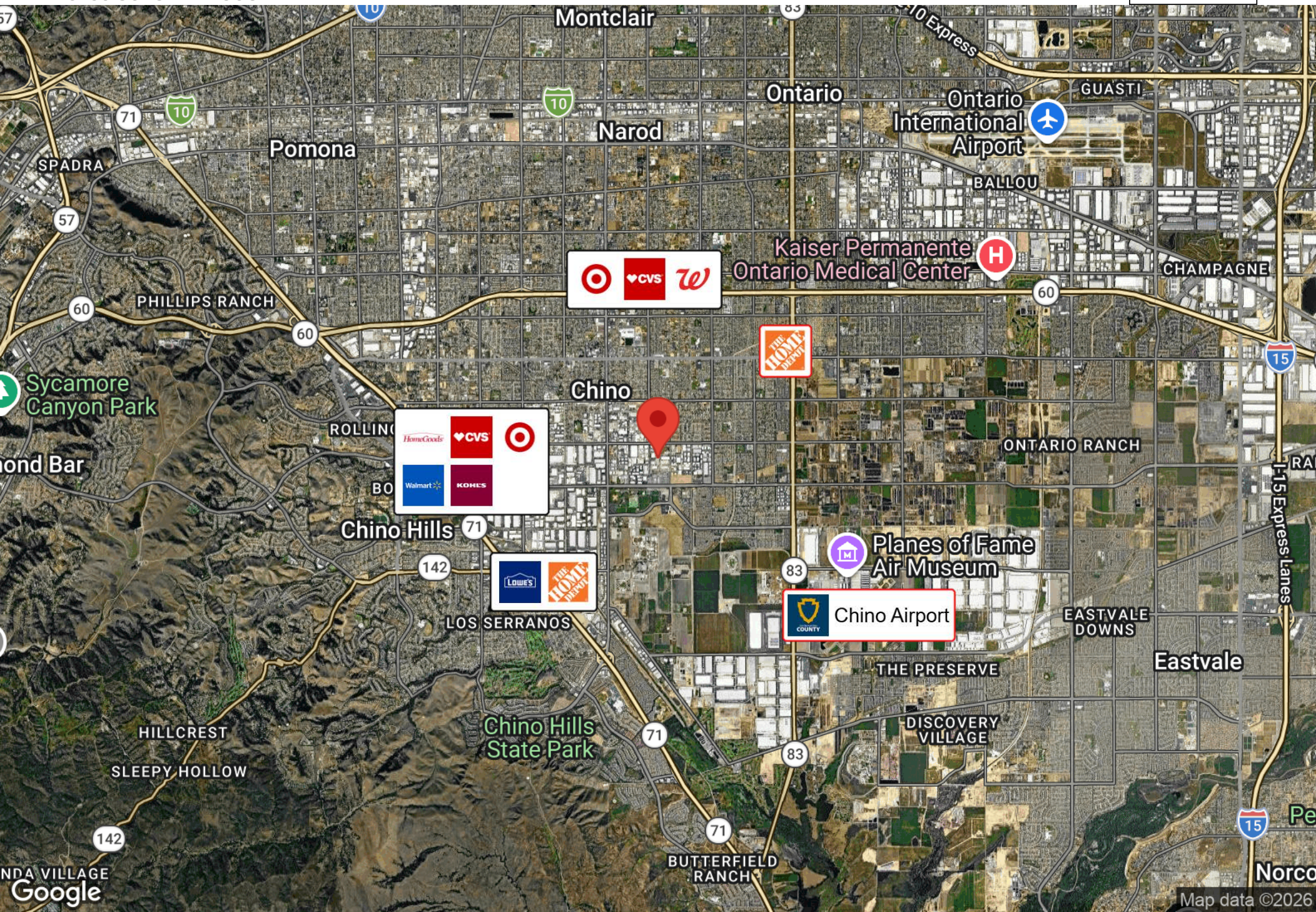

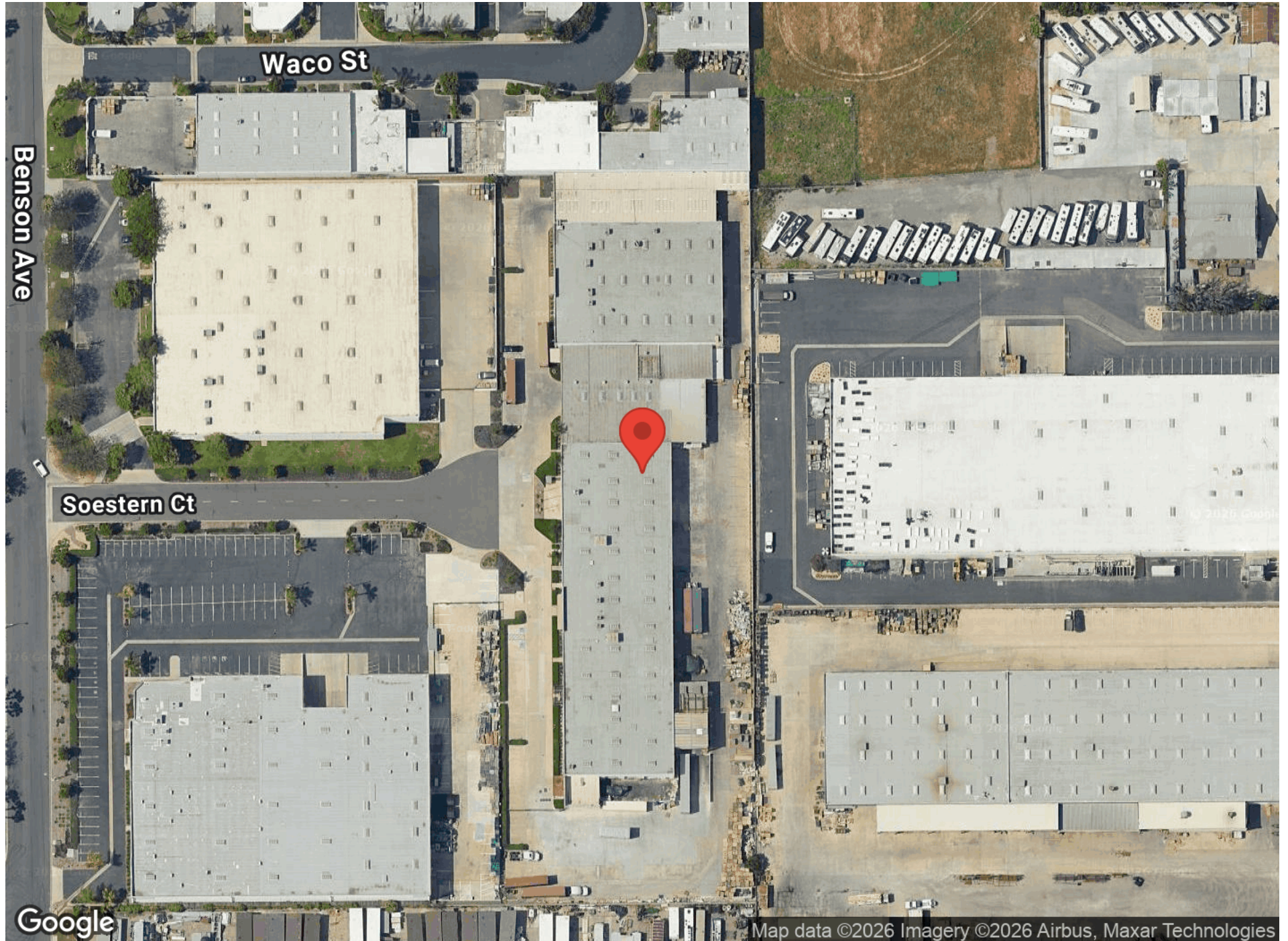
BUSINESS MAP

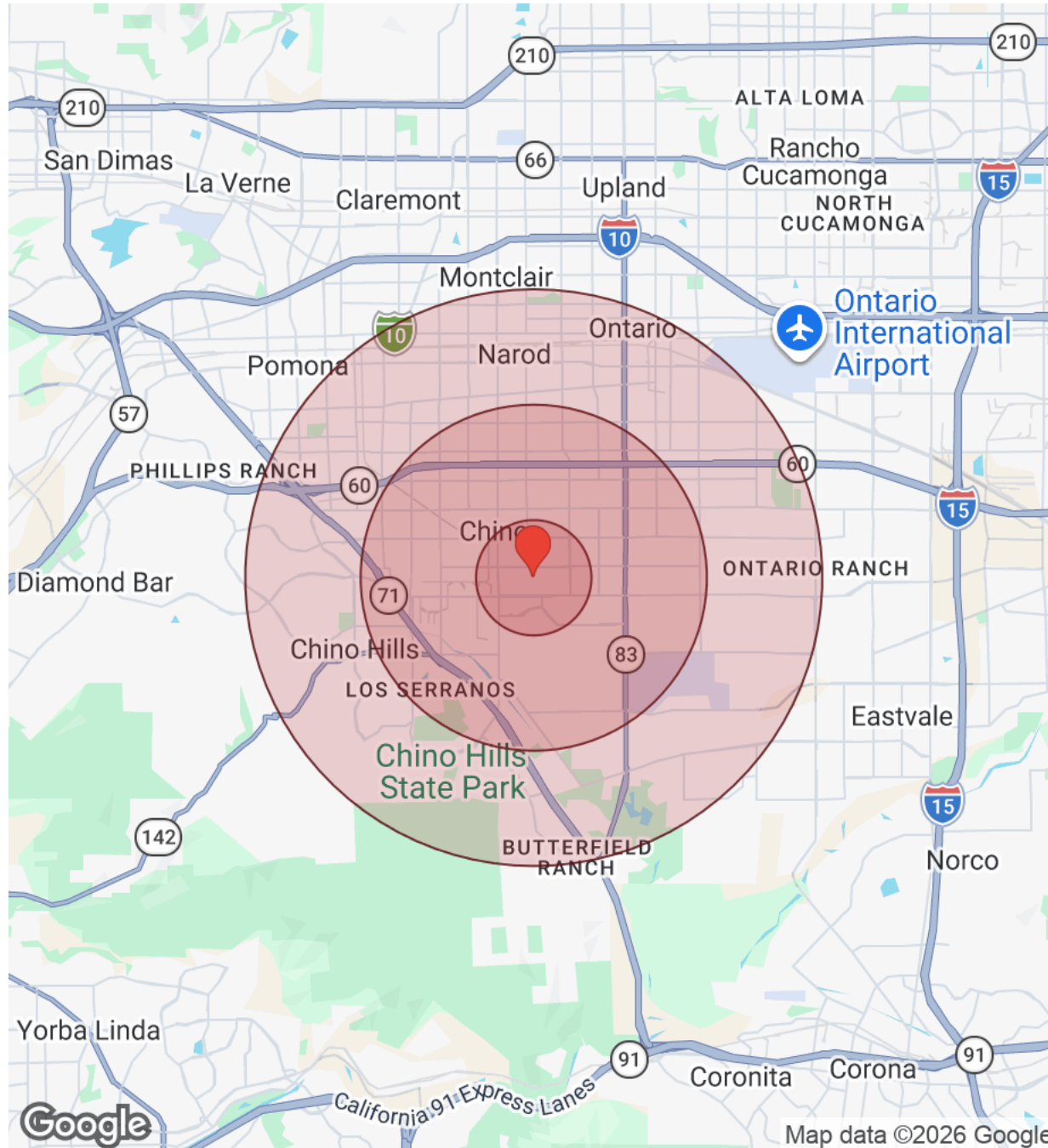
AERIAL MAP
