Executive Summary

Ryan Reid of Colliers is pleased to exclusively offer for sale the Davita Dialysis Medical Office condo Located at 2438 N Ponderosa, Camarillo, CA. The Property is a 5,400 SF medical office Condo 100% occupied by Total Renal Care Inc. d/b/a Davita Dialysis (NYSE: DVA). DaVita carries a Moody's credit rating of Ba2 and S&P rating of BB+.

The Property presents an opportunity to acquire a dialysis center that is strategically located both next to a Nephrology office which sits in the same building, and directly across the street from a hospital. The tenant has recently executed a 5-year extension that

goes through 10/31/2031 which has contractual rent increases of 1.5% annually. The practice has been operating at this location since 2004 and was acquired by DaVita in 2010. DaVita is on a rare NNN lease where they are responsible for all expenses and there are no landlord responsibilities.

This locations operates 16 dialysis stations that are open Monday, Wednesday, and Friday from 4:30AM-6:30PM.

Located at 2438 N. Ponderosa Drive in Camarillo, California, this facility occupies a strategic position within one of Ventura County's premier healthcare corridors. The property is situated directly across the street from St John's Hospital - Camarillo, a full-service acute care hospital operated by Dignity Health that serves as a major healthcare provider for the region. This immediate proximity creates strong referral synergies and enhances convenience for patients requiring ongoing renal care and related medical services.

The facility benefits from its location within an established medical campus environment, surrounded by healthcare providers and assisted living, while maintaining convenient access to U.S. Highway 101 and major regional thoroughfares.

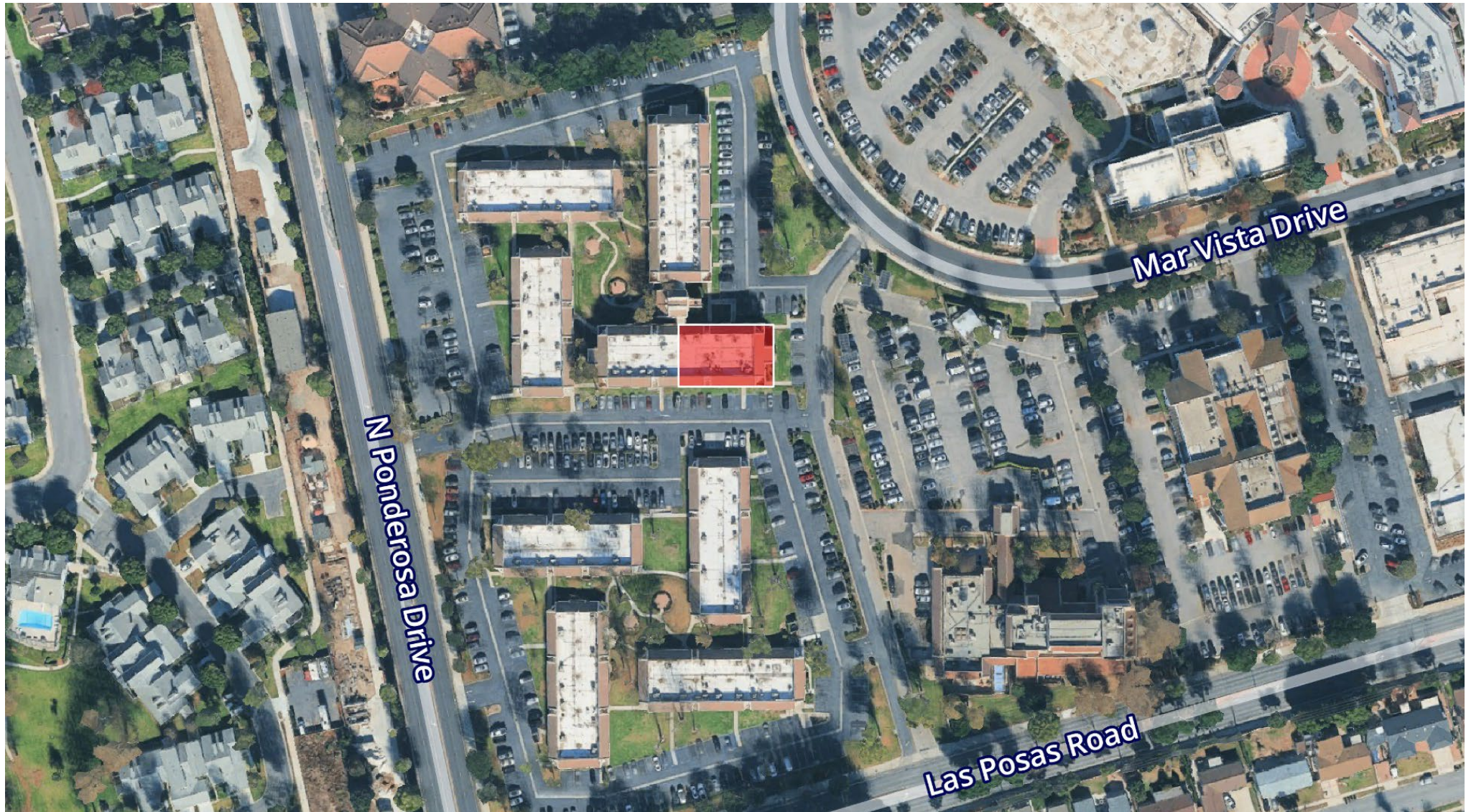

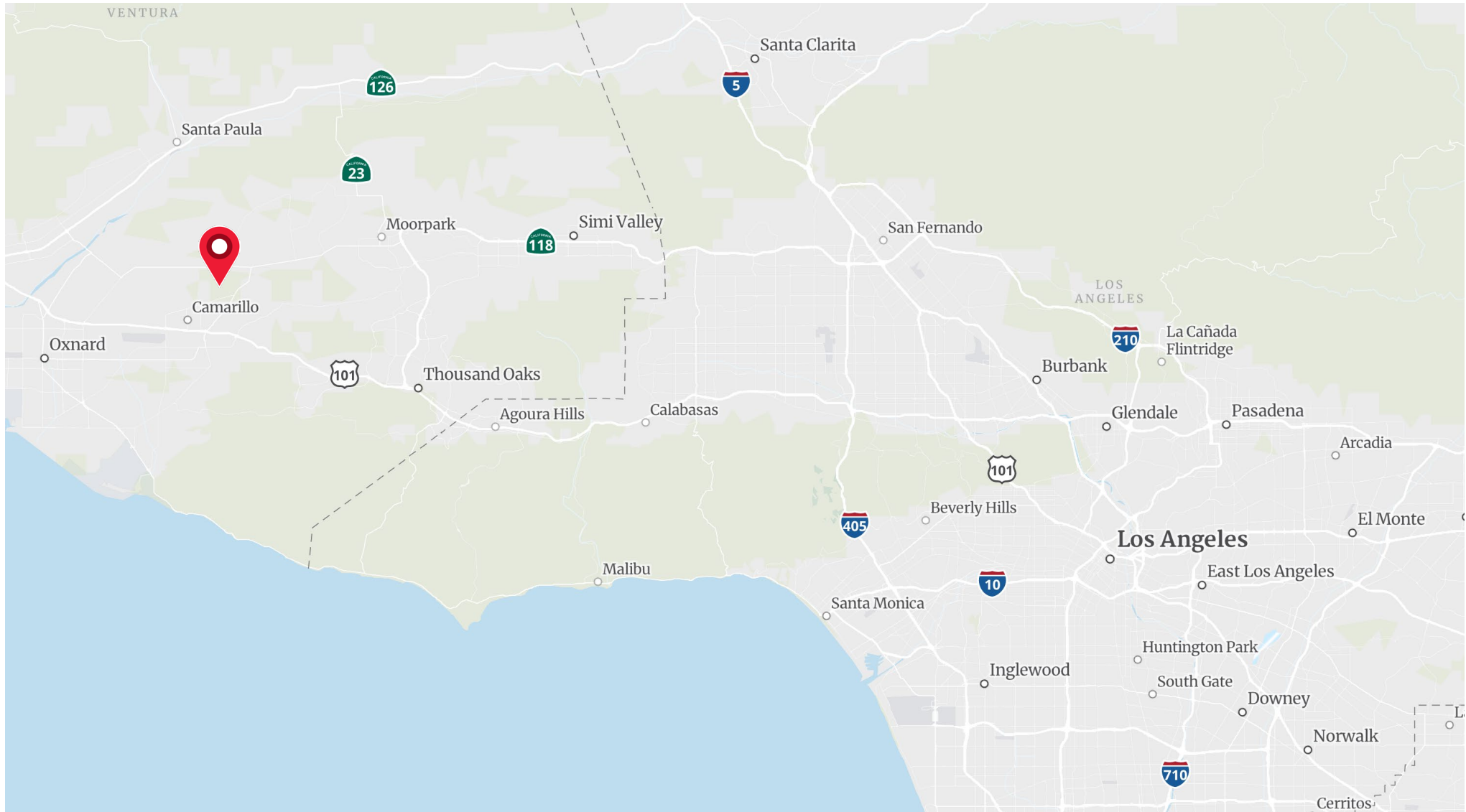
