

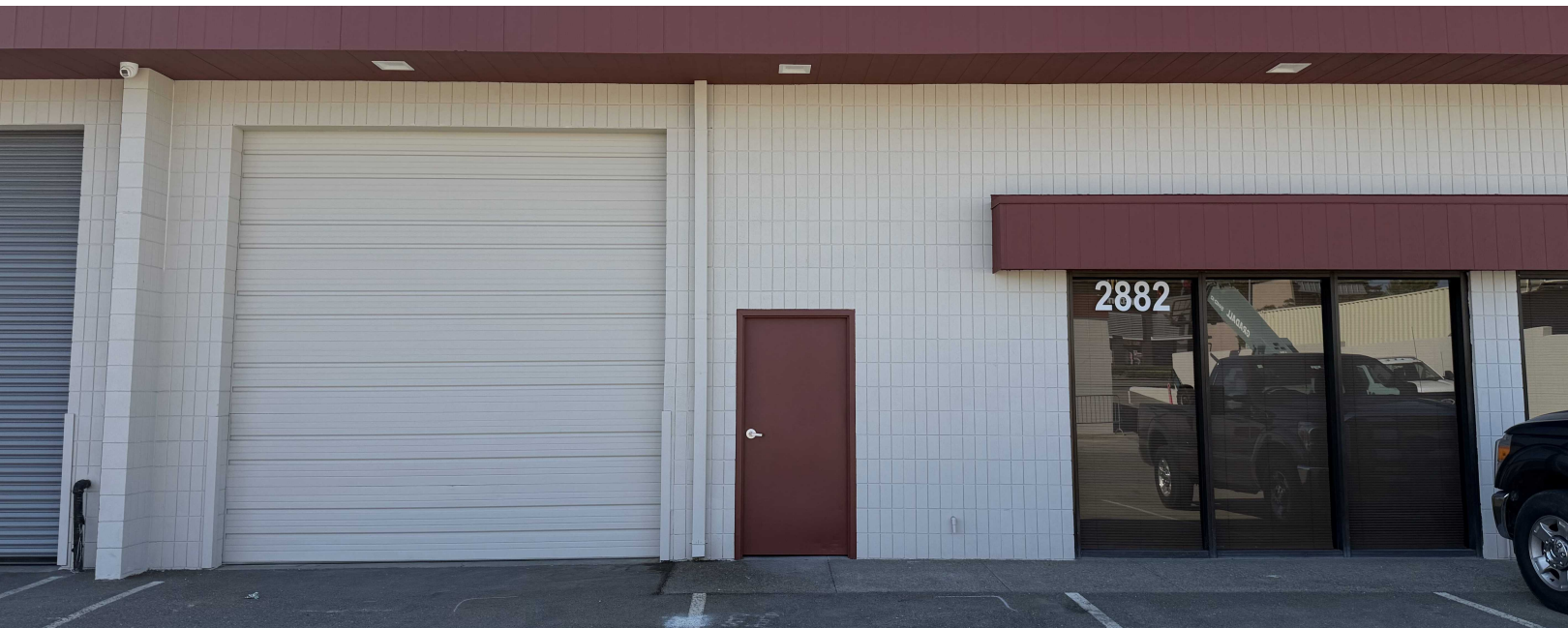

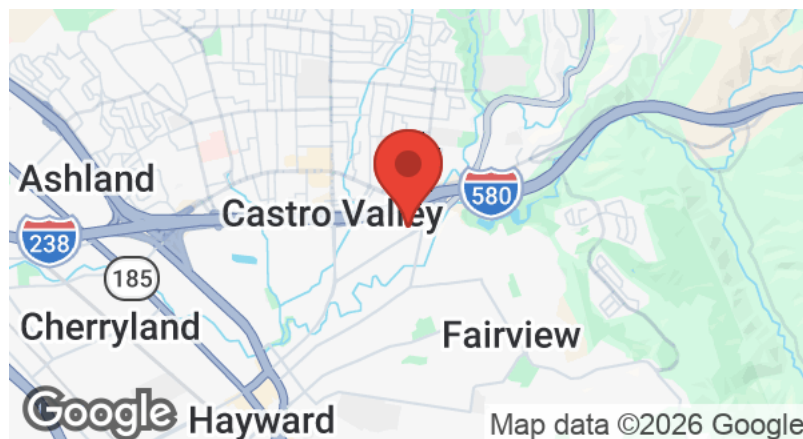
PROPERTY OVERVIEW

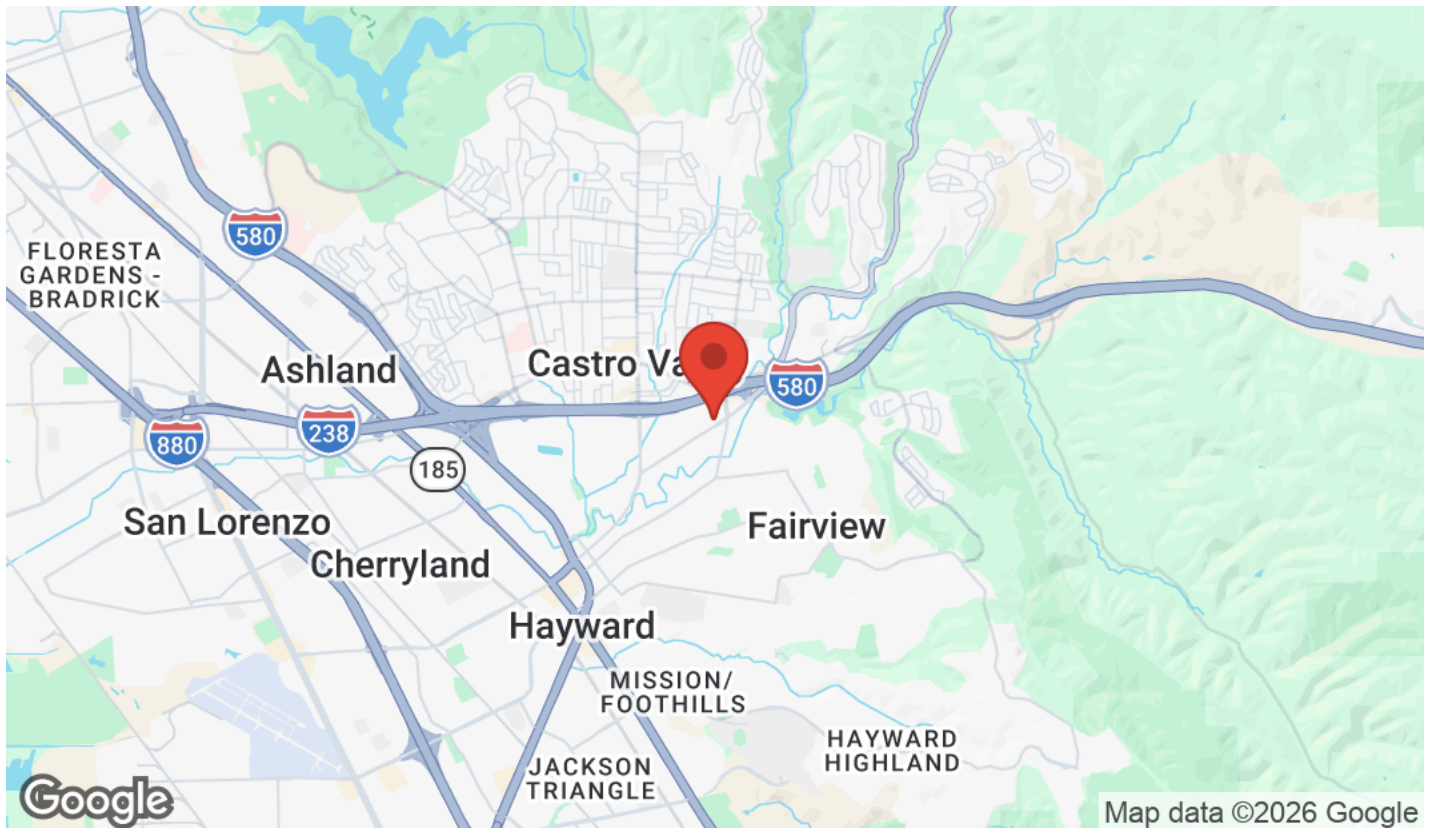
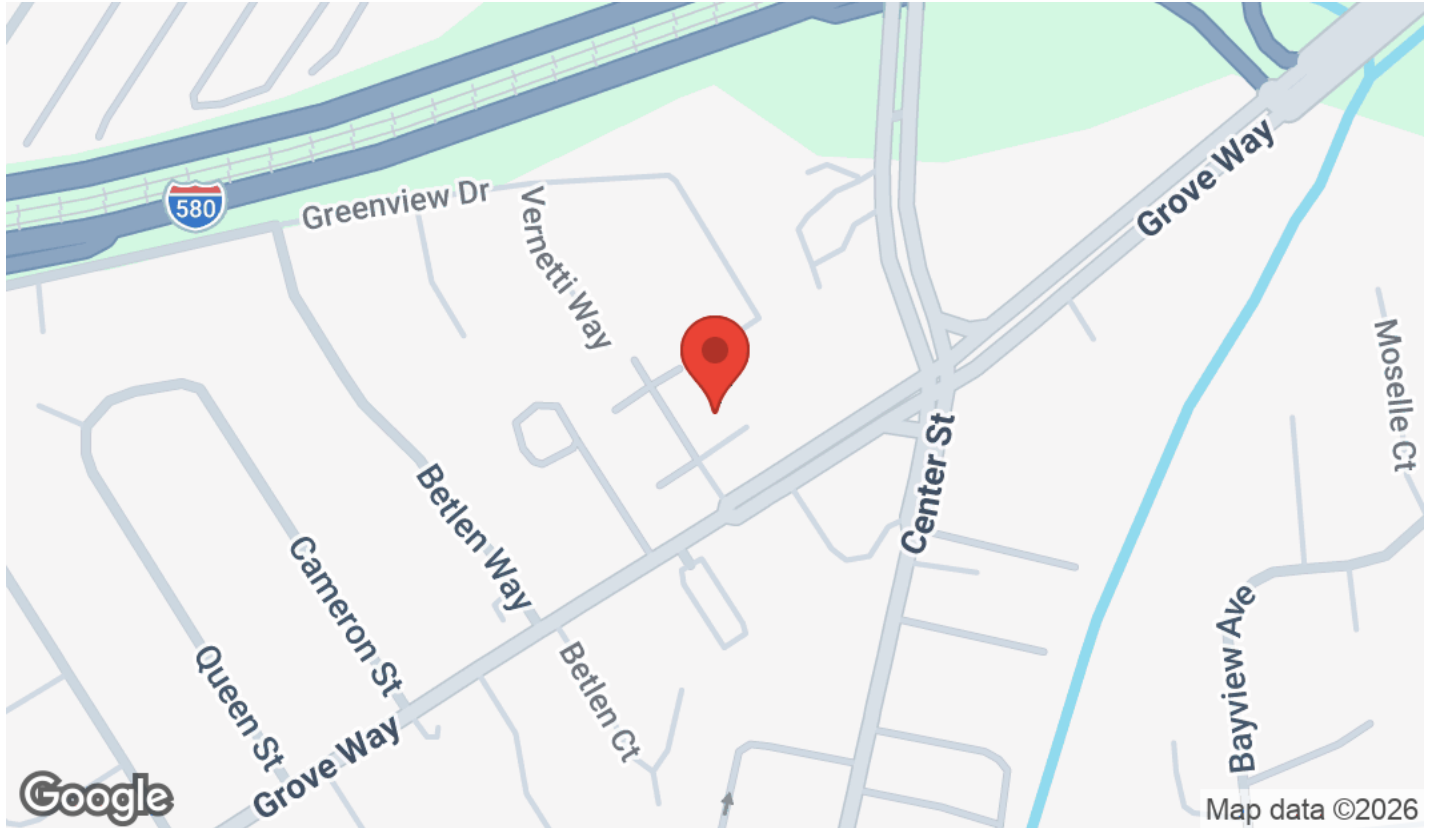
